COME NOW the Iowa Pharmacy Board ("Board") and Bryan Vander Linden ("Respondent"), and enter into the following Agreement Not to Practice ("Agreement"):

1. Respondent holds Iowa pharmacist license number 21951 which is currently active through June 30, 2025.
2. Respondent is the owner and pharmacist in charge of Summit Pharmacy of Iowa, Inc., located at 300 West Burlington Avenue, Fairfield, Iowa 52556.
3. On April 4, 2024, Respondent self-reported to the Board that he had diverted many CII controlled substances for personal use over the previous six (6) years.
4. In order to allow Respondent the opportunity to resolve this matter and the Board to protect public safety, Respondent will not practice as a pharmacist or engage in any conduct that requires a license to practice pharmacy in the State of Iowa until this matter is resolved.
5. Respondent understands he is prohibited from entering Summit Pharmacy located at 300 W. Burlington, Fairfield, Iowa.
6. Respondent understands he is prohibited from accessing Summit Pharmacy's software or records remotely.
7. Respondent understands this Agreement will result in his licensure status being changed to "Suspended" in the licensing database until further order of the Board.
8. Respondent is freely and voluntarily entering into this Agreement.
9. Respondent understands this Agreement, when fully executed, is a public record and is available for inspection and copying in accordance with the requirements of Iowa Code §§ 22 and 272C.
10. The Respondent understands the Board will report this Agreement to the National Association of Boards of Pharmacy ("NABP") Clearinghouse. The report to the Clearinghouse will reflect the language in this Agreement.

11. This Agreement is subject to approval by the Board. If the Board does not approve the Agreement, it shall be of no force or effect to either party.

12. Should Respondent violate the terms of this Agreement, the Board may initiate action to impose other licensee discipline as authorized by Iowa Code chapters 147, 155A, and 272C.
