**DISCUSSION/BACKGROUND:**

Due to a review of our Primary System records Interstate 35 in Franklin County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Interstate 35 in Franklin County be deleted and the new description, as referred in the attached detailed description, be included in the Primary System effective upon the adoption of this resolution.

Locate Interstate 35 in Franklin County as follows:

Beginning on the Wright-Franklin County line near the NW Corner Section 18-T90N-R22W, Franklin County (NE Corner Section 13-T90N-R23W, Wright County); thence northeasterly through Sections 18, 7, 6 and 5-T90N-R22W; Sections 32, 29, 28, 21, 16, 15, 10, 3 and 2-T91N-R22W; Sections 35, 36 (junction Iowa 3), 25 and 24-T92N-R22W and Sections 18, 7, 8 and 5-T92N-R21W; thence northerly following substantially the center section line through Sections 32, 29, 20, 17, 8 and 5-T93N-R21W to the Franklin-Cerro Gordo County line at a point near the N ¼ Corner Section 5-T93N-R21W, Franklin County (S ¼ Corner Section 32-T94N-R21W Cerro Gordo County).

Interstate 35 located in Franklin County, Iowa should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Interstate 35 in Franklin County as follows:

Beginning on the Wright-Franklin County line near the NW Corner Section 18-T90N-R22W, Franklin County (NE Corner Section 13-T90N-R23W, Wright County); thence northeasterly through Sections 18, 7, 6 and 5-T90N-R22W, continuing northeasterly through Sections 32, 29, 28, 21, 16, 15, 10, 3 and 2-T91N-R22W, and Sections 35, 36, 25, 24 and 13-T92N-R22W, and Sections 18, 7, 8 and 5-T92N-R21W; thence northerly following substantially the quarter section line through Sections 32, 29, 20, 17, 8 and 5-T93N-R21W to the Franklin-Cerro Gordo County line at a point in the N  $\frac{1}{4}$  Corner Section 5-T93N-R21W, Franklin County (S  $\frac{1}{4}$  Corner Section 32-T94N-R21W, Cerro Gordo County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Interstate 35 in Franklin County, Iowa.
