DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records Interstate 80 in Cedar County should be deleted and the new description added should be officially included into the Primary Road System

PROPOSAL/ ACTION RECOMMENDATION:

It is recommended that the old description of Interstate 80 in Cedar County be deleted and the new description, as referred in the attached detailed description be included in the Primary Road System effective upon the adoption of this resolution.

Locate Interstate 80 in Cedar County as follows:

Beginning on the Cedar-Johnson County line at a point approximately 1775 feet south of the NW Corner Section 7-T79N-R4W, Cedar County (NE Corner Section 12-T79N-R5W, Johnson County); thence southeasterly and easterly through Section 7-T79N-R4W to a point near the E ¼ Corner Section 7; thence continuing easterly through Sections 8, 9, 10, 11 and 12-T79N-R4W and Section 7-T79N-R3W to a point near the center of Section 7-T79N-R3W; thence curving southeasterly through Sections 7, 8, 9, 16 and 15-T79N-R3W to a point near the E ¼ Corner Section 15-T79N-R3W; thence curving easterly through Section 14-T79N-R3W to a point approximately 885 feet south of the E ¼ Corner Section 14-T79N-R3W; thence easterly through Section 13-T79N-R3W, and Sections 18 (west junction Iowa 38), 17, and 16-T79N-R2W to a point approximately 1050 feet north of the SE Corner Section 16-T79N-R2W; thence southeasterly through Sections 15, 23 (east junction Iowa 38) and

24-T79N-R2W to a point near the E ¼ Corner Section 24-T79N-R2W; thence easterly following substantially the center section line through Sections 19, 20, 21, 22, 23 and 24-T79N-R1W to a point on the Cedar-Scott County line approximately 2548 feet north of the SE Corner Section 24-T79N-R1W, Cedar County (SW Corner Section 19-T79N-R1E, Scott County).

Beginning on-the Cedar-Johnson County line at a point approximately 1775 feet south of the NW Corner Section 7-T79N-R4W, Cedar County (NE Corner Section 12-T79N-R5W, Johnson County); thence southeasterly and easterly through Section 7-T79N-R4W to a point near, the E ¼ Corner Section 7, and continuing easterly through Sections 8, 9, 10, 11 and 12-T79N-R4W and Section 7-T79N-R3W to a point near the center of Section 7-T79N-R3W; thence curving southeasterly and continuing southeasterly through Sections 7, 8, 9, 16 and 15-T79N-R3W to a point near the E ¼ Corner Section 15-T79N-R3W; thence curving easterly and continuing easterly through Section 14-T79N-R3W to a point approximately 885 feet south of the E ¼ Corner Section 14-T79N-R3W; thence easterly through Section 13-T79N-R3W, and Sections 18, 17, and 16-T79N-R2W to a point approximately 1050 feet north of the SE Corner Section 16 T79N-R2W; thence southeasterly through Sections 15, 14, 22, 23 and 24-T79N-R2W to a point near the E ¼ Corner Section 24-T79N-R2W; thence east following substantially the quarter section line through Sections 19, 20, 21, 22, 23 and 24-T79N-R1W to a point on the Cedar-Scott County line approximately 2548 feet north of the SE Corner Section 24-T79N-R1W, Cedar County (SW Corner Section 19-T79N-R1E, Scott County).
