New description – Iowa 1 and its extension in Linn County described as follows:

Beginning on the Linn-Johnson County line at a point approximately 600 feet west of the S $\frac{1}{4}$ Corner Section 36-T82N-R6W, Linn County (N $\frac{1}{4}$ Corner Section 1-T81N-R6W, Johnson County); thence in a northeasterly direction through Section 36-T82N-R6W and Sections 31, 30, 29, 20, 21, and 16-T82N-R5W to the south corporation line of Mount Vernon connecting with South 1st Avenue.

Mount Vernon:

Beginning on South 1st Avenue at the south corporation line; thence northeast on South 1st Avenue to North 1st Avenue; thence northeast on North 1st Avenue to the east corporation line.

Beginning again on the east corporation line of Mount Vernon connecting with North 1st Avenue; thence in a northeasterly direction through Section 2-T82N-R5W and Section 35, 36, 25, 24, 13, 12-T83N-R5W to the Linn-Jones County line at a point approximately 800 feet north of the E $\frac{1}{4}$ Corner Section 12-T83N-R5W, Linn County (W $\frac{1}{4}$ Corner Section 7-T83N-R4W, Jones County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records Iowa 1 in Linn County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 1 in Linn County be deleted and the new description, as referred in the attached detailed description be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 1 and its extension in Linn County as follows:

Beginning on the Linn-Johnson County line at a point approximately 600 feet west of the S $\frac{1}{4}$ Corner Section 36-T82N-R6W, Linn County (N $\frac{1}{4}$ Corner Section 1-T81N-R6W, Johnson County); thence in a northeasterly direction through Section 36-T82N-R6W and Sections 31, 30, 29, 20, 21 and 16-T82N-R5W to the south corporation line of the City of Mount Vernon connecting with an unnamed street.

Mount Vernon:

Beginning on the south corporation line connecting with an unnamed street; thence northeasterly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Mount Vernon connecting with an unnamed street; thence in a northeasterly direction through Section 2-T82N-R5W and Section 35, 36, 25, 24, 13 and 12-T83N-R5W to the Linn-Jones County line at a point approximately 800 feet north of the E $\frac{1}{4}$ Corner Section 12-T83N-R5W, Linn County (W $\frac{1}{4}$ Corner Section 7-T83N-R4W, Jones County).

Beginning on the Linn-Johnson County line at a point approximately 600 feet west of the S $\frac{1}{4}$ Corner Section 36-T82N-R6W, Linn County (N $\frac{1}{4}$ Corner Section 1-T81N-R6W, Johnson County); thence in a northeasterly direction through Section 36-T82N-R6W and Section 31, 30, 29, 20, 21, 16 and 15-T82N-R5W to the south corporation line of the Town of Mount Vernon connecting with Washington Street.

Mount Vernon:

Commencing on Washington Street at the south corporation line; thence northeasterly on Washington Street to the north corporation line.

Beginning again on the north corporation line of the Town of Mount Vernon connecting with Washington Street; thence in a northeasterly direction through Section 3 and 2-T82N-R5W and Section 35, 36, 25, 24, 13 and 12-T83N-R5W to the Linn-Jones County line at a point approximately 800 feet north of the E $\frac{1}{4}$ Corner Section 12-T83N-R5W, Linn County (W $\frac{1}{4}$ Corner Section 7-T83N-R4W, Jones County).
