Milton:

Beginning on the west corporation line (Van Buren–Davis County line) on an unnamed street; thence southeast and east to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of Milton, connecting with an unnamed street; thence in a southeasterly direction through Sections 29, 28, 27, 34 and 35–T68N–R11W to near the center of Section 35–T68N–R11W; thence curving in a northeasterly direction through Sections 35, 36 and 25–T68N–R11W and Sections 30, 19 and 20–T68N–R10W to near the center of Section 20–T68N–R10W; thence east following substantially the center section line through Sections 20, 21, 22, 23 and 24–T68N–R10W (junction Iowa 1), Sections 19, 20, 21, 22, 23 and 24–T68N–R9W and Sections 19 and 20–T68N–R8W to a point approximately 1,800 feet east of the W $\frac{1}{4}$ Corner Section 20–T68N–R8W; thence curving in a southeasterly direction through said Section 20 to a point approximately 700 feet south of the center said Section 20; thence in a general southerly and southeasterly direction through Section 20–T68N–R8W and Sections 29, 32, 33, 34 and 35–T68N–R8W (junction Iowa 81) to the west corporation line of Farmington, connecting with Olive Street.

Farmington:

Beginning on Olive Street at the west corporation line; thence northeast on Olive Street to 4th Street; thence southeast on 4th Street to the south corporation line.

Beginning again on the south corporation line of Farmington connecting with 4th Street; thence in a general southeasterly direction through Section 1-T67N-R8W to the Van Buren-Lee County line at a point in the SE ¼ Section 1-T67N-R8W, Van Buren County (SW ¼ Section 6-T67N-R7W, Lee County).

DISCUSSION/BACKGROUND:

Iowa 2 begins on the Van Buren-Davis County line in Milton, and travels generally easterly via Milton and Farmington to the Van Buren-Lee County line approximately 1 mile north of the SE Corner of Van Buren County, Iowa.

Due to a review of our Primary Road System Road System Records Iowa 2 in Van Buren County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 2 in Van Buren County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 2 and its extensions in Van Buren County as follows:

Milton:

Beginning on the west corporation line (Van Buren–Davis County line) on an unnamed street; thence southeasterly and easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Milton, connecting with an unnamed street; thence in a southeasterly direction through Sections 29, 28, 27, 34, and 35–T68N–R11W to near the center of Section 35–T68N–R11W; thence curving in a northeasterly direction through Sections 35, 36, and 25–T68N–R11W and Sections 30, 19, and 20--T68N–R10W to near the center of Section 20–T68N–R10W; thence easterly following substantially the center section line through Sections 20, 21, 22, 23, and 24–T68N–R10W (junction Iowa 1), Sections 19, 20, 21, 22, 23, and 24–T68N–R9W and Sections 19 and 20–T68N–R8W to a point approximately 1800 feet east of the W $\frac{1}{4}$ Corner Section 20–T68N–R8W thence curving in a southeasterly direction through said Section 20 to a point approximately 700 feet south of the center said Section 20; thence in a general southerly and southeasterly direction through Section 20–T68N–R8W and Sections 29, 32, 33, 34, and 35–T67N–R8W (junction Iowa 81) to the west corporation line of the City of Farmington connecting with an unnamed street.

Farmington:

Beginning on the west corporation line connecting with an unnamed street; thence northeasterly and southeasterly to the south corporation line connecting with an unnamed street.

Beginning again on the south corporation line of the City of Farmington connecting with an unnamed street; thence in a general southeasterly direction through Section 1-T67N-R8W to the Van Buren-Lee County line at a point approximately 1 mile north of the SE corner of Van Buren County, Iowa.

TITLE: Approving revision of Iowa 2 in Van Buren County

Locate Iowa 2 in Van Buren County, Iowa, as follows:

Beginning on the east corporation line of the Town of Milton, connecting with an unnamed street; thence in a southeasterly direction through Sections 29, 28, 27, 34, and 35-T68N-R11W to near the center of Section 35-T68N-R11W; thence curving in a northeasterly direction through Sections 35, 36, and 25-T68N-R11W and Sections 30, 19, and 20-T68N-R10W to near the center of Section 20-T68N-R10W; thence east following substantially the quarter section line through Sections 20, and 21-T68N-R10W to a point approximately 1,000 feet east of the center of Section 21-T68N-R10W.

Milton:

Beginning on an unnamed street at the west corporation line of the Town of Milton; thence in a southeasterly and easterly direction on said unnamed street to the east corporation line.

NOW THEREFORE: Be it resolved that the Iowa State Highway commission approve the revision of Iowa 2 in Van Buren County, Iowa.

NOTE: The following sections of old Iowa 2 and new connections will revert to the Van Buren County secondary road system in accordance with Section 313.2 Code of Iowa; station 273+60 to station 309+21.6, station 349+00 to station 353+20 relocation station 409+45.6 relocation to station 528+44.17 relocation

The section of old Iowa 2 and the new connection from station 5+29.91 relocation to station 82+05 will revert to the Town of Milton. The section of old Iowa 2 from station 309+21.6 to station 349+00 will revert to the Town of Cantril.

The following sections of old Iowa 2 have been obliterated and shall be abandoned; station 1+29.9 to station 7+86.6, station 82+04 to station 87+25.9, station 265+90.4 to station 273+60, approximately station 370+55 to station 373+64.9, station 419-94.0 to approximately station 428+00, approximately station 358+15 to station 361+15.7.
