### **DISCUSSION/BACKGROUND:**

New Description - Iowa 2 and its extensions in Lee County described as follows:

Beginning on the Lee-Van Buren County line at a point approximately 430 feet north of the SW Corner of Section 6-T67N-R7W, Lee County (SE Corner of Section 1-T67N-R8W, Van Buren County); thence in a southeasterly and northeasterly direction through Sections 6 and 7-T67N-R7W, to a point approximately 200 feet south of the NE Corner of Section 7-T67N-R7W; thence in an easterly, northeasterly, and easterly direction through Sections 8, 5, 4, 3, and 2-T67N-R7W, to a point approximately 400 feet east of the NW Corner of Section 2-T67N-R7W; thence east following substantially the section line of Sections 2 and 1-T67N-R7W and Sections 6 and 5-T67N-R6W to the west corporation line of the City of Donnellson connecting with Madison Street (approximately 3030 feet east of the NW Corner of Section 5-T67N-R6W).

Donnellson:

Beginning on Madison Street at the west corporation line (approximately 3030 feet east of the NW Corner of Section 5-T67N-R6W); thence easterly on Madison Street to the east corporation line (approximately 3340 feet west of the NE Corner of Section 4-T67N-R6W).

Beginning again on the east corporation line of the City of Donnellson, connecting with Madison Street (approximately 3340 feet west of the NE Corner of Section 4-T67N-R6W); thence east following substantially the section line of Sections 4, 3, and 2-T67N-R6W to a point approximately 800 feet east of the NW Corner of Section 2-T67N-R6W; thence in a southeasterly and easterly

direction through Sections 2 and 1–T67N–R6W, and Sections 6, 5, 4, 3, and 2–T67N–R5W to a point approximately 1 800 feet west of the SE Corner of Section 2–T67N–R5W (west junction US 61); thence east following substantially the section line of Section 11–T67N–R5W to the west corporation line of the City of Fort Madison, connecting with Avenue "O" (approximately 420 feet west of the NE Corner of Section 11–T67N–R5W).

Fort Madison:

Beginning on Avenue "O" at the west corporation line (approximately 420 feet west of the NE Corner of Section 11–T67N–R5W); thence easterly on Avenue "O" to 40<sup>th</sup> Street; thence northeasterly on an unnamed street to Avenue "L" at 35<sup>th</sup> Street; thence easterly on Avenue "L" to 18<sup>th</sup> Street; thence northerly on 18<sup>th</sup> Street to Avenue "H"; thence easterly on Avenue "H" to 2<sup>nd</sup> Street; thence southerly on 2<sup>nd</sup> Street to the Mississippi River bridge (approximately 3 500 feet south and 190 feet west of the NE Corner of Section 3–T67N–R4W).

Also

Beginning at 18<sup>th</sup> Street on Avenue "H" (begin one-way westbound); thence west on Avenue "H" to 20<sup>th</sup> Street; thence south on 20<sup>th</sup> Street to Avenue "L" (end one-way west bound).

**DISCUSSION/BACKGROUND:**

Iowa 2 begins at the Lee–Van Buren County line approximately 8 miles west of Donnellson and travels in an easterly direction to the Iowa–Illinois State line via the cities of Donnellson and Fort Madison, Iowa.

To provide a more detailed description of the extension of Iowa 2 through Donnellson and Fort Madison, the description of Iowa 2 in Lee County should be revised and the new description officially included in the Primary Road System.

#### **PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve revising the description of Iowa 2 in Lee County and including the new description in the Primary Road System.

New Description – Iowa 2 and its extensions in Lee County described as follows:

Beginning on the Lee–Van Buren County line at a point approximately 700 feet north of the SW Corner of Section 6–T67N–R7W, Lee County (SE Corner of Section 1–T67N–R8W, Van Buren County); thence in a southeasterly and northeasterly direction through Sections 6 and 7–T67N–R7W, to a point approximately 200 feet south of the NE Corner of Section 7–T67N–R7W; thence in an easterly and northeasterly direction through Sections 8, 5, 4, 3, and 2–T67N–R7W, to a point approximately 400 feet east of the NW Corner of Section 2–T67N–R7W; thence east following substantially the section line of Sections 2 and 1–T67N–R7W and Sections 6 and 5–T67N–R6W to the west corporation line of the City of Donnellson connecting with Madison Avenue.

Donnellson:

Beginning on Madison Avenue at the west corporation line; thence easterly on Madison Avenue to the east corporation line.

Beginning again on the east corporation line of the City of Donnellson, connecting with Madison Avenue; thence east following substantially the

section line of Sections 4, 3, and 2–T67N–R6W to a point approximately 800 feet east of the NW Corner of Section 2–T67N–R6W; thence in a southeasterly and easterly direction through Sections 2 and 1–T67N–R6W, and Sections 6, 5, 4, 3, and 2–T67N–R5W to a point approximately 1000 feet west of the SE Corner of Section 2–T67N–R5W (west junction US 61); thence east following substantially the section line of Sections 11 and 12–T67N–R5W to the west corporation line of the City of Fort Madison, connecting with Avenue "O".

Fort Madison:

Beginning on Avenue "O" at the west corporation line; thence easterly on Avenue "O" to Fortieth Street; thence northeasterly on an unnamed street to Avenue "L" at Thirty-fifth Street; thence easterly on Avenue "L" to Eighteenth Street; thence northerly on Eighteenth Street to Avenue "H"; thence easterly on Avenue "H" to Second Street; thence southerly on Second Street to the Iowa–Illinois State line on the Mississippi River bridge.

Also

Beginning at Eighteenth Street on Avenue "H" (begin one-way westbound); thence west on Avenue "H" to Twentieth Street; thence south on Twentieth Street to Avenue "L" (end one-way west bound).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 2 in Lee County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 2 begins at the Lee-Van Buren County line approximately 8 miles west of Donnellson and travels in an easterly direction to the Iowa-Illinois state line via the cities of Donnellson and Fort Madison, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 2 and its extensions in Lee County, Iowa as follows:

Beginning on the Lee-Van Buren County line at a point approximately 700 feet north of the SW Corner of Section 6-T67N-R7W, Lee County (SE Corner of Section 1-T67N-R8W, Van Buren County); thence in a southeasterly and northeasterly direction through Sections 6 and 7-T67N-R7W, to a point approximately 200 feet south of the NE Corner of Section 7-T67N-R7W; thence in an easterly and northeasterly direction through Sections 8, 5, 4, 3, and 2-T67N-R7W, to a point approximately 400 feet east of the NW Corner of Section 2-T67N-R7W; thence east following substantially the section line of

Sections 2 and 1–T67N–R7W and Sections 6 and 5–T67N–R6W to the west corporation line of the City of Donnellson connecting with an unnamed street.

Donnellson:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Donnellson, connecting with an unnamed street; thence east following substantially the section line of Sections 4, 3, and 2–T67N–R6W to a point approximately 800 feet east of the NW Corner of Section 2–T67N–R6W; thence in a southeasterly and easterly direction through Sections 2 and 1–T67N–R6W, and Sections 6, 5, 4, 3, and 2–T67N–R5W to a point approximately 1000 feet west of the SE Corner of Section 2–T67N–R5W (west junction US 61); thence east following substantially the section line of Sections 11 and 12–T67N–R5W to the west corporation line of the City of Fort Madison, connecting with an unnamed street.

Fort Madison:

Beginning on the west corporation line, connecting with an unnamed street; thence easterly, northeasterly, easterly, northerly, easterly and southerly to the Iowa–Illinois State line on the south corporation line of Fort Madison, Iowa.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 2, Lee County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

Beginning again on the east corporation line of the Town of Donnellson, connecting with an unnamed Street on the south line of Section 33-T68N-R6W; thence east following substantially the section line to a point approximately 800 feet east of the NW Corner of Section 2-T67N-R6W; thence in a southeasterly and easterly direction through Sections 2 and 1-T67N-R6W, and Sections 6, 5, 4, 3, and 2-T67N-R5W to a point approximately 1000 feet west of the SE Corner of Section 2-T67N-R5E; thence east following substantially the section line to the west corporation line of the City of Fort Madison, connecting with "O" Street.
