New Description – Iowa 3 and its extensions in Humboldt County described as follows:

Gilmore City:

Beginning on East Iowa Avenue at the Humboldt-Pocahontas County line; thence east on East Iowa Avenue to the east corporation line.

Beginning on the east corporation line of Gilmore City connecting with East Iowa Avenue; thence east following substantially the section line of Sections 6, 5, 4, 3, 2, and 1-T91N-R30W and Sections 6, 5, 4, 3, and 2-T91N-R29W to the west corporation line of Humboldt connecting with an unnamed street.

Humboldt:

Beginning on unnamed street at the west corporation line; thence east on unnamed street to the east corporation line.

Beginning again on the east corporation line of Humboldt, connecting with an unnamed street; thence east following substantially the section line of Sections 6, 5, 4, 3, 2, and 1-T91N-R28W and Sections 6, 5, 4, 3, 2, and 1-T91N-R27W to the Humboldt-Wright County line at a point near the NE Corner Section 1-T91N-R27W, Humboldt County (NW Corner Section 6-T91N-R26W, Wright County).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System Records, Iowa 3 in Humboldt County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 3 begins on the Humboldt-Pocahontas County line in Gilmore City and travels in an easterly direction to the Humboldt-Wright County line approximately 6 ½ miles northeast of Thor, via the Cities of Gilmore City and Humboldt, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 3 and its extensions in Humboldt County as follows:

Gilmore City:

Beginning on an unnamed street at the Humboldt-Pocahontas County line; thence easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Gilmore City connecting with an unnamed street; thence easterly following substantially the section line of Sections 6, 5, 4, 3, 2, and 1-T91N-R30W and Sections 6, 5, 4, 3, and 2-T91N-R29W to the west corporation line of the City of Humboldt connecting with an unnamed street.

Humboldt:

Beginning on the west corporation line, connecting with an unnamed street; thence easterly to the east corporation line, connecting with an unnamed street.

Beginning again on the east corporation line of the City of Humboldt, connecting with an unnamed street; thence easterly following substantially the section line of Sections 6, 5, 4, 3, 2, and 1-T91N-R28W and Sections 6, 5, 4, 3, 2, and 1-T91N-R27W to the Humboldt-Wright County line at a point near the NE Corner Section 1-T91N-R27W, Humboldt County (NW Corner Section 6-T91N-R26W, Wright County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 3 in Humboldt County, Iowa.
