New Description – Iowa 3 and its extensions in Clayton County described as follows:

Beginning at the Clayton–Fayette County line at a point near the NW Corner Section 19–T91N–R6W, Clayton County (NE Corner Section 24–T91N–R7W, Fayette County); thence east following substantially the section line of Sections 19, 20, and 21–T91N–R6W to a point approximately 700 feet west of the N $\frac{1}{4}$ of Section 21–T91N–R6W; thence in a southeasterly direction through Section 21–T91N–R6W to the west corporation line of Strawberry Point, connecting with Mission Street.

Strawberry Point:

Beginning on Mission Street at the west corporation line; thence southeast on Mission Street to Commercial Street; thence southwest and south on Commercial Street to the south corporation line.

Beginning again at the south corporation line of Strawberry Point, connecting with Commercial Street; thence south following substantially the center section line through Section 27–T91N–R6W to a point approximately 1,200 feet north of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence curving in a southeasterly direction to a point approximately 1,200 feet east of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence east following substantially the section line of Sections 34, 35, and 36–T91N–R6W and Section 31–T91N–R5W to a point approximately 1,800 feet east of the NW Corner of Section 31–T91N–R5W; thence in a southeasterly direction through Sections 31 (east junction Iowa 13) and 32–T91N–R5W to the Clayton–Delaware County line at a point approximately 600 feet east of the SW Corner of Section 32–T91N–R5W, Clayton County (NW Corner of Section 5–T90N–R5W, Delaware County); thence east along the Clayton–Delaware County line to the west corporation line of Edgewood, connecting with Union Street.

Edgewood:

Beginning on Union Street at the west corporation line; thence east on Union Street to the east corporation line.

Beginning again at the east corporation line of Edgewood; connecting with Union Street; thence east along the Clayton–Delaware County line to a point approximately 800 feet west of the SE Corner of Section 36–T91N–R5W, Clayton County (NE Corner Section 1–T90N–R5W, Delaware County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 3 in Clayton County should be deleted and the new description added should be officially included into the Primary System.

Iowa 3 begins on the Clayton–Fayette County line approximately 3 miles west of Strawberry Point, Iowa and travels in a southeasterly direction via Strawberry Point and Edgewood, Iowa to the Clayton–Delaware County line approximately 1½ miles east of Edgewood, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 3 and its extensions in Clayton County as follows:

Beginning at the Clayton–Fayette County line at a point near the NW Corner Section 19–T91N–R6W, Clayton County (NE Corner Section 24–T91N–R7W,

Fayette County); thence east following substantially the section line of Sections 19, 20, and 21-T91N-R6W to a point approximately 700 feet west of the N ¼ of Section 21-T91N-R6W; thence in a southeasterly direction through Section 21-T91N-R6W to the west corporation line of the City of Strawberry Point, connecting with an unnamed street.

Strawberry Point:

Beginning at the west corporation line connecting with an unnamed street easterly to Commercial Street; thence south to the south corporation line connecting with an unnamed street.

Beginning again at the south corporation line of the City of Strawberry Point, connecting with an unnamed street; thence south following substantially the center section line through Section 27-T91N-R6W to a point approximately 1,200 feet north of the S ¼ Corner of Section 27-T91N-R6W; thence curving in a southeasterly direction to a point approximately 1,200 feet east of the S ¼ Corner of Section 27-T91N-R6W; thence east following substantially the section line of Sections 34, 35, and 36-T91N-R6W and Section 31-T91N-R5W to a point approximately 1,800 feet east of the NW Corner of Section 31-T91N-R5W; thence in a southeasterly direction through Sections 31 (east junction Iowa 13) and 32-T91N-R5W to the Clayton-Delaware County line at a point approximately 600 feet east of the SW Corner of Section 32-T91N-R5W, Clayton County (NW Corner of Section 5-T90N-R5W, Delaware county); thence east along the Clayton-Delaware County line to the west corporation line of the City of Edgewood, connecting with an unnamed street.

Edgewood:

Beginning at the west corporation line connecting with an unnamed street on the Clayton-Delaware County line; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of Edgewood; thence east along the Clayton-Delaware County line to a point approximately 800 feet west of the SE Corner of Section 36-T91N-R5W, Clayton County (NE Corner Section 1-T90N-R5W, Delaware County).

DISCUSSION/BACKGROUND:

Beginning at the Clayton-Fayette County line at a point near the NW Corner Section 19-T91N-R6W, Clayton County (NE Corner Section 24-T91N-R7W, Fayette County); thence east following substantially the section line of Sections 19, 20, and 21-T91N-R6W to a point approximately 700 feet west of the N ¼ of

Section 21–T91N–R6W; thence in a southeasterly direction through Section 21–T91N–R6W to the west corporation line of the City of Strawberry Point, connecting with an unnamed street.

Strawberry Point:

Beginning at the west corporation line connecting with an unnamed street easterly to Commercial Street; thence south to the south corporation line connecting with an unnamed street.

Beginning again at the south corporation line of the City of Strawberry Point, connecting with an unnamed street; thence south following substantially the center section line through Section 27–T91N–R6W to a point approximately 1,200 feet north of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence curving in a southeasterly direction to a point approximately 1,200 feet east of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence east following substantially the section line of Sections 34, 35, and 36–T91N–R6W and Section 31–T91N–R5W to a point approximately 1,800 feet east of the NW Corner of Section 31–T91N–R5W; thence in a southeasterly direction through Sections 31 (east junction Iowa 13) and 32–T91N–R5W to the Clayton–Delaware County line at a point approximately 600 feet east of the SW Corner of Section 32–T91N–R5W, Clayton County (NW Corner of Section 5–T90N–R5W, Delaware County); thence east along the Clayton–Delaware County line along the south section line of Sections 32, 33, and 34–T91N–R5W to the west corporation line of the City of Edgewood, connecting with an unnamed street.

Edgewood:

Beginning at the west corporation line connecting with an unnamed street on the Clayton–Delaware County line; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of Edgewood; thence east along the Clayton–Delaware County line following substantially the south section line of Section 36–T91N–R5W to a point approximately 800 feet west of the SE Corner of Section 36–T91N–R5W, Clayton County (NE Corner Section 1–T90N–R5W, Delaware County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 3 in Clayton County, Iowa.

Beginning again on the south corporation line of the Town of Strawberry Point, connecting with Commercial Street; thence south to a point approximately 1,200 feet north of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence curving in a southeasterly direction to a point approximately 1,200 feet east of the S $\frac{1}{4}$ Corner of Section 27–T91N–R6W; thence east following substantially the

section line to a point approximately 1,800 feet east of the NW Corner of Section 31-T91N-R5W; thence in a southeasterly direction through Section 31 and 32-T91N-R5W to the Clayton-Delaware County line at a point approximately 600 feet east of the SW Corner of Section 32-T91N-R5W, Clayton County (NW Corner of Section 5-T90N-R5W, Delaware County); thence east along the Clayton-Delaware County line to the west corporation line of the Town of Edgewood, connecting with Union Street.

Beginning again on the east corporation line of the Town of Edgewood, connecting with Union Street; thence east along the Clayton-Delaware County line to a point approximately 800 feet west of the SE Corner of Section 36-T91N-R5W, Clayton County (NE Corner of Section 1-T90N-R5W, Delaware County).
