New description – Iowa 3 and its extensions in Butler County described as follows:

Beginning at the Butler–Franklin County line at a point near the NW Corner of Section 31–T92N–R18W, Butler County (NE Corner of Section 36–T92N–R19W, Franklin County); thence east following substantially the section line of Sections 31, 32, 33, 34, 35 and 36–T92N–R18W; Sections 31, 32, 33, 34 and 35–T92N–R17W (west junction Iowa 14), to the west corporation line of Allison connecting with an unnamed street.

Allison:

Beginning on an unnamed street at the west corporation line; thence easterly on an unnamed street to the east corporation line.

Beginning again on the east corporation line of Allison connecting with an unnamed street; thence easterly following substantially the section line of Sections 31, 32, 33, 34, 35 and 36–T92N–R16W, and Sections 31 (junction Iowa 188), 32, and 33–T92N–R15W to a point approximately 150 feet east of the N  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  of Section 33–T92N–R15W; thence southeasterly through Sections 33 and 34–T92N–R15W and Section 2–T91N–R15W to the north corporation line of Shell Rock connecting with an unnamed street.

Shell Rock:

Commencing on an unnamed street at the north corporation line; thence southeast and east on said unnamed street to the east corporation line.

Beginning again on the east corporation line of Shell Rock connecting with an unnamed street; thence east through Sections 1 and 12-T91N-R15W to a point approximately 590 feet east of the N ¼ Corner NW ¼ of Section 12-T91N-R15W; thence east following substantially the section line of said Section 12 to the Butler-Bremer County line at a point near the NE Corner of Section 12-T91N-R15W, Butler County (NW Corner of Section 7-T91N-R14W, Bremer County).

**DISCUSSION/BACKGROUND:**

Iowa 3 begins on the Butler-Franklin County line approximately three miles west of Dumont and travels easterly via Allison and Shell Rock to the Butler-Bremer County line approximately one mile east of Shell Rock.

Due to an annexation to the south corporation line of the City of Allison, the present description of Iowa 3 in Butler County should be revised. The new description added should be officially included in the primary road system to reflect this change in corporate limits.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 3 in Butler County be deleted and the new description, as listed in the attached detailed description, be included in the primary road system.

Locate Iowa 3 and its extensions in Butler County as follows:

Beginning at the Butler–Franklin County line at a point near the NW Corner of Section 31–T92N–R18W, Butler County (NE Corner of Section 36–T92N–R19W, Franklin County); thence east following substantially the section line of Sections 31, 32, 33, 34, 35 and 36–T92N–R18W and Sections 31, 32, 33, 34, and 35–T92N–R17W (west junction Iowa 14) to the west corporation line of the City of Allison connecting with an unnamed street.

Allison:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Allison connecting with an unnamed street; thence easterly following substantially the section line of Sections 31, 32, 33, 34, 35 and 36–T92N–R16W and Sections 31 (junction Iowa 188), 32, and 33–T92N–R15W to a point approximately 150 feet east of the N  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  of Section 33–T92N–R15W; thence southeasterly through Sections 33 and 34–T92N–R15W and Section 2–T91N–R15W to the north corporation line of the City of Shell Rock connecting with an unnamed street.

Shell Rock:

Commencing on an unnamed street at the north corporation line; thence southeasterly and easterly on said unnamed street to the east corporation line.

Beginning again on the east corporation line of the City of Shell Rock connecting–with an unnamed street; thence easterly through Sections 1 and 12–T91N–R15W to a point approximately 590 feet east of the N  $\frac{1}{4}$  Corner NW  $\frac{1}{4}$  of Section 12–T91N–R15W; thence east following

substantially the section line of said Section 12 to the Butler–Bremer County line at a point near the NE Corner of Section 12–T91N–R15W, Butler County (NW Corner of Section 7–T91N–R14W, Bremer County).

Locate Iowa 3 and its extension in Butler County as follows:

Beginning at the Butler–Franklin County line at a point near the NW Corner of Section 31–T92N–R18W, Butler County (NE Corner of Section 36–T92N–R19W, Franklin County); thence east following substantially the section line of Sections 31, 32, 33, 34, 35, and 36–T92N–R18W, Sections 31, 32, 33, 34, 35 (west junction Iowa 14), and 36–T92N–R17W (east junction Iowa 14), Sections 31, 32, 33, 34, 35, 36–T92N–R16W, and Sections 31 (junction Iowa 188), 32, and 33–T92N–R15W to a point

approximately 150 feet east of the N ¼ Corner NE ¼ of Section 33-T92N-R15W; thence southeasterly through Sections 33 and 34-T92N-R15W and Section 2-T91N-R15W to the north corporation line of the City of Shell Rock connecting with an unnamed street.

Shell Rock:

Commencing on an unnamed street at the north corporation line; thence southeasterly and easterly on said unnamed street to the east corporation line.

Beginning again on the east corporation line of the City of Shell Rock connecting with an unnamed street; thence easterly through Sections 1 and 12-T91N-R15W to a point approximately 590 feet east of the N ¼ Corner NW ¼ of Section 12-T91N-R15W; thence east following substantially the section line said Section 12 to the Butler-Bremer County line at a point near the NE Corner of Section 12-T91N-R15W, Butler County (NW Corner of Section 7-T91N-R14W, Bremer County)

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 3 in Butler County should be deleted and the new description added should be officially included into the Primary System.

Iowa 3 begins at the Butler–Franklin County line approximately 1  $\frac{3}{4}$  miles west of Dumont and travels easterly intersecting with Iowa 14 and Iowa 188; curving southeasterly through Shell Rock to the Butler–Bremer County line approximately  $\frac{3}{4}$  mile east of Shell Rock.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 3 in Butler County as follows:

Beginning at the Butler–Franklin County line at a point near the NW Corner of Section 31–T92N–R18W, Butler County (NE Corner of Section 36–T92N–R19W, Franklin County); thence east following substantially the section line of Sections 31, 32, 33, 34, 35, and 36–T92N–R18W continuing along following substantially the section line of Sections 31, 32, 33, 34, 35 (west junction Iowa 14), and 36–T92N–R17W (east junction Iowa 14), continuing easterly following substantially the section line of Sections 31, 32, 33, 34, 35, 36–T92N–R16W, continuing easterly following substantially the section line of Sections 31 (junction Iowa 188), 32, and 33–T92N–R15W to a point approximately 150 feet east of the N  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  of Section 33–T92N–R15W; thence southeasterly through Sections 33 and 34–T92N–R15W and Sections 3 and 2–T91N–R15W to the north corporation line of the City of Shell Rock connecting with an unnamed street.

Beginning again on the east corporation line of the City of Shell Rock connecting with an unnamed street; thence easterly to a point approximately 590 feet east of the N  $\frac{1}{4}$  Corner NW  $\frac{1}{4}$  of Section 12–T91N–R15W; thence east following substantially the section line to the Butler–Bremer County line at a point near the NE Corner of Section 12–T91N–R15W, Butler County (NW Corner of Section 7–T91N–R14W, Bremer County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 3 in Butler County, Iowa.
