Due to a review of our Primary Road System records, Iowa 3 in Buena Vista County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 3 begins at the Buena Vista-Cherokee County line approximately 5 miles north and 4 miles west of Alta and travels easterly intersecting with US 71 to the Buena Vista-Pocahontas County line approximately 1 ½ miles south and 2 miles east of Albert City.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 3 in Buena Vista County as follows:

Beginning at the Cherokee-Buena Vista County line at a point near the NW Corner of Section 31-T92N-R38W, Buena Vista County (SE Corner Section 25-T92N-R39W, Cherokee County); thence easterly following substantially the section line of Sections 31, 32, 33, 34, 35, and 36-T92N-R38W, Sections 31, 32, 33, 34, 35, and 36-T92N-R37W (junction US 71), Sections 31, 32, 33, 34, 35, and 36-T92N-R36W, and Sections 31, 32, 33, 34, 35, and 36-T92N-R35W to the Buena Vista-Pocahontas County line near the NE Corner Section 36-T92N-R35W, Buena Vista County (SW Corner Section 30-T92N-R34W, Pocahontas County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 3 in Buena Vista County, Iowa.
