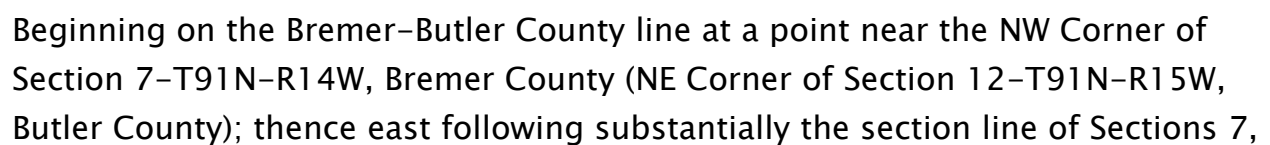
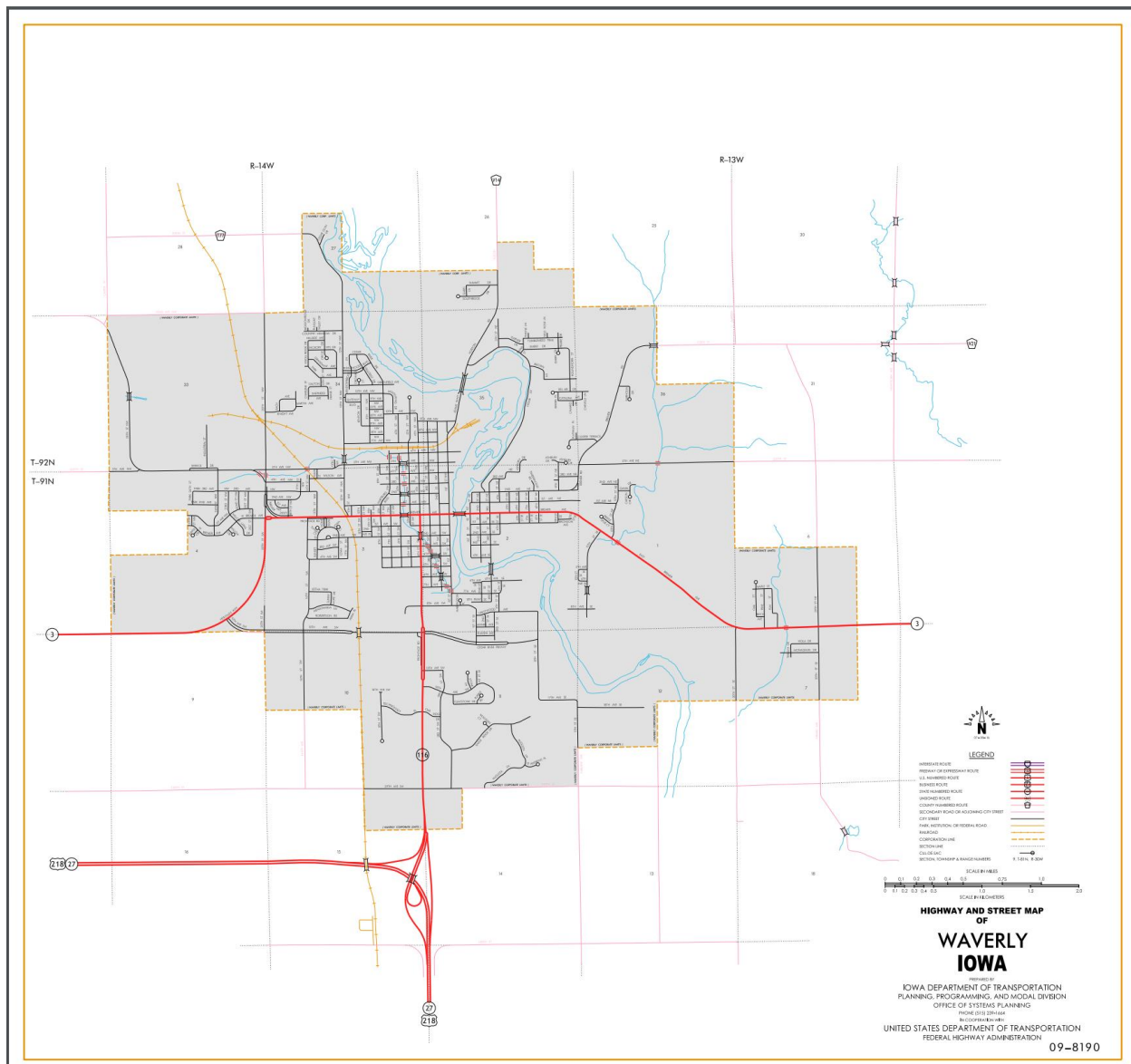

New Description – Iowa 3 and its extensions in Bremer County described as follows:

Beginning on the Bremer-Butler County line at a point near the NW Corner of Section 7-T91N-R14W, Bremer County (NE Corner of Section 12-T91N-R15W, Butler County); thence east following substantially the section line of Sections 7, 8, and 9-T91N-R14W to the west corporation line of Waverly connecting with Heritage Way.

Waverly:

Beginning on Heritage Way at the west corporation line; thence northeast on Heritage Way to 20th Street Southwest; thence north on 20th Street Southwest to unnamed street; thence northeast on unnamed street to West Bremer Avenue; thence east on West Bremer Avenue to East Bremer Avenue; thence east, southeast, and east on East Bremer Avenue to the east corporation line.

Beginning again at the east corporation line of Waverly connecting with East Bremer Avenue; thence east following substantially the section line of Sections 7, 6, 9, 10, 11, (junction US 63) and 12-T91N-R13W; Sections 7, 8, 9, 10, 11, and 12-T91N-R12W; and Sections 7, 8, 9, 10, 11, and 12-T91N-R11W to a point on the Bremer-Fayette County line near the NE Corner of Section 12-T91N-R11W, Bremer County (NW Corner of Section 7-T91N-R10W, Fayette County).

DISCUSSION/BACKGROUND:

Iowa 3 begins at the Bremer-Butler County line approximately two and one-half miles west of the City of Waverly, and travels easterly via the City of Waverly to the Bremer-Fayette County line approximately seven miles east of the City of Readlyn.

Due to an annexation to the City of Waverly, the present description of Iowa 3 in Bremer County should be revised to reflect this change in corporate limits. Iowa 3 in the remainder of Bremer County remains unchanged.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 3 in Bremer County from the primary road system and approve including the attached new description of Iowa 3 in the primary road system.

Locate Iowa 3 and its extension in Bremer County as follows:

Beginning on the Bremer–Butler County line at a point near the NW Corner of Section 7–T91N–R14W, Bremer County (NE Corner of Section 12–T91N–R15W, Butler County); thence east following substantially the section line of Sections 7, 8, and 9–T91N–R14W to the west corporation line of the City of Waverly connecting with an unnamed street.

Waverly:

Beginning on the west corporation line, connecting with an unnamed street; thence northeasterly, northerly, easterly, southeasterly and easterly to the east corporation line, connecting with an unnamed street.

Beginning again at the east corporation line of the City of Waverly connecting with an unnamed street; thence east following substantially the section line of Sections 7, 8, 9, 10, 11, (junction US 63) and 12–T91N–R13W; Sections 7, 8, 9, 10, 11, and 12–T91N–R12W; and Sections 7, 8, 9, 10, 11, and 12–T91N–R11W to a point on the Bremer–Fayette County line near the NE Corner of Section 12–T91N–R11W, Bremer County (NW Corner of Section 7–T91N–R10W, Fayette County).
