New Description – Iowa 3 and its extensions in Wright County described as follows:

Beginning on the Wright–Humboldt County line at a point near the NW Corner Section 6–T91N–R26W Wright County (NE Corner Section 1–T91N–R27W Humboldt County) (W junction Iowa 17); then east following substantially the section line of Sections 6 and 5–T91N–R26W to the west corporation line of Goldfield, connecting with an unnamed street.

Goldfield:

Beginning on an unnamed street at the west corporation line; then east on said unnamed street to the east corporation line.

Beginning again on the east corporation line of Goldfield connecting with an unnamed street; then easterly following substantially the section line of Sections 3, 2 and 1–T91N–R26W and Sections 6, 5, 4, 3 and 2–T91N–R25W to a point approximately 1,350 feet east of the SW Corner Section 35–T92N–R25W; then in a northeasterly and southeasterly direction through the south part of Section 35–T92N–R25W to a point approximately 1,400 feet west of the SE Corner Section 35–T92N–R25W; then easterly following substantially the section line of Section 2–T91N–R25W to the west corporation line of Clarion, connecting with Central Avenue.

Clarion:

Beginning on Central Avenue at the west corporation line; then east on Central Avenue to the east corporation line.

Beginning again on the east corporation line of Clarion, connecting with Central Avenue then easterly following substantially the section line of Sections 5, 4, 3, 2, (S junction US 69) and 1-T91N-R24W to a point approximately 1,200 feet west of the SE Corner Section 36-T92N-R24W; then curving in a northeasterly direction to a point approximately 1,200 feet north of the SE Corner Section 36-T92N-R24W; then northerly following substantially the section line of Section 31-T92N-R23W to a point near the NW Corner Section 31-T92N-R23W (N junction US 69); then easterly following substantially the section line of Sections 31, 32, 33, 34, 35 and 36-T92N-R23W to the Wright-Franklin County line at a point near the NE Corner Section 36-T92N-R23W, Wright County, (NW Corner Section 31-T92N-R22W, Franklin County).

**DISCUSSION/BACKGROUND:**

Iowa 3 begins on the Wright-Humboldt County line approximately 2 ½ miles west of Goldfield, and travels generally easterly via Goldfield and Clarion to the Wright Franklin County line approximately 2 ½ miles east and ½ mile north of Rowan, Iowa.

Due to a review of our Primary Road System Records Iowa 3 in Wright County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 3 in Wright County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System affective upon the adoption of this resolution.

Iowa 3 and its extensions in Wright County as follows:

Beginning on the Wright–Humboldt County line at a point near the NW Corner Section 6–T91N–R26W Wright County (NE. Corner Section 1–T91N–R27W Humboldt County) (W junction Iowa 17); thence easterly following substantially the section line of Sections 6 and 5–T91N–R26W to the west corporation line of the City of Goldfield connecting with an unnamed street.

Goldfield:

Beginning on the west corporation line connecting with an unnamed street: thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Goldfield connecting with an unnamed street; thence easterly following substantially the section line of Sections 3, 2, and 1–T91N–R26W and Sections 6, 5, 4, 3, and 2–T91N–R25W to a point approximately 1350 feet east of the SW Corner Section 35–T92N–R25W; thence in a northeasterly and southeasterly direction through the south part of Section 35–T92N–R25W to a point approximately 1400 feet west of the SE Corner Section 35–T92N–R25W; thence easterly following substantially

the section line of Section 2-T91N-R25W to the west corporation line of the City of Clarion connecting with an unnamed street.

Clarion:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Clarion, connecting with an unnamed street thence easterly following substantially the section line of Sections 5, 4, 3, 2, (S junction US 69) and 1-T91N-R24W to a point approximately 1200 feet west of the SE Corner Section 36-T92N-R24W; thence curving in a northeasterly direction to a point approximately 1200 feet north of the SE Corner Section 36-T92N-R24W; thence northerly following substantially the section line of Section 31-T92N-R23W to a point approximately 800 feet south of the NW Corner Section 31-T92N-R23W (N junction US 69); thence curving in a northeasterly direction to a point approximately 800 feet east of the NW Corner Section 31-T92N-R23W; thence easterly following substantially the section line of Sections 31, 32, 33, 34, 35, and 36-T92N-R23W to the Wright-Franklin County line at a point near the NE Corner Section 36-T92N-R23W, Wright County, (NW Corner Section 31-T92N-R22W, Franklin County).

Beginning again on the east corporation line of the Town of Goldfield, connecting with an unnamed street; thence east following substantially the section line to a point approximately ¼ mile east of the SW Corner Section 35-T92N-R25W; thence in a northeasterly and southeasterly direction through the south part of Section 35-T92N-R25W to a point approximately ¼ mile west of the SE Corner Section 35-T92N-R25W; thence east following substantially the section line to the west corporation line of the City of Clarion, connecting with Central Avenue.

Beginning again on the east corporation line of the City of Clarion, connecting with Central Avenue; thence east following substantially the section line to a point approximately 1,200 feet west of the SE Corner Section 36-T92N-R24W; thence curving in a northeasterly direction to a point approximately 1,200 feet north of the SE Corner Section 36--T92N-R24W; thence north following substantially the section line to a point approximately 800 feet south of the NW Corner Section 31-T92N-R23W; thence curving in a northeasterly direction to a point approximately 800 feet east of the NW Corner Section 31-T92N-R23W; thence east following substantially the section line to the Wright-Franklin County line at a point near the NE Corner Section 36-T92N-R23W, Wright County (NW Corner Section 31-T92N-R22W, Franklin County).
