New Description – Iowa 4 and its extensions in Greene County described as follows:

Beginning at the Greene-Guthrie County line near the S  $\frac{1}{4}$  Corner Section 32-T82N-R30W, Greene County (N  $\frac{1}{4}$  Corner Section 5-T81N-R30W, Guthrie County); thence north following substantially the center section line of Sections 32, 29, 20, 17, 8, and 5-T82N-R30W and Sections 32 and 29-T83N-R30W to a point near the N  $\frac{1}{4}$  Corner Section 29-T83N-R30W; thence in a northwesterly direction through Section 20--T83N-R30W to a point approximately 400 feet south of the W  $\frac{1}{4}$  Corner Section 20-T83N-R30W; thence north following substantially the section line of Sections 20 and 17-T83N-R30W to the south corporation line of Jefferson connecting with South Elm Street.

Jefferson:

Beginning on South Elm Street at the south corporation line; thence north on South Elm Street to North Elm Street; thence north on North Elm Street to the north corporation line (junction US 30).

Beginning again at the north corporation line of Jefferson connecting with North Elm Street; thence north following substantially the section line of Sections 32, 29, 20, 17, 8, and 5-T84N-R30W and Sections 32 and 29-T85N-R30W to a point approximately 800 feet south of the NW Corner of Section 29-T85N-R30W; thence curving in a northwesterly direction through Section 30-T85N-R30W to a point approximately 800 feet west of the NE Corner of Section 30-T85N-R30W; thence west following substantially the section line of Section 30-T85N-R30W and

Sections 25, 26, and 27–T85N–R31W to the east corporation line of Churdan connecting with Harding Street.

Churdan:

Beginning on Harding Street at the east corporation line; thence west on Harding Street to Fitzpatrick Street; thence north on Fitzpatrick Street to the north corporation line.

Beginning again at the north corporation line of Churdan connecting with Fitzpatrick Street; thence north following substantially the section line of Sections 9 and 4–T85N–R31W to a point on the Greene–Calhoun County line near the NW Corner Section 4–T85N–R31W, Greene County (SW Corner Section 33–T86N–R31W, Calhoun County).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System Iowa 4 in Greene County, Iowa should be deleted and the new description should be officially included into the Primary System.

Iowa 4 begins at the Greene–Guthrie County line approximately 10 miles south of Jefferson and travels in a northwesterly direction to the Greene–Calhoun County line approximately 2 miles north of Churdan, via the Cities of Jefferson and Churdan, Iowa.

## **PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 4 and its extensions in Greene County as follows:

Beginning at the Greene–Guthrie County Line near the S  $\frac{1}{4}$  Corner Section 32–T82N–R30W, Greene County (N  $\frac{1}{4}$  Corner Section 5–T81N–R30W, Guthrie County); thence north following substantially the center section line of Sections 32, 29, 20, 17, 8, and 5–T82N–R30W and Sections 32 and 29–T83N–R30W to a point near the N  $\frac{1}{4}$  Corner Section 29–T83N–R30W; thence in a northwesterly direction through Section 20–T83N–R30W to a point approximately 400 feet south of the W  $\frac{1}{4}$  Corner Section 20–T83N–R30W; thence north following substantially the section line of Sections 20 and 17–T83N–R30W to the south corporation line of the City of Jefferson connecting with an unnamed street.

Jefferson:

Beginning at the south corporation line connecting with an unnamed street; thence north to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Jefferson connecting with an unnamed street; thence northerly following substantially the section line of Sections 32, 29, 20, 17, 8, and 5–T84N–R30W and Sections 32 and 29–T85N–R30W to a point approximately 800 feet south of the NW Corner of Section 29–T85N–R30W; thence curving in a northwesterly direction through Section 30–T85N–R30W to a point approximately 800 feet west of the NE Corner Section 30–T85N–R30W; thence west following substantially the section line of Section 30–T85N–R30W and Sections 25, 26, and 27–T85N–R31W to the east corporation line of the City of Churdan connecting with an unnamed street.

Churdan:

Beginning at the east corporation line connecting with an unnamed street; thence westerly and northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Churdan connecting with an unnamed street; thence northerly following substantially the section line of Sections 9 and 4-T85N-R31W to a point on the Greene-Calhoun County line near the NW Corner Section 4-T85N-R31W, Greene County (SW Corner Section 33-T86N-R31W, Calhoun County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 4 in Greene County, Iowa.

Beginning on the Greene-Guthrie County line at a point near the S  $\frac{1}{4}$  Corner Section 32-T82N-R30W, Greene County (N  $\frac{1}{4}$  Corner Section 5-T81N-R30W, Guthrie County); thence north, following substantially the  $\frac{1}{4}$  section line to a point near the N  $\frac{1}{4}$  Corner Section 29-T83N-R30W; thence in a northwesterly direction to a point approximately 400 feet south of the W  $\frac{1}{4}$  Corner Section 20-T83N-R30W; thence north following substantially the section line to the south corporation line of the City of Jefferson connecting with South Elm Street.

Jefferson:

Beginning on South Elm Street at the south corporation line; thence north on South Elm Street and North Elm Street to the north corporation line.

Beginning again on the north corporation line of the City of Jefferson connecting with North Elm Street; thence north following substantially the section line to a point approximately 300 feet south of the NE Corner Section 30-T85N-R30W; thence curving in a northwesterly direction to a point approximately 300 feet west of the NE Corner Section 30-T85N-R30W; thence west following substantially the section line to the east corporation line of the Town of Churdan connecting with Harding Street.

Churdan:

Beginning on Harding Street at the east corporation line; thence westerly on Harding Street to Fitzpatrick Street; thence northerly on Fitzpatrick Street to the north corporation line.

Beginning again at the north corporation line of the Town of Churdan connecting with Fitzpatrick Street; thence north following substantially the section line to the Greene-Calhoun County line at the NE Corner Section 5-T85N-R31W, Greene County (SE Corner Section 32-T86N-R31W, Calhoun County).
