New Description – Iowa 5 and its extensions in Polk County described as follows:

Beginning on the Polk-Warren County line at a point near the SW Corner Section 33-T78N-R23W, Polk County (NW Corner Section 4-T77N-R23W, Warren County); thence northwesterly and westerly to the east corporation line of Des Moines (approximately 290 feet north of the S ¼ Corner SE ¼ Section 31-T78N-R23W).

Des Moines:

Beginning on the east corporation line, connecting with an unnamed street (approximately 290 feet north of the S ¼ Corner SE ¼ Section 31-T78N-R23W); thence southwesterly on said unnamed street to the south corporation line (approximately 840 feet west of the S ¼ Corner Section 31-T78N-R23W) (Polk-Warren County line).

(Warren County Section)

Des Moines:

Beginning on the Polk-Warren County line/south corporation line at a point near the SE Corner Section 31-T78N-R24W, Polk County (NE Corner Section 6-T77N-R24W, Warren County) connecting with an unnamed street; thence westerly on said unnamed street to the south junction of Iowa 28 (approximately 730 feet north and 600 feet east of the S ¼ Corner Section 36-T78N-R25W); thence westerly approximately 4560 feet to the east corporation

line of West Des Moines (approximately 540 feet north of the S ¼ Corner SE ¼ Section 35–T78N–R25W) connecting with an unnamed street.

West Des Moines:

Beginning on the east corporation line (approximately 540 feet north of the S ¼ Corner SE ¼ Section 35–T78N–R25W) connecting with an unnamed street; thence westerly and northwesterly to the junction with Interstate 35 (approximately 790 feet south and 670 feet west of the NE Corner Section 31–T78N–R25W).

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 5 and its extensions in Polk County be deleted and the new description be included in the Primary Road System.

DISCUSSION/BACKGROUND:

Iowa 5 is being relocated between Southeast 14th Street (US 69/65) and Iowa 28.

Transfer of jurisdiction agreement number 2001–TJ–002, between the City of Des Moines and the Iowa Department of Transportation, transferred that portion of Iowa 5 from Southeast 14th Street (US 69/65) to Iowa 28 (a point

near the E ¼ Corner SW ¼ Section 36–T78N–R25W) to city jurisdiction on February 20, 2001.

New Description – Iowa 5 and its extensions in Polk County described as follows:

Beginning on the Polk–Warren County line at a point near the SW Corner Section 33–T78N–R23W, Polk County (NW Corner Section 4–T77N–R23W, Warren County); thence in a northwesterly and westerly to the east corporation line of Des Moines (approximately 290 feet north of the S ¼ Corner SE ¼ Section 31–T78N–R23W).

Des Moines:

Beginning on the east corporation line, connecting with an unnamed street (approximately 290 feet north of the S ¼ Corner SE ¼ Section 31–T78N–R23W); thence southwesterly on said unnamed street to the south corporation line (approximately 840 feet west of the S ¼ Corner Section 31–T78N–R23W) (Polk–Warren County line).

(Warren County Section)

Des Moines:

Beginning on the Polk–Warren County line/south corporation line at a point near the SE Corner Section 31–T78N–R24W, Polk County (NE Corner Section 6–T77N–R24W, Warren County) connecting with an unnamed street; thence westerly on said unnamed street to the south junction of Iowa 28 (approximately 730 feet north and 600 feet east of the S ¼ Corner Section 36–T78N–R25W); thence northwesterly and northerly to the north junction of Iowa 28 (Army Post Road) (approximately 990 feet west of the NE Corner Section 35–T78N–R25W) connecting with Army Post Road; thence west on Army Post Road to the west corporation line/east corporation line of West Des Moines at approximately 1340 feet west of the NE Corner Section 35–T78N–R25W.

West Des Moines:

Beginning on the east corporation line of West Des Moines/west corporation line of Des Moines, connecting with Army Post Road (approximately 1340 feet west of the NE Corner Section 35-T78N-R25W); thence west on Army Post Road to the west corporation line (approximately 1280 feet west of the NE Corner Section 34-T78N-R25W).

Beginning again on the west corporation line of West Des Moines (approximately 1280 feet west of the NE Corner Section 34-T78N-R25W); thence westerly on Army Post Road to approximately 380 feet east of the NW Corner Section 33-T78N-R25W (begin one-way northbound); thence westerly following substantially the north section line of Section 32-T78N-R25W to the Interstate 35 ramp (approximately 990 feet west and 160 feet south of the NE Corner Section 31-T78N-R25W) (end one-way northbound).

Also

Beginning at the Iowa 5/Interstate 35 ramps, connecting with an unnamed street (approximately 1450 feet south and 260 feet east of the NW Corner Section 32-T78N-R25W) (begin one-way southbound); thence easterly and southeasterly on said unnamed street to the junction with Southwest 96th Court (approximately 2060 feet south and 720 feet east of the NW Corner Section 33-T78N-R25W); thence northerly approximately 2100 feet on Southwest 96th Court to the junction of northbound Iowa 5 (approximately 380 feet east of the NW Corner Section 33-T78N-R25W).

Beginning on the Warren-Polk County line at a point near the SW Corner Section 33-T78N-R23W, Polk County (NW Corner Section 4-T77N-R23W, Warren County); thence in a northwesterly, westerly, and southwesterly direction to the Polk-Warren County line just east of the SW Corner Section 31-T78N-R23W, Polk County (NW Corner Section 6-T77N-R23, Warren County).

(Warren County Section)

Des Moines:

Beginning on the Polk-Warren County line/south corporation line of Des Moines at a point near the SE Corner Section 35-T78N-R24W, Polk County (NE Corner Section 2-T77N-R24W, Warren County), connecting with an unnamed street; thence northwesterly and northerly on said unnamed street to Army Post Road (SE Corner Section 27-T78N-R24W); thence west and southwest on Army Post Road to a point near the N $\frac{1}{4}$ Corner Section 32-T78N-R24W; thence southwest, west, and southwest to a point near the E $\frac{1}{4}$ Corner SW $\frac{1}{4}$ of Section 36-T78N-R25W (south junction Iowa 28), connecting with an unnamed street; thence northwest and north on said unnamed street to Army Post Road (north junction Iowa 28); thence west on Army Post Road approximately 320 feet to the west corporation line/east corporation line of West Des Moines.

West Des Moines:

Beginning on the east corporation line/west corporation line of Des Moines (320 feet west of north junction Iowa 28), connecting with Army Post Road; thence west on Army Post Road to the west corporation line.

Beginning again on the west corporation line of West Des Moines at a point near the N $\frac{1}{4}$ corner NE $\frac{1}{4}$ Section 34-T78N-R25W; thence west following substantially the south section line of Sections 34, 33, and 32-T78N-R25W to a point approximately 650 feet east of NW Corner Section 32-T78N-R25W; thence southwest of the NW Corner Section 32-T78N-R25W approximately 1425 feet (center of interchange with Interstate 35); thence southwest approximately 320 feet to the west ramps of Interstate 35.

Beginning on an unnamed street at the east corporation line; thence northwest on unnamed street to Army Post Road; thence west and southwest on Army Post Road to a point near the N $\frac{1}{4}$ Corner Section 32–T78N–R24W; thence southwest and west to a point near the E $\frac{1}{4}$ Corner Section 36–T78N–R25W (junction Southwest 42nd Street); thence north on Southwest 42nd Street to a point near the NE Corner Section 36–T78N–R25W (junction Army Post Road); thence west on Army Post Road to the west corporation line (east corporation line of West Des Moines).

West Des Moines:

Beginning on an unnamed street at the east corporation line (west corporation line of Des Moines); thence west on said unnamed street to the west corporation line.

DISCUSSION/BACKGROUND:

Iowa 5 is being routed with US 65 from the east junction to the west junction; thence north on US 69 to its current location on Army Post Road in Des Moines.

Transfer of jurisdiction agreement numbers 91-TJ-014 and 91-TJ-012, between the Iowa Department of Transportation, the City of Des Moines and Polk County transferred the old location of Iowa 5 to the City of Des Moines and Polk County on December 31, 1997.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the old description of Iowa 5 in Polk County be deleted from the Primary Road System and the new description, as described in the attachment, be included in the Primary Road System.

New Description – Iowa 5 and its extension in Polk County described as follows:

Beginning on the Warren-Polk County line at a point near the SW Corner Section 33-T78N-R23W, Polk County (NW Corner Section 4-T77N-R23W, Warren County) in a northwesterly, westerly and southwesterly direction to the Polk-Warren County line just east of the SW Corner Section 31-T78N-R23W, Polk County (NW Corner Section 6-T77N-R23W, Warren County).

(Warren County Section)

Beginning on the Polk–Warren County line near the SE Corner Section 35–T78N–R24W, Polk County (NE Corner Section 2–T77N–R24W, Warren County); thence northwest through Section 35–T78N–R24W to the east corporation line of Des Moines, connecting with an unnamed street.

Des Moines:

Beginning on an unnamed street at the east corporation line; thence northwest on unnamed street to Army Post Road; thence west on Army Post Road to the west corporation line.

Beginning again on the west corporation line of Des Moines connecting with Army Post Road; thence west following substantially the section line of Section 31–T78N–R24W and Sections 36, 35, 34, 33 and 32–T78N–R25W to a point near the NW Corner Section 32–T78N–R25W; thence west through the south part of Section 30–T78N–R25W to a point (center of interchange with Interstate 35) approximately 434 meters (1425 feet) west of the SE Corner Section 30–T78N–R25W; thence west through the south part of said Section 30 to a point approximately 533 meters (1750 feet) west of the SE Corner Section 30–T78N–R25W, Polk County.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 5 in Polk County should be deleted and the new description added should be officially included into the Primary System.

Iowa 5 begins on the Polk-Warren County line approximately 2 miles west of Carlisle, and travels northwesterly and westerly via the City of Des Moines to a point approximately 1 mile north and 2/3 mile east of the SW Corner of Polk County, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 5 and its extension in Polk County as follows:

Beginning on the Polk-Warren County line at a point near the SW Corner Section 33-T78N-R23W, Polk County (NW Corner Section 4-T77N-R23W, Warren County); thence in a northwesterly direction through Sections 33 and 32-T78N-R23W to a point approximately ¼ mile west of the E ¼ Corner Section 32-T78N-R23W to a point (junction Iowa 46) approximately ¼ mile west and 100 feet north of the SE Corner Section 29-T78N-R23W; thence westerly

through the southern part of Section 29-T78N-R23W to a point near the NE Corner Section 31-T78N-R23W thence westerly following substantially the section line of Sections 31-T78N-R23W and Sections 36 and 35-T78N-R24W to the east corporation line of the City of Des Moines connecting with an unnamed street.

Des Moines:

Beginning on the east corporation line connecting with an unnamed street; thence westerly to the west corporation line connecting with an unnamed street.

Beginning again on the west corporation line of the City of Des Moines connecting with an unnamed street; thence westerly following substantially the section line of Section 31-T78N-R24W (junction Iowa 28) and Sections 36, 35, 34, 33 and 32-T78N-R25W to a point near the NW Corner Section 32-T78N-R25W; thence westerly through the south part of Section 30-T78N-R25W to a point (center of interchange with Interstate 35) approximately 1425 west of the SE Corner Section 30-T78N-R25W thence westerly through the south part of said Section 30 to a point approximately 1750 feet west of the SE Corner Section 30-T78N-R25W, Polk County.
