Due to the review of our Primary Road System records, Iowa 8 in Benton County, Iowa should be deleted and the new description added should be officially included into the Primary System.

Iowa 8 begins at the Benton-Tama County line approximately ½ mile north of Dysart and travels easterly to the junction US 218 approximately 5 miles east of Dysart.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 8 in Benton County as follows:

Beginning on the Benton-Tama County line at a point near the NW Corner of Section 18-T85N-R12W, Benton County (SE Corner of Section 12-T85N-R13W, Tama County); thence east following substantially the section line of Section 18, 17, 16, 15, and 14-T86N-R12W to a point approximately 850 feet west of the NE corner said Section 14; thence northeasterly through Sections 11 and 12-T86N-R12W to a junction with US 218 in the SW ¼ Section 12-T86N-R12W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 8 in Benton County, Iowa.
