Chatsworth:

Beginning on 12th Avenue at the Sioux-Plymouth County line; thence north on 12th Avenue to the north corporation line.

Beginning on the north corporation line of Chatsworth connecting with 12th Avenue; thence northeast through Sections 28, 27, 22, 15 and 14-T94N-R48W and north through Sections 11 and 2-T94N-R48W to the south corporation line of Hawarden, connecting with Avenue E.

Hawarden:

Beginning on Avenue E at the south corporation line; thence north on Avenue E to 10th Street (junction Iowa 10).

Due to a review of our Primary Road System Records Iowa 12 in Sioux County should be deleted and the new description added should be officially included into the Primary System.

Locate Iowa 12 and its extensions in Sioux County as follows:

Chatsworth:

Beginning on an unnamed street at the Sioux–Plymouth County line; thence northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Chatsworth connecting with an unnamed street; thence in a northeasterly direction through Sections 28, 27, 22, 15 and 14–T94N–R48W and in a northerly direction through Sections 11 and 2–T94N–R48W to the south corporation line of the City of Hawarden connecting with an unnamed street.

Hawarden:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to 10th Street (junction Iowa 10).
