New description – Iowa 14 and its extension in Lucas County described as follows:

Beginning on the Lucas-Wayne County line at a point approximately 300 feet east of the S $\frac{1}{4}$ Corner Section 31-T71N-R21W, Lucas County (N $\frac{1}{4}$ Corner Section 6-T70N-R21W, Wayne County); thence in a northerly and northeasterly direction through Section 31 and 30-T71N-R21W to a point approximately 1000 feet north of the SE Corner of Section 30-T71N-R21W; thence north following substantially the section line of Sections 29, 20, 17, 8, and 5-T71N-R21W and Section 32 and 29-T72N-R21W to the south corporation line of Chariton connecting with Main Street.

Chariton:

Beginning on Main Street at the south corporation line; thence north on Main Street to Woodlawn Avenue; thence easterly on Woodlawn Avenue to 7th Street; thence north on 7th Street to the north corporation line.

Beginning again on the north corporation line of Chariton connecting with 7th Street; thence north following substantially the west quarter section line of Sections 17, 8, and 5-T72N-R21W to a point approximately 1300 feet west and 800 feet south of the center of Section 5-T72N-R21W; thence in a northeasterly direction through Section 5-T72N-R21W, Sections 32, 33, 28, 27, 22, 23, 14, and 13-T73N-R21W, and Sections 18, 7, 8, and 5-T73N-R20W to the Lucas-Marion County line at a point approximately 300 feet east of the N $\frac{1}{4}$ Corner of Section 5-T73N-R20W, Lucas County (S $\frac{1}{4}$ Corner Section 32-T74N-R20W, Marion County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 14 in Lucas County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 14 begins at Lucas-Wayne County line approximately 7 miles south of Chariton travels in a northerly direction to the Lucas-Marion County line via the City of Chariton, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 14 and its extension in Lucas County, Iowa as follows:

Beginning on the Lucas-Wayne County line at a point approximately 300 feet east of the S $\frac{1}{4}$ Corner Section 31-T71N-R21W Lucas County (N $\frac{1}{4}$ Corner Section 6-T70N-R21W, Wayne County); thence in a northerly and northeasterly direction through Section 31 and 30-T71N-R21W, to a point approximately 1000 feet north of the SE Corner of Section 30-T71N-R21W; thence north following substantially the section line of Sections 29, 20, 17, 8 and 5-T71N-R21W and Section 32 and 29-T72N-R21W to the south corporation line of the City of Chariton connecting with an unnamed street.

Chariton:

Beginning on the south corporation line connecting with an unnamed street; thence northerly, easterly and northerly to the north corporation line, connecting with an unnamed street.

Beginning again on the north corporation line of the City of Chariton, connecting with an unnamed street; thence north following substantially the west quarter line of Section 17, 8 and 5-T72N-R21W, to a point approximately 1300 feet west and 800 feet south of the center of Section 5-T72N-R21W; thence in a northeasterly direction through Section 5-T72N-R21W, Sections 32, 33, 28, 27, 22, 23, 14, and 13-T73N-R21W, and Section 18, 7, 8, and 5-T73N-R20W to the Lucas-Marion County line at a point approximately 300 feet east of the N $\frac{1}{4}$ Corner Section 5-T73N-R20W, Lucas County (S $\frac{1}{4}$ Corner Section 32-T74N-R20W, Marion County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 14, Lucas County, Iowa.

Beginning again on the north corporation line of the City of Chariton, connecting with Seventh Street; thence north following substantially the west quarter-quarter line of Section 17, 8 and 5-T72N-R21W, to a point approximately $\frac{1}{4}$ mile west and 800 feet south of the center of Section 5-T72N-R21W; thence in a northeasterly direction through Section 5-T72N-R21W, Section 32, 33, 28, 27, 22, 23, 14 and 13-T73N-R21W, and Section 18, 7, 8 and 5-T73N-R20W to the Lucas-Marion County line at a point approximately 300 feet east of the N $\frac{1}{4}$ Corner of Section 5-T73N-R20W, Lucas County (S $\frac{1}{4}$ Corner of Section 32-T74N-R20W, Marion County).
