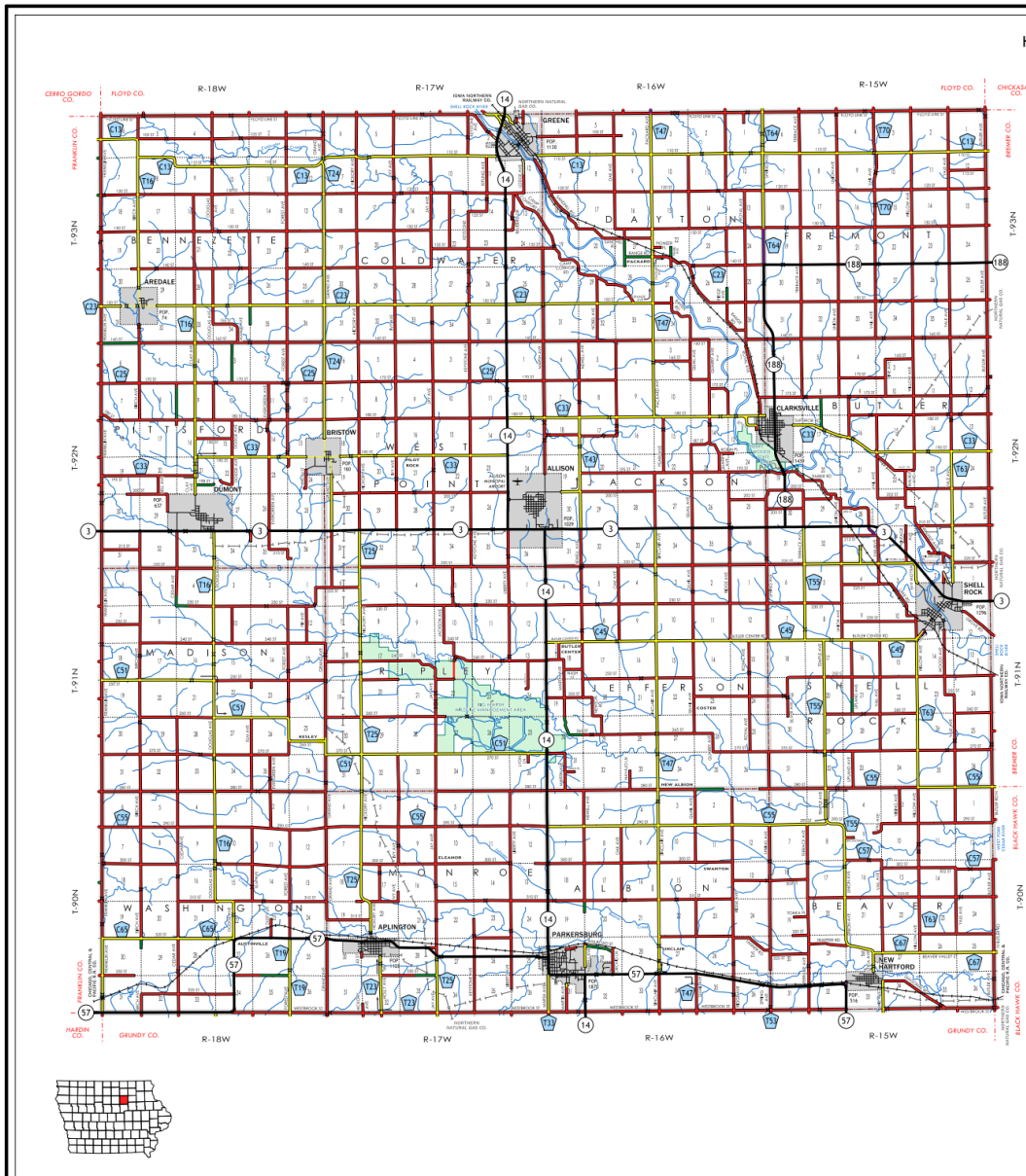

New description – Iowa 14 and its extensions in Butler County described as follows:

Beginning at the Butler–Grundy County line at a point near the SE Corner of Section 31–T90N–R16W, Butler County (NE Corner of Section 6–T89N–R16W, Grundy County); thence north following substantially the section line of Section 32–T90N–R16W to a point near the NW Corner Section 32 (east junction Iowa 57) at the east corporation line of Parkersburg connecting with Newell Avenue.

Parkersburg:

Beginning at the junction of Iowa 57 and Newell Avenue at the east corporation line; thence west to 6th Street; thence north on 6th Street to the north corporation line.

Beginning again at the north corporation line of Parkersburg connecting with 6th Street; thence north following substantially the section line of Sections 30, 19, 18, 7, 6–T90N–R16W; Sections 31, 30, 19, 18, 7, and 6–T91N–R16W; and Section 31–T92N–R16W to the south corporation line of Allison.

Allison:

Beginning at the south corporation line; thence north to the junction Iowa 3 and Cherry Street; thence west to the west corporation line.

Beginning again on the west corporation line of Allison connecting with Liberty Avenue; thence north following substantially the section line of Sections 25, (west junction Iowa 3) 24, 13, 12, and 1–T92N–R17W, and Sections 36, 25, 24, 13, and 12–T93N–R17W to a point approximately 600 feet south of the E $\frac{1}{4}$ Corner Section 11–T93N–R17W; thence in a northwesterly direction through Section 11–T93N–R17W to the south corporation line of Greene, connecting with South Street.

Greene:

Beginning on the south corporation line connecting with South street; thence northwesterly and northeasterly to the north corporation line.

Beginning again on the north corporation line of Greene, connecting with Sandhill Road; thence in a northeasterly direction through Section 2-T93N-R17W to the Butler-Floyd County line at a point near the NE Corner of Section 2-T93N-R17W, Butler County (SE Corner of Section 35-T94N-R17W, Floyd County).

Beginning again at the north corporation line of Parkersburg connecting with 6th Street; thence north following substantially the section line of Sections 30, 19, 18, 7, 6-T90N-R16W; Sections 31, 30, 19, 18, 7, and 6-T91N-R16W; and Section 31-T92N-R16W to the south corporation line of Allison connecting with an unnamed street.

Allison:

Beginning on an unnamed street at the south corporation line; thence north and west on unnamed street to the west corporation line.

Beginning again on the west corporation line of Allison connecting with an unnamed street; thence north following substantially the section line of Sections 25, (west junction Iowa 3) 24, 13, 12, and 1-T92N-R17W, and Sections 36, 25, 24, 13, and 12-T93N-R17W to a point approximately 600 feet south of the E $\frac{1}{4}$ Corner Section 11-T93N-R17W; thence in a northwesterly direction through Section 11-T93N-R17W to the south corporation line of Greene, connecting with an unnamed street.

Greene:

DISCUSSION/BACKGROUND:

Iowa 14 begins on the Butler-Grundy County line approximately one mile southeast of Parkersburg and travels generally northerly via Parkersburg, Allison, and Greene to the Butler-Floyd County line approximately one mile northwest of Greene.

Due to an annexation to the south corporation line of the City of Allison, the present description of Iowa 14 in Butler County should be revised. The new description added should be officially included in the primary road system to reflect this change in corporate limits.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 14 in Butler County be deleted and the new description, as listed in the attached detailed description, be included in the primary road system.

Locate Iowa 14 and its extensions in Butler County as follows:

Beginning at the Butler-Grundy County line at a point near the SE Corner of Section 31-T90N-R16W, Butler County (NE Corner of Section 6-T89N-R16W, Grundy County); thence north following substantially the section line of Section 32-T90N-R16W to the corporation line of the City of Parkersburg connecting with an unnamed street.

Parkersburg:

Beginning at the east corporation line connecting with an unnamed street; thence westerly and northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Parkersburg connecting with an unnamed street; thence north following substantially the section line of Sections 30, 19, 18, 7, 6-T90N-R16W; Sections 31, 30, 19, 18, 7, and 6-T91N-R16W; and Section 31-T92N-R16W to the south corporation line of the City of Allison connecting with an unnamed street.

Allison:

Beginning on the south corporation line connecting with an unnamed street; thence northerly and westerly to the west corporation line connecting with an unnamed street.

Beginning again on the west corporation line of the City of Allison connecting with an unnamed street; thence westerly following substantially the section line of Section 36-T92N-R17W to a point near the SW Corner of Section 25-T92N-R17W (west junction Iowa 3); thence north following substantially the section line of Sections 25, 24, 13, 12, and 1-T92N-R17W, and Sections 36, 25, 24, 13, and 12-T93N-R17W to a point approximately 600 feet south of the E $\frac{1}{4}$ Corner Section 11-T93N-R17W; thence in a northwesterly direction through Section 11-T93N-R17W to the south corporation line of the City of Greene, connecting with an unnamed street.

Greene:

Beginning on the south corporation line connecting with an unnamed street; thence northwesterly and northeasterly to the north corporation line connecting with an unnamed street.

Beginning at the Butler–Grundy County line at a point near the SE Corner of Section 31–T90N–R16W, Butler County (NE Corner of Section 6–T89N–R16W, Grundy County); thence north following substantially the section line of Section 32–T90N–R16W to the east corporation line of the City of Parkersburg connecting with an unnamed street (junction US 20).

Parkersburg:

Beginning at the east corporation line connecting with an unnamed street; thence westerly and northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Parkersburg connecting with an unnamed street; thence north following substantially the section line of Sections 30, 19, 18, 7, 6-T90N-R16W; Sections 31, 30, 19, 18, 7, and 6-T91N-R16W; and Section 31-T92N-R16W to a point near the NW Corner of Section 31-T91N-R16W (east junction Iowa 3); thence west following substantially the section line of Section 36-T92N-R17W to a point near the SW Corner of Section 25-T92N-R17W (west junction Iowa 3); thence north following substantially the section line of Sections 25, 24, 13, 12, and 1-T92N-R17W, and Sections 36, 25, 24, 13, and 12-T93N-R17W to a point approximately 600 feet south of the E $\frac{1}{4}$ Corner Section 11-T93N-R17W; thence in a northwesterly direction through Section 11-T93N-R17W to the south corporation line of the City of Greene, connecting with an unnamed street.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 14 in Butler County should be deleted and the new description added should be officially included into the Primary System.

Iowa 14 begins at the Butler–Grundy County line approximately 1 mile south of Parkersburg and travels northerly intersecting with US 20, westerly and northerly, intersecting with Iowa 3 through Parkersburg and Greene to the Butler–Floyd County line approximately ½ mile north of Greene.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 14 and its extensions in Butler County as follows:

Beginning at the Butler–Grundy County line at a point near the SE Corner of Section 31–T90N–R16W, Butler County (NE Corner of Section 6–T89N–R16W, Grundy County); thence north following substantially the section line of Section 32–T90N–R16W to a point near the NW Corner of Section 32–T90N–R16W (junction US 20); thence west to the east corporation line of the City of Parkersburg connecting with an unnamed street.

Parkersburg:

Beginning at the east corporation line connecting with an unnamed street; thence westerly to Sixth Street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Parkersburg connecting with unnamed street; thence north following substantially the section line of Sections 19, 18, 7, 6-T90N-R16W; thence continuing northerly following substantially the section line of Sections 31, 30, 19, 18, 7, and 6-T91N-R16W; thence continuing northerly following substantially the section line of Section 31-T92N-R16W to a point near the NW Corner of Section 31-T91N-R16W (east junction Iowa 3); thence west along the south corporation line of the City of Allison and Section 36-T92N-R17W to a point approximately 270 feet east of the SW Corner of Section 25-T92N-R17W (west junction Iowa 3); thence curving in a northwesterly direction to a point approximately 30 feet west and 300 feet north of the SW Corner of Section 25-T92N-R17W; thence northerly approximately 3/4 mile to a point on the west side of Section 25-T92N-R17W; thence north following substantially the section line of Sections 25, 24, 13, 12, and 1-T92N-R17W, continuing north following substantially the section line of Sections 36, 25, 24, 13, and 12-T93N-R17W to a point approximately 600 feet south of the E 1/4 Corner Section 11-T93N-R17W; thence in a northwesterly direction to the south corporation line of the City of Greene, connecting with an unnamed street.

Beginning again on the north corporation line of the City of Greene, connecting with an unnamed street; thence in a northeasterly direction to the south corporation line of the City of Greene connecting with an unnamed street.

Beginning again on the north corporation line of the City of Greene, connecting with an unnamed street; thence in a northeasterly direction to the Butler-Floyd County line at a point near the NE Corner of Section 2-T93N-R17W, Butler County (SE Corner of Section 35-T94N-R17W, Floyd County).
