TITLE: Iowa 15, Palo Alto County, Iowa

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records Iowa 15 in Palo Alto County should be deleted and the new description added should be officially included into the Primary System.

Iowa 15 begins on the Palo Alto-Kossuth County line near the SE Corner of Palo Alto County, and travels northerly along the Palo Alto-Kossuth County line via West Bend to a junction with US 18.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 15 and its extension in Palo Alto County as follows:

Beginning at a point near the SE Corner Section 35-T94N-R31W, Palo Alto County (SW Corner Section 31-T94N-R30W, Kossuth County) (NW Corner Section 6-T93N-R30W, Humboldt County); thence north along the Palo Alto-Kossuth County line to the south corporation line of the City of West Bend connecting with an unnamed street.

West Bend:

Beginning on an unnamed street at the south corporation line thence north of said unnamed street Palo Alto-Kossuth County line to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of West Bend connecting with an unnamed street; thence north along the Palo Alto–Kossuth County line to the south corporation line of the City of West Bend connecting with an unnamed street.

West Bend:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street (Palo Alto–Kossuth County line) to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of West Bend connecting with an unnamed street; thence northerly on the Kossuth–Palo Alto County line to the NE Corner Section 1–T95N–R31W, Palo Alto County (NW Corner Section 6–T95N–R30W, Kossuth County (junction US 13)).

NOTE: See Kossuth County description for details and mileage.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 15 in Palo Alto County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

Beginning again on the north corporation line of the Town of West Bend connecting with an unnamed street; thence north on the Kossuth-Palo Alto county line to the NE Corner Section 1-T95N-R31W, Palo Alto County (NW Corner Section 6-T95N-R30W, Kossuth County).

CONNECTING CURVE

Junction of US 18 and Iowa 15

Beginning on the Palo Alto-Kossuth County line at a point approximately 700 feet south of the NE Corner Section 1-T95N-R31W, Palo Alto County (NW Corner Section 6-T95N-R30W, Kossuth County); thence curving in a northwesterly direction to a point approximately 700 feet west of the NE Corner Section 1-T95N-R31W.
