Beginning at the Benton-Iowa County line at a point near the SW Corner Section 32-T82N-R12W, Benton County (NW Corner of Section 5-T81N-R12W, Iowa County); thence north following substantially the section line of Sections 32 and 29-T82N-R12W to the south corporation line of Belle Plaine connecting with 7th Avenue.

Belle Plaine:

Beginning at the south corporation line connecting with 7th Avenue; thence north on 7th Avenue to 13th Street; thence west and northwest on 13th Street to the west corporation line.

Beginning again on the west corporation line of Belle Plaine connecting with 13th Street; thence in a northwesterly direction through Sections 19 and 18-T82N-R12W to a point on the Benton-Tama County line approximately $\frac{1}{4}$ mile north of the SW Corner of Section 18-T82N-R12W; thence north along the Benton-Tama County line following substantially the section line of Sections 18, 7, and 6-T82N-R12W, Sections 31 (junction US 30) 30, 19, 18, 7, and 6-783N-R12W, Sections 31, 30, 19, 18, 7, and 6-T84N-R12W, and Sections 31, 30, 19, and 18-T85N-R12W to a point near the NW Corner of Section 18-T85N-R12W, Benton County (NE Corner of Section 13-T85N-R13W, Tama County) (junction Iowa 8).

Beginning again on the west corporation line of the City of Belle Plaine connecting with an unnamed street; thence in a northwesterly direction through Sections 19 and 18-T82N-R12W to a point on the Benton-Tama County line approximately ¼ mile north of the SW Corner of Section 18-T82N-R12W thence north along the Benton-Tama County line following substantially the section line of Sections 18, 7, and 6-T82N-R12W, Sections 31 (junction US 30), 30, 19, 18, 7, and 6-T83N-R12W, Sections 31, 30, 19, 18, 7, and 6-T84N-R12W, and Sections 31, 30, 19, and 18-T85N-R12W to a point near the NW Corner of Section 18-T85N-R12W, Benton County (NE Corner of Section 13-T85-R13W, Tama County) (junction Iowa 8).

Beginning again on the west corporation line of the City of Belle Plaine connecting with an unnamed street; thence in a northwesterly direction through Sections 19 and 18-T82N-R12W to a point on the Benton-Tama County line approximately ¼ mile north of the SW Corner of Section 18-T82N-R12W (junction Iowa 212); thence north along the Benton-Tama County line following substantially the section line of Sections 18, 7, and 6-T82N-R12W, continuing along Section line of Sections 31 (junction US 30), 30, 19, 18, 7, and 6-T83N-R12W, continuing along section line of Sections 31, 30, 19, 18, 7, and 6-T84N-R12W, continuing along section line of Sections 31, 30, 19, and 18-T85N-R12W to a point near the NW Corner of Section 18-T85N-R12W, Benton County (NE Corner of Section 13-T85N-R13W, Tama County)(junction Iowa 8).

Connecting Curves

Junction of Primary Road No. 21 and Relocation of Primary Road No. U.S. 30

Beginning a point approximately 1000 feet south of the NW Corner of Section 31-T83R12, thence curving in a northeasterly direction to a point approximately 1000 feet east of the NW Corner of Section 31-T83-R12.

Beginning at a point approximately 1000 feet north of the SW Corner of Section 30-T-83-R12, thence curving in a southeasterly direction to a point approximately 1000 feet east of the SE Corner of Section 30-T-83-R12.

CONNECTING CURVES

Junction of Iowa 21 and of US 30

Beginning at a point approximately 1000 feet south of the NW Corner of Section 31-T83N-R12W; thence curving in a northeasterly direction to a point approximately 1000 feet east of the NW Corner of Section 31-T83N-R12W.

Beginning at a point approximately 1000 feet north of the SW Corner of Section 30-T83N-R12W thence curving in a southeasterly direction to a point approximately 1000 feet east of the SE Corner of Section 30-T83N-R12W.

Junction of Iowa 21 and Iowa 212

Beginning at a point approximately 100 feet east of the SW Corner of Section 18-T82N-R12W; thence curving in a northeasterly direction to a point approximately 300 feet east and 300 feet north of the SW Corner of Section 18-T82N-R12W.
