New Description – Iowa 22 and its extensions in Washington County described as follows:

Beginning on the Washington-Keokuk County line at a point near the NW Corner Section 19-T77N-R9W, Washington County (NE Corner Section 24-T77N-R10W, Keokuk County); thence east following substantially the section line of Sections 19, 20, 21, 22, 23 and 24-T77N-R9W to the west corporation line of Wellman, connecting with 6th Street.

Wellman:

Beginning on 6th Street at the west corporation line; thence east on 6th Street to the east corporation line.

Beginning again on the east corporation line of Wellman connecting with 6th Street; thence east following substantially the section line of Section 19-T77N-R8W to a point approximately 2,150 feet east of the NW Corner said Section 19; thence in a generally northeasterly direction through Sections 18, 17, 16 and 15-T77N-R8W to a point approximately 900 feet south of the N $\frac{1}{4}$ Corner Section 15-T77N-R8W; thence in a northeasterly direction through Sections 15, 10 and 11-T77N-R8W to a point approximately $\frac{1}{4}$ mile north and 600 feet east of the SW Corner Section 11-T77N-R8W; thence east following substantially the south quarter section line of Sections 11 and 12-T77N-R8W to the west corporation line of Kalona, connecting with East Avenue.

Kalona:

Beginning on East Avenue at the west corporation line; thence east and northeast an East Avenue to the east corporation line.

Beginning again on the east corporation line of Kalona connecting with East Avenue; thence in a northeasterly direction through Section 8-T77N-R7W to a point approximately ¼ mile west of the E ¼ Corner Section 8-T77N-R7W; thence east following substantially the center section line of Sections 8, 9 and 10-T77N-R7W to a point near the E ¼ Corner Section 10-T77N-R7W; thence in a southeasterly direction through Sections 11 and 12-T77N-R7W to a point approximately 1,700 feet east of the NW Corner Section 13-T77N-R7W; thence east following substantially the section line of Section 13-T77N-R7W and Section 18-T77N-R6W to a point approximately 800 feet east of the NW Corner Section 18-T77N-R6W; thence southeast through said Section 18 to the west corporation line of Riverside, connecting with 1st Street.

Riverside:

Beginning on 1st Street at the west corporation line; thence southeast, east and northeast on 1st Street to Hickory Street; thence north on Hickory Street to an unnamed street; thence northeast on unnamed street to the east corporation line.

Beginning again on the east corporation line of Riverside, connecting with an unnamed street; thence in an easterly and northeasterly direction through Sections 6, 8, (west junction US 218) and 10-T77N-R6W (east junction US 218) to a point near the N ¼ Corner said Section 10; thence east following substantially the section line of Sections 10 and 11-T77N-R6W to the Washington-Johnson County line (Iowa River) at a point approximately 500 feet east of the N ¼ Corner Section 11-T77N-R6W.

DISCUSSION/BACKGROUND:

Iowa 22 begins on the Washington-Keokuk County line approximately 3 miles south of the NW corner of Washington County, and travels generally easterly via Wellman, Kalona, and Riverside to the Washington-Johnson County line approximately 1 mile south and 1 mile east of the NE corner of Washington County, Iowa.

Due to a review of our Primary Road System Records Iowa 22 in Washington County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 22 in Washington County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 22 and its extensions in Washington County as follows:

Beginning on the Washington-Keokuk County line at a point near the NW Corner Section 19-T77N-R9W, Washington County (NE Corner Section 24-T77N-R10W, Keokuk County) thence easterly following substantially the section line of Sections 19, 20, 21, 22, 23, and 24-T77N-R9W to the west corporation line of the City of Wellman connecting with an unnamed street.

Wellman:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Wellman connecting with an unnamed street; thence easterly following substantially the section line of Section 19-T77N-R8W to a point approximately 2150 feet east of the NW Corner said Section 19; thence in a generally northeasterly direction through Sections 18, 17, 16, and 15-T77N-R8W to a point approximately 900 feet south of the N $\frac{1}{4}$ Corner Section 15-T77N-R8W; thence in a northeasterly direction through Sections 15, 10, and 11-T77N-R8W to a point approximately $\frac{1}{4}$ mile north and 600 feet east of the SW Corner Section 11-T77N-R8W; thence easterly following substantially the south quarter section line of Sections 11 and 12-T77N-R8W to the west corporation line of the City of Kalona connecting with an unnamed street.

Kalona:

Beginning on the west corporation line connecting with an unnamed street thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Kalona connecting with an unnamed street; thence in an easterly and northeasterly direction through Section 8-T77N-R7W to a point approximately $\frac{1}{4}$ mile west of the E $\frac{1}{4}$ Corner Section 8-T77N-R7W; thence easterly following substantially the center section line of Sections 8, 9, and 10-T77N-R7W to a point near the E $\frac{1}{4}$ Corner Section 10-T77N-R7W; thence in a southeasterly direction through Sections 11 and 12-T77N-R7W to a point approximately $\frac{1}{4}$ mile east of the SW Corner Section 12-T77N-R7W; thence easterly following substantially the south line of Section 12-T77N-R7W to a point approximately 1700 feet east of the NW Corner Section 13-T77N-R7W; thence easterly following substantially the section line of Section 13-T77N-R7W and Section 18-T77N-R6W to a point approximately 800 feet east of the NW Corner Section 18-T77N-R6W; thence southeasterly through said Section 18 to the west corporation line of the City of Riverside connecting with an unnamed street.

Riverside:

Beginning on the west corporation line connecting with an unnamed street; thence in a general southeasterly and northeasterly direction to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Riverside, connecting with an unnamed street; thence in an easterly and northeasterly direction through Sections 8, 9 (junction US 218), and 10-T77N-R6W to a point near the N $\frac{1}{4}$ Corner said Section 10; thence easterly following substantially the section line of Sections 10 and 11-T77N-R6W to the Washington-Johnson County line (Iowa River) at a point approximately 500 feet east of the N $\frac{1}{4}$ Corner Section 11-T77N-R6W.

Beginning on the Washington-Keokuk County Line at a point near the NW Corner Section 19-T77N-R9W, Washington County (NE Corner Section 24-T77N-R10W, Keokuk County); thence east following substantially the section line to the west corporation line of the Town of Wellman, connecting with First Street.

Beginning again on the east corporation line of the Town of Wellman, connecting with First Street; thence east following substantially the section line to a point approximately 700 feet west of the S $\frac{1}{4}$ Corner Section 18-T77N-R8W; thence in a northeasterly direction to a point on the north side of the Chicago, Rock Island and Pacific Railway approximately $\frac{1}{4}$ mile south and c mile west of the E $\frac{1}{4}$ Corner Section 18-T77N-R8W; thence in a northeasterly direction along the north side of said railroad and substantially parallel thereto through Sections 18, 17, 16 and 15-T77N-R8W to a point approximately 900 feet south of the N $\frac{1}{4}$ Corner Section 15-T77N-R8W; thence in a northeasterly direction through Sections 15, 10 and 11-T77N-R8W to a point approximately $\frac{1}{4}$ mile north and 600 feet east of the SW Corner Section 11-T77N-R8W; thence east following substantially the south quarter-quarter line of Sections 11 and 12-T77N-R8W to the west corporation line of the Town of Kalona, connecting with Randle Street.

Beginning again on the east corporation line of the Town of Kalona, connecting with Randle Street; thence in an easterly and northeasterly direction through Section 8-T77N-R7W to a point approximately $\frac{1}{4}$ mile west of the E $\frac{1}{4}$ Corner Section 8-T77N-R7W; thence east following

substantially the quarter section line to a point near the E $\frac{1}{4}$ Corner Section 10-T77N-R7W; thence in a southeasterly direction through Sections 11 and 12-T77N-R7W to a point approximately $\frac{1}{4}$ mile east of the SW Corner Section 12-T77N-R7W; thence east following substantially the section line to a point approximately 800 feet east of the NW Corner Section 18-T77N-R6W; thence southeasterly to the west corporation line of the Town of Riverside, connecting with an unnamed street.

Beginning again on the east corporation line of the Town of Riverside, connecting with an unnamed street; thence in an easterly and northeasterly direction through Sections 8, 9 and 10-T77N-R6W to a point near the N $\frac{1}{4}$ Corner Section 10-T77N-R6W to a point near the N $\frac{1}{4}$ Corner Section 10-T77N-R6W; thence east following substantially the section line to the Washington-Johnson County line (Iowa River) at a point approximately 500 feet east of the N $\frac{1}{4}$ Corner Section 11-T77N-R6W.
