New Description – Iowa 25 and its extension in Guthrie County described as follows:

Beginning at the Guthrie-Adair County line at the SW Corner Section 32-T78N-R31W, Guthrie County (NW Corner Section 5-T77N-R31W, Adair County); thence north following substantially the section line of Section 32-T78N-R31W to the NW Corner Section 32-T78N-R31W; thence west following substantially the section line of Section 31-T78N-R31W and Section 36-T78N-R32W to the NW Corner Section 36-T78N-R32W; thence north following substantially the section line of Sections 25, 24, 13, 12 and 1-T78N-R32W to the NW Corner Section 1-T78N-R32W; thence in a northwesterly direction through Section 32-T79N-R31W to a point approximately 300 feet north of the W  $\frac{1}{4}$  Corner Section 32-T79N-R31W; thence north following substantially the section line of Sections 32 and 29-T79N-R31W to a point approximately 900 feet north of the W  $\frac{1}{4}$  Corner Section 29-T79N-R31W; thence in a northwesterly direction through Sections 30 and 19-T79N-R31W to a point approximately 400 feet south of the center of Section 19-T79N-R31W; thence north following substantially the center section line of Sections 19, 18, and 7-T79N-R31W to the south corporation line of Guthrie Center connecting with 5th Street.

Guthrie Center:

Beginning on 5th Street at the south corporation line; thence north on 5th Street to the north corporation line.

Beginning again on the north corporation line of Guthrie Center connecting with 5th Street; thence north following substantially the center section line of

Sections 31, 30, and 19-T80N-R31W to a point near the N ¼ Corner Section 19-T80N-R31W; thence in a northeasterly direction through Section 18-T80N-R31W to a point approximately 1,200 feet south of the NE Corner Section 18-T80N-R31W; thence north following substantially the section line of Sections 17, 8, and 5-T80N-R31W and Sections 32, 29, 20, 17, and 8-T81N-R31W to a point near the NW Corner Section 8-T81N-R31W (east junction of Iowa 141); thence west following substantially the section line of Section 7-T81N-R31W and Sections 12 and 11-T81N-R32W to a point near the NW Corner Section 11-T81N-R32W (west junction of Iowa 141); thence north following substantially the section line of Section 2-T81N-R32W to the Guthrie-Greene County line near the NW Corner Section 2-T81N-R32W, Guthrie County (SW Corner Section 35-T82N-R32W, Greene County).

#### **DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records Iowa 25 in Guthrie County should be deleted from the Primary Road System and the new description added should officially be included into the Primary Road System.

Iowa 25 begins at the Guthrie-Adair County line approximately 3 miles east of Casey and travels in a northerly direction to the Guthrie-Greene County line ½ mile north of Bayard, via the City of Guthrie Center, Iowa.

#### **PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 25 and its extensions in Guthrie County as follows:

Beginning at the Guthrie–Adair County line at the SW Corner Section 32--T78N–R31W Guthrie County (NW Corner Section 5–T77N–R31W Adair County); thence northerly following substantially the section line of Section 32–T78N–R31W to the NW Corner Section 32–T78N–R31W; thence westerly following substantially the section line of Section 31–T78N–R31W and Section 36–T78N–R32W to the NW Corner Section 36–T78N–R32W; thence northerly following substantially the section line of Sections 25, 24, 13, 12 and 1–T78N–R32W to the NW Corner Section 1–T78N–R32W; thence in a northwesterly direction through Section 32–T79N–R31W to a point approximately 300 feet north of the W  $\frac{1}{4}$  Corner Section 32–T79N–R31W; thence northerly following substantially the section line of Sections 32 and 29–T79N–R31W to a point approximately 900 feet north of the W  $\frac{1}{4}$  Corner Section 29–T79N–R31W; thence in a northwesterly direction through Sections 30 and 19–T79N–R32W to a point approximately 400 feet south of the center of Section 19–T79N–R31W; thence northerly following substantially the center section line of Sections 19, 18, and 7–T79N–R31W to the south corporation line of the City of Guthrie Center connecting with an unnamed street.

Guthrie Center:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Guthrie Center connecting with an unnamed street; thence northerly following substantially the center section line of Sections 31, 30, and 19–T80N–R31W to a point near the N  $\frac{1}{4}$  Corner Section 19–T80N–R31W; thence in a northeasterly direction through Section 18–T80N–R31W to a point approximately 1200 feet south of the NE Corner Section 18–T80N–R31W; thence northerly following substantially the section line of Sections 17, 8, and 5–T80N–R31W and Sections 32, 29, 20, 17, and 8–T81N–R31W to a point near the NW Corner Section 8–T81N–R31W (east

junction of Iowa 141); thence westerly following substantially the section line of Section 7-T81N-R31W and Sections 12 and 11-T81N-R32W to a point near the NW Corner Section 11-T81N-R32W (west junction of Iowa 141); thence northerly following substantially the section line of Section 2-T81N-R32W to the Guthrie-Greene County line near the NW Corner Section 2-T81N-R32W, Guthrie County (SW Corner Section 35-T82N-R32W, Greene County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 25 in Guthrie County, Iowa.

Beginning at the Guthrie-Adair County line at the SW Corner Section 32-T78N-R31W Guthrie County (NW Corner Section 5-T77N-R31W Adair County); thence north following substantially the section line to the NW Corner Section 32-T78N-R31W; thence west following substantially the section line to the SW Corner Section 25-T78N-R32W; thence north following substantially the section line to a point near the NW Corner Section 1-T78N-R32W; thence in a northwesterly direction to a point approximately 300 feet north of the W  $\frac{1}{4}$  Corner Section 32-T79N-R31W; thence north following substantially the section line to a point approximately 900 feet north of the E  $\frac{1}{4}$  Corner Section 30-T79N-R31W; thence in a northwesterly direction to a point approximately 400 feet south of the center of Section 19-T79N-R31W; thence north following substantially the quarter section line to the south corporation line of the Town of Guthrie Center connecting with Fifth Street.

Beginning again on the north corporation line of the Town of Guthrie Center, connecting with Fifth Street; thence north following substantially the quarter section line to a point near the N  $\frac{1}{4}$  Corner Section 19-T80N-R31W; thence in a northeasterly direction to a point approximately 1200 feet south of the NE Corner Section 18-T80N-R31W; thence north following substantially the section line to a point near the NE Corner Section 7-T81N-R31W; thence west following substantially the section line to a point near the SW Corner Section 2-T81N-R32W; thence north following substantially the section line to the Guthrie-Greene County line, at a point near the NW Corner Section 2-T81N-R32W, Guthrie County (SW Corner Section 35-T82N-R32W Greene County).
