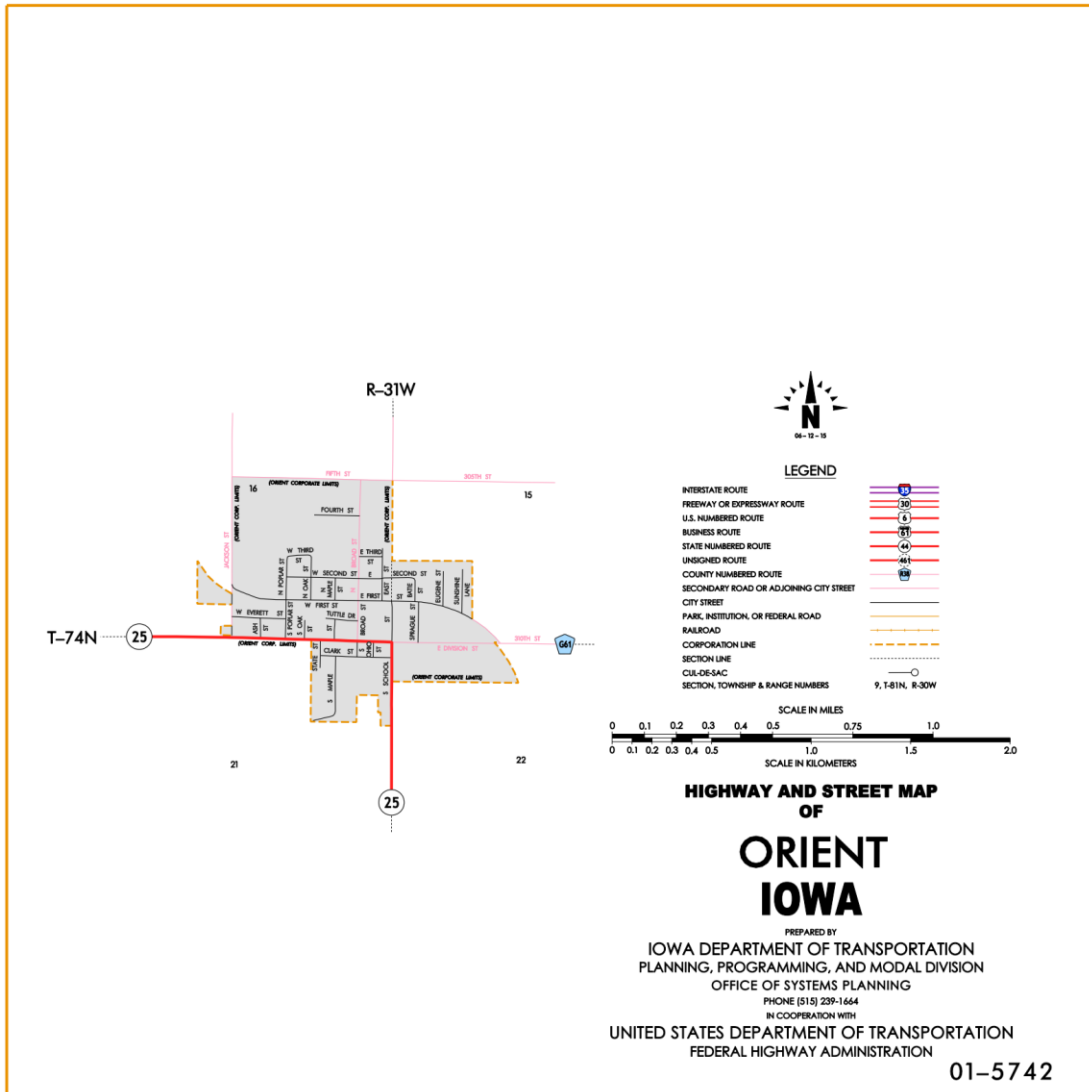

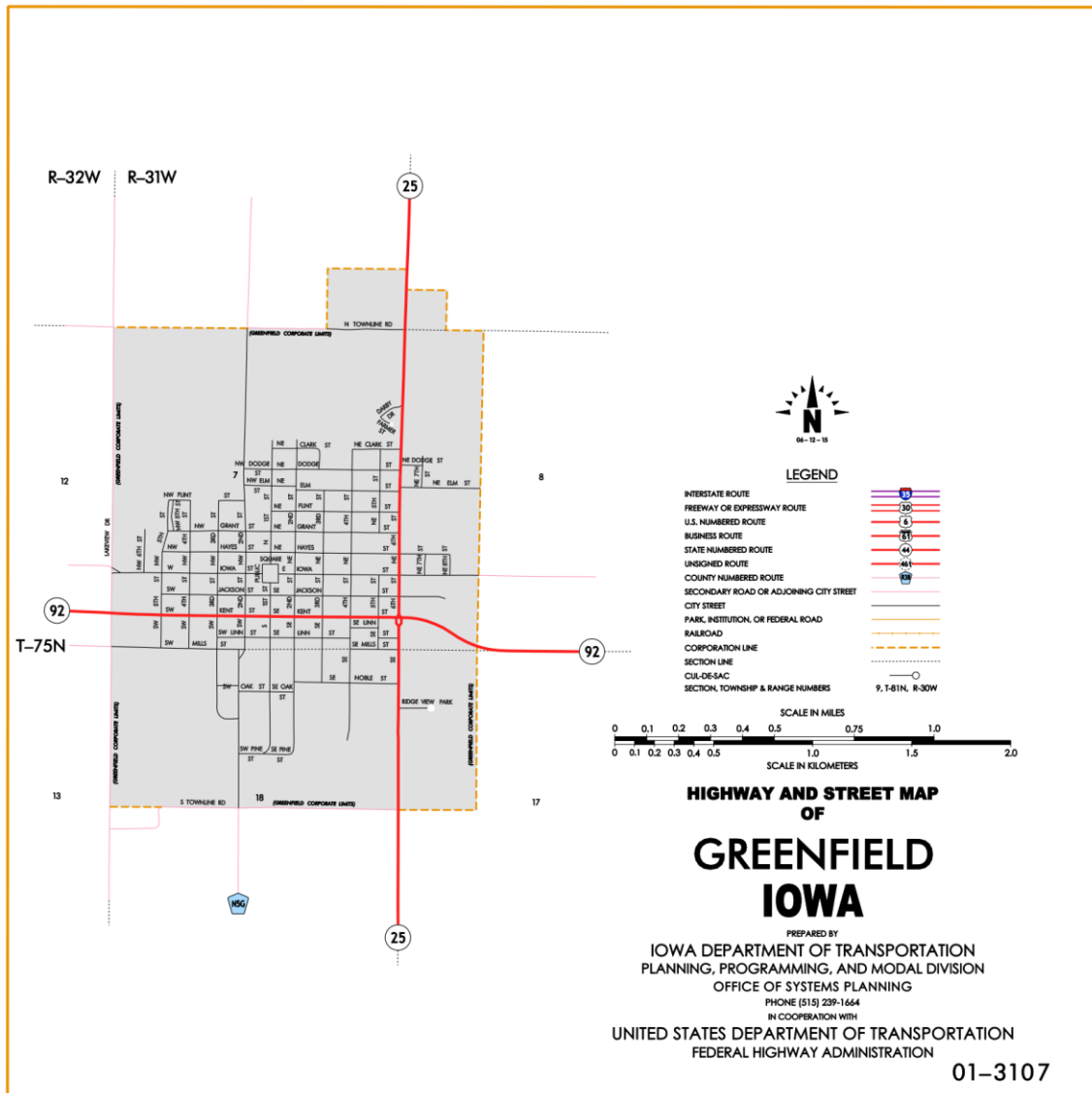


Orient:

Beginning again on the west corporation line of Orient, connecting with West Division Street; thence west following substantially the section line through Sections 21 and 20-T74N-R31W; to a point approximately 600

feet east of the SW Corner of Section 17-T74N-R31W; thence curving in a northwesterly direction to a point approximately 600 ft. north of the SW Corner of Section 17-T74N-R31W; thence northerly following substantially the section line of Sections 17, 8, and 5-T74N-R31W; thence Sections 32, 29, 20, and 17-T75N-R31W to the south corporation line of Greenfield connecting with Southeast 6th Street.



Greenfield:

Beginning at the south corporation line connecting with Southeast 6th Street; thence northerly to Northeast 6th Street and continuing northerly on Northeast 6th Street to the north corporation line.

Beginning again on the north corporation line of Greenfield connecting with Northeast 6th Street then northerly following substantially the section line through Sections 5-T75N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T76N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T77N-R31W (junction Interstate 80) to the Adair-Guthrie County line at a point near the NW Corner of Section 5-T77N-R31W, Adair County (SW Corner Section 32-T78N-R31W, Guthrie County).

Orient:

Beginning at the south corporation line connecting with School Street; thence northerly on School Street to an unnamed street; thence westerly on an unnamed street to the west corporation line.

Beginning again on the west corporation line of Orient, connecting with

an unnamed street; thence west following substantially the section line through Sections 21 and 20-T74N-R31W; to a point approximately 600 feet east of the SW Corner of Section 17-T74N-R31W; thence curving in a northwesterly direction to a point approximately 600 ft. north of the SW Corner of Section 17-T74N-R31W; thence northerly following substantially the section line of Sections 17, 8, and 5-T74N-R31W; thence Sections 32, 29, 20, and 17-T75N-R31W to the south corporation line of Greenfield connecting with Southeast 6th Street.

Greenfield:

Beginning at the south corporation line connecting with Southeast 6th Street; thence northerly to Northeast 6th Street and continuing northerly on Northeast 6th Street to the north corporation line.

Due to the review of our Primary Road System records, Iowa 25, Adair

County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 25 begins at the Union–Adair County line approximately 3 miles south of Orient, Iowa and travels in a northwesterly direction to the Guthrie–Adair County line approximately 3 miles east of Casey, Iowa, via the Cities of Orient and Greenfield, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 25 and its extensions in Adair County as follows:

Beginning on the Adair–Union County line at a point near the SW Corner of Section 34–T74N–R31W, Adair County (NW Corner of Section 3–T73N–R31W, Union County); thence north following substantially the section line thru Sections 34, 27, and 22–T74N–R31W to the south corporation line of the City of Orient connecting with an unnamed street.

Orient:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to unnamed street; thence westerly to the west corporation line connecting with an unnamed street.

Beginning again on the west corporation line of the City of Orient, connecting with an unnamed street; thence west following substantially the section line through Sections 21 and 20–T74N–R31W; to a point approximately 600 feet east of the SW Corner of Section 17–T74N–R31W; thence curving in a northwesterly direction to a point approximately 600 ft. north of the SW Corner of Section 17–T74N–R31W; thence northerly following substantially the section line of Sections 17, 8, and 5–T74N–R31W; thence Sections 32, 29, 20, and 17–T75N–31W to the south corporation line of the City of Greenfield connecting with an unnamed street.

Greenfield:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Greenfield connecting with an unnamed street then northerly following substantially the section line through Sections 5-T75N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T76N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T77N-R31W (junction Interstate 80) to the Adair-Guthrie County line (SW Corner Section 32-T78N-R31W, Guthrie County).

Beginning again on the north corporation line of the City of Greenfield connecting with an unnamed street then northerly following substantially the section line through Sections 5-T75N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T76N-R31W; thence through Sections 32, 29, 20, 17, 8, and 5-T77N-R31W (junction Interstate 80) to the Adair-Guthrie County line (SW Corner Section 32-T78N-R31W, Guthrie County).
