**DISCUSSION/BACKGROUND:**

Iowa 27 begins in the City of Alvord and travels generally easterly to US 75 approximately six miles east of the City of Alvord.

Transfer of jurisdiction agreement number TJ-027-0 (4)--2M-60, between the City of Alvord and the Iowa Department of Transportation, transferred that portion of Iowa 27 from Second Street northwesterly to the north corporation line of the City of Alvord to city jurisdiction on September 27, 1980.

Transfer of jurisdiction agreement number TJ-027-0 (4)--2M-60, between the City of Alvord and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-027-0 (3)--2M-60 between Lyon County and the Iowa Department of Transportation, transferred that portion of Iowa 27 easterly along the north corporation line of the City of Alvord to the east corporation line of the City of Alvord to local jurisdiction on September 27, 1980.

Transfer of jurisdiction agreement number TJ-027-0 (3)--2M-60, between Lyon County and the Iowa Department of Transportation, transferred that portion of Iowa 27 from the east corporation line of the City of Alvord easterly to a junction with US 75 to a point approximately 1845 feet north of the SE Corner of Section 32-T99N-R45W to county jurisdiction on August 11, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 27 in Lyon County from the primary road system.

Remove Iowa 27 and its extension in Lyon County as follows:

Alvord:

Beginning on an unnamed street at Second Street; thence northwesterly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Alvord; connecting with an unnamed street; thence east following substantially the section line of Sections 5, 4, 3, 2 and 1–T98N–R46W and Sections 6 and 5–T98N–R45W to a point 2068 feet west of the SE Corner Section 32–T99N–R45W; thence curving in a northeasterly and easterly direction through said Section 32 to a point approximately 1845 feet north of the SE Corner Section 32–T99N–R45W (junction US 75).

#### **DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 27 in Lyon County should be deleted from the Primary Road System and the new

description added should be officially included into the Primary Road System.

Iowa 27 begins in Alvord and travels in an easterly direction terminating at junction US 75, approximately 6 miles east of Alvord.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 27 and its extension in Lyon County, Iowa as follows:

Alvord:

Beginning on an unnamed street at Second Street; thence northwesterly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Alvord; connecting with an unnamed street; thence east following substantially the section line of Sections 5, 4, 3, 2 and 1–T98N–R46W and Sections 6 and 5–T98N–R45W to a point 2068 feet west of the SE Corner Section 32–T98N–R45W; thence curving in a northeasterly and easterly direction through said Section 32 to a point approximately 1845 feet north of the SE Corner Section 32–T99N–R45W (junction US 75).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 27, Lyon County, Iowa.
