New Description – Iowa 37 and its extension in Monona County described as follows:

Beginning at a point approximately 210 feet north of the center of Section 10-T83N-R44W (junction Iowa 175); thence in a southeasterly direction through Section 10-T83N-R44W to a point approximately 200 feet north of the SE Corner of Section 10-T83N-R44W; thence in a general easterly direction through Sections 11, 14, 11, 12 and 13-T83N-R44W and Sections 18, 17, 16, 15, and 10-T83N-R43W to a point approximately 100 feet west of the SE Corner of Section 10-T83N-R43W; thence in a southeasterly direction through Sections 15, 14, 13 and 24-T83N-R43W and Section 19-T83N-R42W to the west corporation line of Soldier, connecting with an unnamed street.

Soldier:

Beginning on an unnamed street at the west corporation line; thence southeasterly on an unnamed street to the south corporation line.

Beginning again on the south corporation line of Soldier, connecting with an unnamed street; thence southeasterly through Section 19-T83N-R42W to the west corporation line of Soldier, connecting with an unnamed street.

Soldier:

Beginning on an unnamed street at the west corporation line; thence easterly and southeasterly on an unnamed street to the east corporation line.

Beginning again on the east corporation line of Soldier connecting with an unnamed street; thence in a southeasterly direction through Sections 19, 30, 29 and 32-T83N-R42W and Sections 5, 4, 9, 10, 11, 14, 13 and 24-T82N-R42W to the Monona-Crawford County line at a point approximately 766 feet north of the SE Corner of Section 24-T82N-R42W, Monona County (SW Corner Section 19-T82N-R41W, Crawford County).

Beginning at a point approximately 210 feet north of the center of Section 10-T83N-R44W (junction Iowa 175); thence in a southeasterly direction through Section 10-T83N-R44W to a point approximately 200 feet north of the SE Corner of Section 10-T83N-R44W; thence in a general easterly direction through Sections 11, 14, 11, 12 and 13-T83N-R44W and Sections 18, 17, 16, 15 and 10-T83N-R43W to a point approximately 100 feet west of the SE Corner of Section 10-T83N-R43W; thence in a southeasterly direction through Sections 16, 15, 13 and 24-T83N-R43W and Section 19-T83N-R42W to the west corporation line of the City of Soldier, connecting with an unnamed street.

Soldier:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line connecting with an unnamed street.

Beginning again on the south corporation line of the City of Soldier, connecting with an unnamed street; thence southeasterly through Section 19-T83N-R42W to the west corporation line of the City of Soldier, connecting with an unnamed street.

Soldier:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and southeasterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of Soldier connecting with an unnamed street; thence in a southeasterly direction through Sections 19, 30, 29 and 32-T83N-R42W and Sections 5, 4, 9, 10, 11, 14, 13 and 24-T82N-R42W to the Monona-Crawford County line at a point approximately 766 feet north of the SE Corner of Section 24-T82N-R42W, Monona County (SW Corner Section 19-T82N-R41W, Crawford County).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records Iowa 37 in Monona County should be deleted and the new description added should be officially included into the Primary System.

Iowa 37 begins at a junction with Iowa 175 approximately ¼ mile east of Turin and travels easterly and southeasterly via the City of Soldier to the Monona–Crawford County line approximately 2 miles north of the Monona–Harrison County line.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 37 and its extension in Monona County as follows:

Beginning at a point approximately 210 feet north of the center of Section 10–T83N–R44W (junction of Iowa 175); thence in a southeasterly direction through Section 10–T83N–R44W to a point approximately 200 feet north of the SE Corner of Section 10–T83N–R44W; thence in a general easterly direction through Sections 11, 14, 11, 12 and 13–T83N–R44W and Sections 18, 17, 16, 15, and 10–T83N–R43W to a point approximately 100 feet west of the SE Corner of Section 10–T83N–R43W; thence in a southeasterly direction through Sections 15, 14, 13 and 24–T83N–R43W and Section 19–T83N–R42W to the west corporation line of the City of Soldier, connecting with an unnamed street.

Soldier:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly and easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of Soldier connecting with an unnamed street; thence in a southeasterly direction through Sections 19, 30, 29 and 32-T83NR42W and Sections 5, 4, 9, 10, 14, 13 and 24-T82N-R42W to the Monona-Crawford County line at a point approximately 766 feet north of the SE Corner of Section 24-T82N-R42W, Monona County (SW Corner Section 19-T82N-R41W, Crawford County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 37 in Monona County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

Beginning at a point approximately 210 feet north of the center of Section 10-T83N-R44W; thence in a southeasterly direction through Section 10-T83N-R44W to a point at or near the SE Corner of said Section 10; thence in an easterly direction substantially along the section line to a point near the S  $\frac{1}{4}$  Corner of Section 12-T83N-R44W; thence southeasterly and northeasterly through Section 13-T83N-R44W and Sections 18 and 17-T83N-R43W to a point on the north line of Section 17-T83N-R43W; thence in a general easterly direction along or near the section line to a point near the SE Corner of Section 10-T83N-R43W; thence southeasterly through Sections 14, 13, and 24-T83N-R43W and Section 19-T83N-R42W to the west corporation line of the Town of Soldier connecting with Maple Street.

Beginning again on the east corporation line of the Town of Soldier connecting with an unnamed street; thence in a southeasterly and southerly direction through Sections 19, 30, 29, and 32-T83N-R42W to a point approximately  $\frac{1}{4}$  mile south of the center of Section 32-T83N-R42W; thence southeasterly through Sections 5 and 4-T82N-R42W to a point approximately 728 feet west of the SE Corner of said Section 4, and continuing southeasterly through Sections 9, 10, and 11-T82N-R42W to a point 100 feet east of the S  $\frac{1}{4}$  Corner of Section 11-T82N-R42W; thence south-southeasterly through Sections 14, 13, and 24-T82N-R42W to the Monona-Crawford line at a point approximately 766 feet north of the SE Corner of Section 24-T82N-R42W, Monona County (SW Corner Section 19-T82N-R41W, Crawford County).
