New Description Iowa 48 and its extensions in Montgomery County described as follows:

Beginning on the Montgomery-Page County line at a point near the SW Corner Section 33-T71N-R38W, Montgomery County (NW Corner Section 4-T70N-R38W, Page County); thence northerly following substantially the section line of Sections 33, 28, 21, 16, 9, and 4-T71N-R38W and 33-T72N-R38W to the south corporation line of Red Oak connecting with Broadway Street.

Red Oak:

Beginning on Broadway Street at the south corporation line; thence north on Broadway Street to the north corporation line.

Beginning again on the north corporation line of Red Oak connecting with Broadway Street; thence northerly following substantially the section line of Sections 21, 16, 9, and 4-T72N-R38W to a point approximately 4,276 feet north of the SW Corner of Section 4-T72N-R38W; thence northerly through the east part of Section 5-T72N-R38W to a point near the SW Corner Section 33-T73N-R38W; thence in a northerly direction following substantially the section line of Sections 33, 28, 21, 16, and 9-T73N-R38W to a point approximately 3,000 feet north of the SW Corner of Section 9-T73N-R38W; thence curving in a northeasterly direction to a point approximately 2,900 feet west of the NE Corner Section 9-T73N-R38W; thence in an easterly direction following substantially the section line of Sections 9, 10, and 11-T73N-R38W; to a point approximately 700 feet east of the N $\frac{1}{4}$ Corner Section 11-T73N-R38W; thence in an easterly direction through the north part of

Sections 11 and 12-T73N-R38W and Section 7-T73N-R37W to a point near the S ¼ Corner Section 6-T73N-R37W; thence in an easterly, northeasterly, and northerly direction through Sections 7 and 6-T73N-R37W to a point approximately 2,800 feet south of the NE Corner Section 6-T73N-R37W; thence northerly following substantially the section line of Section 5-T73N-R37W to the Montgomery-Cass County line at a point near the NW Corner Section 5-T73N-R37W, Montgomery County (SW Corner Section 32-T74N-R37W, Cass County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 48 in Montgomery County should be deleted and the new description added should be officially included into the Primary System.

Iowa 48 begins on the Montgomery-Page County line approximately 7 miles south of Red Oak and travels northerly and easterly via the cities of Red Oak and Elliot to the Montgomery-Cass County line approximately 2 miles northeast of Elliot, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 48 and its extensions in Montgomery County as follows:

Beginning on the Montgomery–Page County line at a point near the SW Corner Section 33–T71N–R38W, Montgomery County (NW Corner Section 4–T70N R38W, Page County); thence northerly following substantially the section line of Sections 33, 28, 21, 16, 9, and 4–T71N–R38W and 33–T72N–R38W to the south corporation line of the City of Red Oak connecting with an unnamed street.

Red Oak:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to the north corporation line, connecting with an unnamed street.

Beginning again on the north corporation line of the City of Red Oak connecting with an unnamed street; thence northerly following substantially the section line of Section 21, 16, 9, and 4–T72N–R38W to a point approximately 4,276 feet north of the SW Corner of Section 4–T72N–R38W; thence northerly through the east part of Section 5–T72N–R38W to a point near the SW Corner Section 33–T73N–R38W; thence in a northerly direction following substantially the section line of Sections 33, 28, 21, 16, and 9–T73N–R38W to a point approximately 3,000 feet north of the SW corner of Section 9–T73N–R38W; thence curving in a northeasterly direction to a point approximately 2,900 feet west of the NE Corner Section 9–T73N–R38W; thence in an easterly direction following substantially the section line of Sections 9, 10, and 11–T73N–R38W to a point approximately 700 feet east of the N ¼ Corner Section 11–T73N–R38W; thence in an easterly direction through the north part of Sections 11 and 12–T73N–R38W to the south corporation line of the City of Elliott, connecting with an unnamed street.

Elliott:

Beginning on the south corporation line, connecting with an unnamed street; thence northeasterly to the east corporation line, connecting with an unnamed street.

Beginning again on the east corporation line of the City of Elliott, connecting with an unnamed street; thence in an easterly direction through the north part of Section 7-T73N-R37W to a point near the S ¼ Corner Section 6-T73N-R37W; thence in an easterly, northeasterly, and northerly direction through Sections 7 and 6-T73N-R37W to a point approximately 2800 feet south of the NE Corner Section 6-T73N-R37W; thence northerly following substantially the section line of Section 5-T73N-R37W to the Montgomery-Cass County line at a point near the NW Corner Section 5-T73N-R37W, Montgomery County (SW Corner Section 32-T74N-R37W, Cass County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 48 in Montgomery County, Iowa.

Beginning again on the north corporation line of the City of Red Oak, connecting with West First Street; thence north following substantially the section line to a point approximately 1,000 feet south of the NW Corner Section 9–T73N–R38W; thence curving in a northeasterly direction to a point approximately 1,000 feet east of the NW Corner Section 9–T83N–R38W; thence east following substantially the section line to a point approximately 700 feet east of the N ¼ Corner Section 11–T73N–R38W; thence in an easterly direction through the north part of Sections 11 and 12–T73N–R38W to the south corporation line of the Town of Elliott, connecting with an unnamed street.

Beginning again on the east corporation line of the Town of Elliott, connecting with an unnamed street; thence in an easterly direction through the south part of Section 6–T73N–R37W, to a point near the S ¼ Corner Section 6–T73N–R37W; thence east following substantially the section line to a point approximately 600 feet west of the SE Corner Section 6–T73N–R37W; thence curving in a northeasterly direction to a point approximately 600 feet north of the SE Corner Section 6–T73N–R37W; thence north following substantially the section line to the Montgomery–Cass County line at a point near the NE Corner Section 6–T73N–R37W, Montgomery County (SE Corner Section 31–T74N–R37W, Cass County).
