Griswold:

Beginning on Adair Street at the south corporation line; thence north on Adair Street to the north corporation line.

Beginning again on the north corporation line of Griswold, connecting with Adair Street; thence north following substantially the section line of Section 5–T74N–R37W; thence Sections 32, 29, 20, 17 and 8–T75N–R37W to a point near the NW Corner of Section 8–T75N–R37W (junction US 6).

Due to a review of our Primary Road System records, Iowa 48 in Cass County should be deleted, and the new description added should be officially included into the Primary Road System.

Iowa 48 begins on the Cass–Montgomery County line approximately 4 ½ miles south of Griswold and travels in a northerly direction terminating at the junction US 6, 2 ½ miles northwest of Lewis via the City of Griswold, Iowa.

## **PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 48 and its extension in Cass County as follows:

Beginning on the Cass–Montgomery County line a point near the SW Corner Section 32–T74N–R37W, Cass County (NE Corner Section 6–T73N–R37W, Montgomery County); thence north following substantially the section line of Sections 32, 29, 20, 17, 8–T74N–R37W to the south corporation line of the City of Griswold, connecting with unnamed street.

Griswold:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Griswold, connecting with unnamed street; thence north following substantially the section line of Section 5–T74N–R37W; thence Sections 32, 29, 20, 17 and 8–T75N–R37W to a point near the NW Corner of Section 8–T75N–R37W (US 6).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 48, Cass County.
