**DISCUSSION/BACKGROUND:**

Iowa 54 begins in the City of Marble Rock and proceeds easterly approximately three miles to Iowa 14.

Transfer of jurisdiction agreement number TJ-54-0 (1)-2M-34, between the City of Marble Rock and the Iowa Department of Transportation, transferred that portion of Iowa 54 from Main Street northerly and easterly to the east corporation line of Marble Rock to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-54-0 (2)--2M-34, between Floyd County and the Iowa Department of Transportation, transferred that portion of Iowa 54 from the east corporation line of the City of Marble Rock easterly to Iowa 14 near the NE Corner Section 14-T94N--R17W to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 54 in Floyd County from the primary road system.

Remove Iowa 54 and its extension in Floyd County as follows:

Marble Rock:

Beginning on Main Street; thence northerly and easterly to the east corporation line connecting with an unnamed street.

Beginning at the east corporation line of the City of Marble Rock connecting with an unnamed street; thence easterly following substantially the section line of Sections 16, 15 and 14-T94N-R17W to a point near the NE Corner of Section 14-T94N-R17W (junction of Iowa 14).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 54 in Floyd County, Iowa should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 54 begins in Marble Rock and travels easterly terminating at the junction of Iowa 14 approximately 2 ½ miles east of Marble Rock, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 54 and its extension in Floyd County as follows:

Marble Rock:

Beginning on Main Street; thence northerly and easterly to the east corporation line connecting with an unnamed street.

Beginning at the east corporation line of the City of Marble Rock connecting with an unnamed street; thence easterly following

substantially the section line of Sections 16, 15, and 14-T94N-R17W to a point near the NE Corner of Section 14-T94N-R17W (junction of Iowa 14).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 54 in Floyd County, Iowa.

point approximately 600 feet north of the SE Corner of Section 11-T94N-R17W.
