New description – Iowa 62 and its extensions in Jackson County described as follows:

Maquoketa:

Beginning on an unnamed street at East Platt Street; thence northeasterly on unnamed street to the east corporation line.

Beginning on the east corporation line of Maquoketa, connecting with an unnamed street; thence northeasterly through Section 20-T84N-R3E to a point approximately 1,126 feet east of the NW Corner Section 20-T84N-R3E and continuing in a northeasterly direction through Sections 17, 16, 9, 4, and 3-T84N-R3E to a point 857 feet east of the SW Corner Section 34-T85N-R3E; then northeasterly and curving northerly through Section 34-T85N-R3E to a point approximately 1,000 feet west of the NE Corner of said Section 34 and continuing northerly through Section 27-T85N-R3E to the south corporation line of Andrew, connecting with Jefferson Street.

Andrew:

Beginning on Jefferson Street at the south corporation line; thence northerly on Jefferson Street to the north corporation line.

Beginning again on the north corporation line of Andrew, connecting with Jefferson Street; thence northwesterly through Section 22-T85N-R3E and northerly through Section 15-T85N-R3E to a point near the N $\frac{1}{4}$ Corner of said Section 15; thence curving northeasterly through the SE $\frac{1}{4}$ Section 10-T85N-R3E and continuing northeasterly and easterly through Section 11-T85N-R3E to a point approximately 270 feet south and 750 feet west of the

center of Section 11-T85N-R3E; thence northeasterly through Sections 11, 2, and 1-T85N-R3E to a point near the E ¼ Corner Section 1-T85N-R3E and continuing northeasterly through Section 6-T85N-R4E, and Sections 31, 32, 33, 28, 27, 22, 23, 24, and 13-T86N-R4E to the west corporation line of Bellevue connecting with State Street.

Bellevue:

Beginning on State Street at the west corporation line; thence northeasterly on State Street to Water Street (junction US 52).

DISCUSSION/BACKGROUND:

Due to a review of the Primary Road System records, Iowa 62 in Jackson County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 62 begins at the junction of Iowa 64 in Maquoketa, Iowa and travels in a northeasterly direction via Andrew, Iowa terminating at the junction of US 52 in Bellevue, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 62 and its extensions in Jackson County as follows:

Maquoketa:

Beginning on an unnamed street at East Platt Street; thence northeasterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Maquoketa connecting with an unnamed street; thence northerly and northeasterly through Section 20-T84N-R3E to a point approximately 1,126 feet east of the NW Corner Section 20-T84N-R3E and continuing in a northeasterly direction through Sections 17, 16, 9, 4, and 3-T84N-R3E to a point 857 feet east of the SW Corner Section 34-T85N-R3E; thence northeasterly and curving northerly through Section 34-T85N-R3E to a point approximately 1,000 feet west of the NE Corner of said Section 34, and continuing northerly and northwesterly through Section 27-T85N-R3E to the south corporation line of the City of Andrew, connecting with an unnamed street.

Andrew:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Andrew, connecting with an unnamed street; thence northwesterly through Section 22-T85N-R3E and northerly through Section 15-T85N-R3E to a point near the N $\frac{1}{4}$ Corner of said Section 15; thence curving northeasterly through the SE $\frac{1}{4}$ Section 10-T85N-R3E and continuing northeasterly and easterly through Section 11-T85N-R3E to a point approximately 270 feet south and 750 feet west of the center of Section 11-T85N-R3E; thence northeasterly through Sections 11, 2, and 1-T85N-R3E to a point near the E $\frac{1}{4}$ Corner Section 1-T85N-R3E and continuing northeasterly through Section 6-T85N-R4E, and Sections 31, 32, 33, 28, 27, 22, 23, 24, and 13-T86N-R4E to the west corporation line of the City of Bellevue connecting with an unnamed street.

Bellevue:

Beginning on the west corporation line connecting with an unnamed street;
thence northeasterly on unnamed street to Water Street (junction US 52).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation
approve the location of Iowa 62 in Jackson County, Iowa.

Beginning on the east corporation line of the City of Maquoketa, connecting with Platt Street; thence north-northeasterly through Sections 19 and 20-T84N-R3E to a point approximately 1,126 feet east of the NW Corner Section 20-T84N-R3E and continuing in a northeasterly direction through Sections 17, 16, 9, 4 and 3-T84N-R3E to a point 857 feet east of the SW Corner Section 34-T85N-R3E; thence northeasterly and curving northerly through Section 34-T85N-R3E to a point approximately 1,000 feet west of the NE Corner of said Section 34, and continuing northerly and north-northwesterly through Section 27-T85N-R3E to the south corporation line of the Town of Andrew, connecting with Jefferson Street.

Andrew:

Commencing on Jefferson Street at the south corporation line; thence northerly on Jefferson Street to the north corporation line.

Beginning again on the north corporation line of the Town of Andrew, connecting with Jefferson Street; thence northwesterly through Section 22-T85N-R3E and northerly through Section 15-T85N-R3E to a point near the N $\frac{1}{4}$ Corner of said Section 15; thence curving northeasterly through the SE $\frac{1}{4}$ Section 10-T85N-R3E and continuing northeasterly and easterly through Section 11-T85N-R3E to a point approximately 270 feet south and 750 feet west of the center of Section 11-T85N-R3E; thence northeasterly through Sections 11, 2 and 1-T85N-R3E to a point near the E $\frac{1}{4}$ Corner Section 1-T85N-R3E and continuing northeasterly through Section 6-T85N-R4E, and Sections 31, 32, 33, 28, 27, 22, 23, 24 and

13-T86N-R4E to the west corporation line of the Town of Bellevue,
connecting with State Street.
