DISCUSSION/BACKGROUND:

Iowa 89 begins at a junction with Iowa 141 approximately one mile south of the City of Woodward and proceeds north to the Dallas-Boone County line at the north corporation line of the City of Woodward.

Transfer of jurisdiction agreement number TJ-089-2 (9)--2M-08 between Boone County and the Iowa Department of Transportation and transfer of jurisdiction agreement number TJ-089-2 (8)--2M-08 between the City of Madrid and the Iowa Department of Transportation, extended Iowa 210 from the Boone-Story County line to a junction with Iowa 17 in the City of Madrid. To maintain continuity in the Iowa route numbering system Iowa 89 should be re-designated as Iowa 210.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Iowa 89 in Dallas County from the primary road system.

Remove Iowa 89 and its extension in Dallas County as follows:

Beginning at a point near the S ¼ Corner Section 7-T81N-R26W (junction of Iowa 141); thence northerly through said Section 7 to the south corporation line of the City of Woodward connecting with an unnamed street.

Woodward:

Beginning at the south corporation line connecting with an unnamed street; thence north to the north corporation line connecting with an unnamed street, (Dallas–Boone County line).
