New Description – Iowa 92 and its extensions in Warren County described as follows:

Bevington:

Beginning on an unnamed street at the Warren–Madison County line; thence northeast to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of Bevington connecting with an unnamed street; thence northeast through Sections 30 (junction Interstate 35), 29, 20 and 21–T76N–R25W to the south corporation line of Martensdale, connecting with an unnamed street.

Martensdale:

Beginning on the south corporation line connecting with an unnamed street; thence northeast and southeast to the south corporation line connecting with an unnamed street.

Beginning again on the south corporation line of Martensdale connecting with an unnamed street; thence in a southeasterly direction through Section 21–T76N–R25W to a point near the SE Corner said Section 21; thence east following substantially the section line of Sections 27, 26 and 25–T76N–R25W to a point near the NE Corner Section 25–T76N–R25W; thence in a southeasterly direction through Sections 30 and 29–T76N–R24W; to a point approximately $\frac{1}{4}$ mile north and 900 feet east of the SW Corner Section 29–T76N–R24W; thence east following substantially the south quarter section line of Sections 29 and 28–T76N–R24W to a point approximately 400 feet east and $\frac{1}{4}$ mile north of the S $\frac{1}{4}$ Corner Section 28–T76N–R24W; thence northeast and east through the

south part of Sections 28 and 27-T76N-R24W to the west corporation line of Indianola, connecting with 2nd Avenue.

Indianola:

Beginning on 2nd Avenue at the west corporation line; thence east, northeast and east on 2nd Avenue to the east corporation line.

Beginning again on the east corporation line of Indianola connecting with 2nd Avenue; thence east following substantially the center section line of Section 29-T76N-R23W to a point near the E $\frac{1}{4}$ Corner said Section 29; thence northeast, east and northeast through Sections 28, 27 and 23-T76N-R23W to the west corporation line of Ackworth, connecting with an unnamed street.

Ackworth:

Beginning on the west corporation line connecting with an unnamed street; thence northeast to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of Ackworth connecting with an unnamed street; thence in a northeasterly and easterly direction through Sections 23 and 24-T76N-R23W and Sections 19, 20 and 21-T76N-R22W to the west corporation line of Sandyville, connecting with an unnamed street.

Sandyville:

Beginning on the west corporation line connecting with an unnamed street; thence east to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of Sandyville connecting with an unnamed street; thence east following substantially the center section line of Sections 22, 23 and 24-T76N-R22W to the Warren-Marion County line at a point near the E $\frac{1}{4}$ Corner Section 24-T76N-R22W Warren County (W $\frac{1}{4}$ Corner Section 19-T76N-R21W Marion County).

DISCUSSION/BACKGROUND:

Iowa 92 begins on the Warren-Madison County line in Bevington, and travels generally easterly via Bevington, Martensdale, Indianola, Ackworth, and Sandyville to the Warren-Marion County line approximately 3 miles east of Sandyville, Iowa.

Due to a review of our Primary Road System Records Iowa 92 in Warren County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 92 in Warren County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 92 and its extensions in Warren County as follows:

Bevington:

Beginning on an unnamed street at the Warren–Madison County line; thence northeasterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Bevington connecting with an unnamed street; thence northeasterly through Sections 30 (junction Interstate 35), 29, 20, and 21–T76N–R25W to the south corporation line of the City of Martensdale connecting with an unnamed street.

Martensdale:

Beginning on the south corporation line connecting with an unnamed street; thence northeasterly and southeasterly to the south corporation line connecting with an unnamed street.

Beginning again on the south corporation line of the City of Martensdale connecting with an unnamed street; thence in a southeasterly direction through Section 21–T76N–R25W to a point near the SE Corner said Section 21; thence easterly following substantially the section line of Sections 27, 26, and 25–T76N–R25W to a point near the NE Corner Section 25–T76N–R25W; thence in a southeasterly direction through Sections 30 and 29–T76N–R24W, to a point approximately $\frac{1}{4}$ mile north and 900 feet east of the SW Corner Section 29–T76NR24W; thence east following substantially the south quarter section line of Sections 29 and 28–T76N–R24W to a point approximately 400 feet east and $\frac{1}{4}$ mile north of the S $\frac{1}{4}$ Corner Section 28–T76N–R24W; thence in a northeasterly and easterly direction through the south part of Sections 28 and 27–T76N–R24W, to the west corporation line of the City of Indianola connecting with an unnamed street.

Indianola:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Indianola connecting with an unnamed street; thence easterly following substantially the center

section line of Section 29-T76N-R23W to a point near the E ¼ Corner said Section 29; thence in a northeasterly easterly, and northeasterly direction through Sections 28, 27, and 23-T76N-R23W to the west corporation line of the City of Ackworth connecting with an unnamed street.

Ackworth:

Beginning on the west corporation line connecting with an unnamed street; thence northeasterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Ackworth connecting with an unnamed street; thence in a northeasterly and easterly direction through Sections 23 and 24-T76N-R23W and Sections 19, 20, and 21-T76N-R22W to the west corporation line of the City of Sandyville connecting with an unnamed street.

Sandyville:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Sandyville connecting with an unnamed street; thence easterly following substantially the center section line of Sections 22, 23, and 24-T76N-R22W to the Warren-Marion County line at a point near the E ¼ Corner Section 24-T76N-R22W Warren County (W ¼ Corner Section 19-T76N-R21W Marion County).

Beginning again on the south corporation line of the Town of Martensdale, connecting with an unnamed street; thence in a southeasterly direction to a point near the southeast corner Section 21-T76-R25; thence east following substantially the section line to a point near the NE Corner Section 25-T76N-R25W; thence in a southeasterly direction through Sections 30 and 29-T76N-R24W to a point approximately $\frac{1}{4}$ mile north and 900 feet east of the SW Corner Section 29-T76N-R24W; thence east following substantially the south quarter-quarter line of Section 29 and 28-T76N-R24W to a point approximately 400 feet east and $\frac{1}{4}$ mile north of the S $\frac{1}{4}$ Corner Section 28-T76N-R24W; thence in a northeasterly and easterly direction through the south part of Sections 28 and 27-T76N-R24W to the west corporation line of the City of Indianola connecting with West Second Street.

Beginning again on the east corporation line of the City of Indianola connecting with East Second Street; thence east following substantially the quarter section line to a point near the E $\frac{1}{4}$ Corner Section 29-T76N-R23W; thence in a northeasterly, easterly, and northeasterly direction through Sections 28, 27, and 23-T76N-R23W to the west

corporation line of the Town of Ackworth connecting with an unnamed street.

Beginning again on the east corporation line of the Town of Ackworth connecting with an unnamed street; thence in a northeasterly and easterly direction through Sections 23 and 24-T76N-R23W and Sections 19, 20, and 21-T76N-R22W to the west corporation line of the Town of Sandyville connecting with an unnamed street.

Beginning again on the east corporation line of the Town of Sandyville connecting with an unnamed street; thence east following substantially the quarter section line to the Warren-Marion County line at a point near the E $\frac{1}{4}$ Corner Section 24-T76N-R22W, Warren County (W $\frac{1}{4}$ Corner Section 19-T76N-R21W, Marion County)
