New Description Iowa 92 and its extensions in Pottawattamie County described as follows:

Council Bluffs:

Beginning on South Omaha Bridge Road at the west corporation line (Iowa-Nebraska State line); thence easterly and northeasterly on South Omaha Bridge Road to the east corporation line.

Beginning on the east corporation line of Council Bluffs connecting with South Omaha Bridge Road; thence northeasterly through Sections 8, 5 and 4-T74N-R43W to a point approximately 930 feet east and 150 feet north of the SW Corner of Section 4-T74N-R43W; thence easterly through said Section 4 to a point near the SE Corner of Section 4-T74N-R43W; thence easterly following substantially the south line of Section 3-T74N-R43W to a point near the SE Corner Section 3-T74N-R43W; thence easterly following substantially the section line of Sections 11 and 12-T74N-R43W and Sections 7, 8, 9, 10, 11 and 12-T74N-R42W to the west corporation line of Treynor, connecting with Main Street.

Treynor:

Beginning on Main Street at the west corporation line; thence east on Main Street to the east corporation line.

Beginning again on the east corporation line of Treynor connecting with Main Street; thence easterly following substantially the section line of Sections 7, 8, 9, 10, 11 and 12-T74N-R41W, and Sections 7, 8, 9, 10, 11, (junction US 59) and 12-T74N-R40W; Sections 7, 8, 9, 10, 11 and

12-T74N-R39W and Sections 7, 8, 9, 10 and 11-T74N-R38W to a point approximately 4,300 feet east of the SW Corner Section 2-T74N-R38W; thence in a northeasterly and easterly direction through the south part of Sections 2 and 1-T74N-R38W to the Pottawattamie-Cass County line at a point approximately ¼ mile north of the SE Corner of Section 1-T74N-R38W, Pottawattamie County (SW Corner of Section 6-T74N-R37W, Cass County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 92 in Pottawattamie County should be deleted and the new description added should be officially included into the Primary System.

Iowa 92 begins on the Iowa-Nebraska State line at the west corporation line of Council Bluffs, and travels generally easterly via Council Bluffs and Treynor to the Pottawattamie-Cass County line approximately 5 miles north of the SE corner of Pottawattamie County, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 92 and its extensions in Pottawattamie County as follows:

Council Bluffs:

Beginning on the west corporation line (Iowa–Nebraska State line) connecting with an unnamed street; thence generally easterly and northeasterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Council Bluffs connecting with an unnamed street; thence northeasterly through Sections 8, 5, and 4–T74N–R43W to a point approximately 930 feet east and 150 feet north of the SW Corner of Section 4–T74N–R43W; thence easterly through said Section 4 to a point near the SE Corner of Section 4–T74N–R43W; thence easterly following substantially the south line of Section 3–T74N–R43W to a point near the SE Corner Section 3–T74N–R43W; thence easterly following substantially the section line of Sections 11 and 12–T74N–R43W and Sections 7, 8, 9, 10, 11 and 12–T74N–R42W to the west corporation line of the City of Treynor connecting with an unnamed street.

Treynor:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Treynor connecting with an unnamed street; thence easterly following substantially the section line of Sections 7, 8, 9, 10, 11 and 12–T74N–R41W, and Sections 7, 8, 9, 10, 11, (junction US 59) and 12–T74N–R40W; Sections 7, 8, 9, 10, 11 and 12–T74N–R39W and Sections 7, 8, 9, 10 and 11–T74N–R38W to a point approximately 4300 feet east of the SW Corner Section 2–T74N–R38W; thence in a northeasterly and easterly direction through the south part of Sections 2 and 1–T74N–R38W to the Pottawattamie–Cass County line at a point approximately $\frac{1}{4}$ mile north of the SE Corner of Section 1–T74N–R38W Pottawattamie County (SW Corner of Section 6–T74N–R37W Cass County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 92 in Pottawattamie County, Iowa.

Beginning again on the east corporation line of the Town of Treynor connecting with Main Street; thence east following substantially the section line to a point near the SE Corner of Section 2-T74N-R38W; thence in a northeasterly and easterly direction through the south part of Section 1-T74-R38W to the Pottawattamie-Cass County line at a point approximately ¼ mile north of the SE Corner of Section 1-T74N-R38W, Pottawattamie County (SW Corner of Section 6-T74N-R37W, Cass County).

Beginning on the South Omaha Bridge over the Missouri River; thence easterly and northeasterly through Section 16, 15, and 14-T74N-R44W to a point near the SW Corner of Section 11-T74N-R44W; thence northeasterly and easterly through the south part of Section 11-T74N-R44W to the west corporation line of the City of Council Bluffs connecting with an unnamed street.

Beginning again on the east corporation line of the City of Council Bluffs connecting with an unnamed street; thence northeasterly through Section 8, 5 and 4-T74N-R43W to a point approximately 330 feet east and 150 feet north of the SW Corner of Section 4-T74N-R43W; thence easterly to a point near the SE Corner of Section 4-T74N-R43W; thence east following substantially the south line of Section 3, 2 and 1-T74N-R43W; thence easterly following substantially the south line of Section 6, 5 and 4-T74N-R42W to a point near the E $\frac{1}{4}$ Corner of Section 4-T74N-R42W; thence east following substantially the section line to the west corporation line of the Town of Treynor connecting with Main Street.

Beginning again on the east corporation line of the Town of Treynor connecting with Main Street; thence east following substantially the section line to a point near the SE Corner of Section 2-T74N-R38W; thence in a northeasterly and easterly direction through the south part of Section 1-T74N-R38W to the Pottawattamie-Cass County line at a point

approximately ¼ mile north of the SE Corner of Section 1–T74N–R38W
Pottawattamie County (SW Corner of Section 6–T74N–R37W Cass County.)
