


DISCUSSION/BACKGROUND:

Due to the opening of the new U.S. 61 alignment in Louisa County which Iowa 92 now runs concurrent with, it is recommended that the route description for Iowa 92 in Louisa County be modified.



New description – Iowa 92 and its extension in Louisa County described as follows:

Beginning on the Louisa–Washington County line at a point near the NW Corner of Section 19–T73N–R5W, Louisa County, (NE Corner of Section 24–T73N–R6W, Washington County); thence in a southeasterly and easterly direction through Sections 19, 20, 21, 22, 23, and 24–T75N–R5W to the west corporation line of Columbus Junction connecting with Oak Street.



Columbus Junction:

Beginning on Oak Street at the west corporation line; thence east on Oak Street to the east corporation line.

Beginning again on the east corporation line of Columbus Junction connecting with Oak Street; thence in an easterly and southeasterly direction through Section 19 (junction lowa 70), 20, and 21–T75N–R4W to a point approximately 900 feet west of the S ¼ Corner of Section 21–T75N–R4W; thence easterly following substantially the section line of Sections 28, 27, 26, and 25–T75N–R4W and Sections 30, 29, and 28–T75N–R3W (junction of US 61) at a point near the NE Corner of Section 28–T75N–R3W; thence northerly and northeasterly following Section 21 and 15–T75N–R3W; thence northwesterly and northerly through Section 16–T75N–R3W; thence; northerly following substantially the east quarter section line of Sections 16 and 9–T75N–R3W to a point approximately ¼ mile west at the NE Corner of Section 9–T75N–R3W; thence in a northwesterly, northerly, and northeasterly direction through the east part of Section 4–T75N–R3W to the Louisa–Muscatine County line at a point approximately 1850 feet west of the NE Corner of Section 4–T75N–R3W, Louisa County (SE Corner of Section 33–T76N–R3W, Muscatine County).

Beginning on the Louisa–Washington County line at a point near the NW Corner of Section 19–T73N–R5W, Louisa County, (NE Corner of Section 24–T73N–R6W, Washington County); thence in a southeasterly and easterly direction through Sections 19, 20, 21, 22, 23, and 24–T75N–R5W to the west corporation line of Columbus Junction connecting with Oak Street.

Columbus Junction:

Beginning on Oak Street at the west corporation line; thence east on Oak Street to the east corporation line.

Beginning again on the east corporation line of Columbus Junction connecting with Oak Street; thence in an easterly and southeasterly direction through Section 19, 20, and 21–T75N–R4W to a point approximately 900 feet west of the S ¹/₄ Corner of Section 21–T75N–R4W; thence easterly following substantially the section line of Sections 28, 27, 26, and 25-T75N-R4W and Sections 30, 29, and 28-T75N-R3W (south junction of US 61) at a point near the NE Corner of Section 28–T75N–R3W; thence northerly following substantially the section line of Sections 22 and 15-T75N-R3W to a point approximately 1050 feet north of the SW Corner of Section 15-T75N-R3W; thence in a northwesterly direction through Section 16–T75N–R3W to a point approximately ¼ mile west and 1100 feet south of the NE Corner of Section 16-T75N-R3W; thence northerly following substantially the east guarter section line of Sections 16 and 9-T75N-R3W to a point approximately ¼ mile west at the NE Corner of Section 9-T75N-R3W; thence in a northwesterly, northerly, and northeasterly direction through the east part of Section 4–T75N–R3W to the Louisa–Muscatine County line at a point approximately 1850 feet west of the NE Corner of Section 4-T75N-R3W, Louisa County (SE Corner of Section 33-T76N-R3W, Muscatine County).

TITLE: Iowa 92, Louisa County, Iowa.

DISCUSSION/BACKGROUND:

Due to a review of the Primary Road System records, Iowa 92 in Louisa County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 92 begins on the Louisa–Washington County line approximately ³/₄ miles west of Cotter, Iowa and travels easterly and northerly via Columbus Junction, Iowa to the Louisa–Muscatine County line approximately 2 miles east of Letts, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 92 and its extension in Louisa County as follows:

Beginning on the Louisa–Washington County line at a point near the NW Corner of Section 19–T73N–R5W, Louisa County, (NE Corner of Section 24–T73N–R6W, Washington County); thence in a southeasterly and easterly direction through Sections 19, 20, 21, 22, 23 and 24–T75N–R5W to the west corporation line of the City of Columbus Junction connecting with an unnamed street.

Columbus Junction:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line, connecting with an unnamed street.

Beginning again on the west corporation line of the City of Columbus Junction, connecting with an unnamed street; thence in an easterly and southeasterly direction through Sections 19, 20 and 21–T75N–R4W to a point approximately 900 feet west of the S ¼ Corner of Section 21–T75N–R4W; thence easterly following substantially the section line of Sections 28, 27, 26 and 25–T75N–R4W and Sections 30,29, and 28–T75N–R3W (south junction of US 61) at a point near the NE Corner of Section 28–T75N–R3W; thence northerly following substantially the section line of Sections 22 and 15–T75N–R3W to a point approximately 1050 feet north of the SW Corner of Section 15–T75N–R3W; thence in a northwesterly direction through Section 16–T75N–R3W to a point approximately ¼ mile west and 1100 feet south of the

NE Corner of Section 16–T75N–R3W; thence northerly following substantially the east quarter section line of Sections 16 and 9–T75N–R3W to a point approximately ¼ mile west of the NE Corner of Section 9–T75N–R3W; thence in a northwesterly, northerly and northeasterly direction through the east part of Section 4–T75N–R3W to the Louisa–Muscatine County line at a point approximately 1850 feet west of the NE Corner of Section 4–T75N–R3W, Louisa County (SE Corner of Section 33–T76N–R3W, Muscatine County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 92 in Louisa County, Iowa.

Beginning on the Louisa–Washington County line at a point near the NW Corner Section 19–T75–R5W, Louisa County (NE Corner Section 24–T75–R6W, Washington County); thence east to a point near the N ¼ Corner Section 19–T75–R5W; thence in a southeasterly direction along the south side of the Chicago, Rock Island and Pacific Railway and substantially parallel thereto, through Sections 19, 20, 21, and 22–T75–R5W, to a point a short distance south of the center of Section 22–T75–R5W; thence in a southeasterly and easterly direction through Sections 22, 23, and 24–T75–R5W to the west corporation line of the Town of Columbus Junction connecting with Oak Street.

Beginning again on the east corporation line of the Town of Columbus Junction, connecting with Oak Street; thence in an easterly and southeasterly direction through Sections 19, 20, and 21–T75–R4W to a point approximately 700 feet west of the S ¼ Corner of Section 21–T75–R4W; thence east following substantially the section line to a point near the SE Corner of Section 21–T75–R3W; thence north following substantially the section line to a point approximately 800 feet north of the SE Corner of Section 16–T75–R3W; thence in a northwesterly direction to a point approximately ¼ mile west and 1100 feet south of the NE Corner of Section 16–T75–R3W; thence north following substantially the east quarter-quarter line of Sections 16 and 9–T75–R3W; thence in a point approximately ¼ mile west of the NE Corner of Section 9–T75–R3W; thence in a northwesterly and northerly direction through the east part of Section 4–T75–R3W to the Louisa–Muscatine County line at point approximately 1500 feet west of the NE Corner of Section 4–T75–R3W, Louisa County, (SE Corner of Section 33–T76–R3W, Muscatine County).
