New description – Iowa 92 and its extension in Keokuk County described as follows:

Beginning on the Keokuk–Mahaska County line at a point near the NW Corner Section 6–T75N–R13W, Keokuk County (NE Corner Section 1–T75N–R14W, Mahaska County); thence east following substantially the section line of Sections 6, 5, 4 (junction Iowa 21), 3, 2, and 1–T75N–R13W and Sections 6, 5, 4, and 3–T75N–R12W to the west corporation line of Sigourney connecting with Jackson Street.

Sigourney:

Beginning on Jackson Street at the west corporation line; thence east on Jackson Street to the east corporation line.

Beginning again on the east corporation line of Sigourney connecting with Jackson Street; thence east following substantially the section line of Section 1–T75N–R12W (east junction Iowa 149) and Sections 6, 5, 4, 3, 2, and 1–T75N–R11W and Sections 6, 5, 4, 3, 2, and 1–T75N–R10W to the Keokuk–Washington County line at a point near the NE Corner Section 1–T75N–R10W, Keokuk County (NW Corner Section 6–T75N–R9W, Washington County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 92 in Keokuk County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 92 begins at the Keokuk-Mahaska County line approximately 5 miles west of Delta and travels in an easterly direction to the Keokuk-Washington County line approximately 1 ½ miles south of Keota via the City of Sigourney, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 92 and its extension Keokuk County, Iowa as follows:

Beginning on the Keokuk-Mahaska County line at a point near the NW Corner Section 6T75N-R13W, Keokuk County (NE Corner Section 1-T75N-R14W, Mahaska County); thence east following substantially the section line of Sections 6, 5, 4 (junction Iowa 21), 3, 2, and 1-T75N-R13W and Sections 6, 5, 4, and 3-T75N-R12W to the west corporation line of the City of Sigourney connecting with an unnamed street.

Sigourney:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Sigourney connecting with an unnamed street thence east following substantially the section line of Section 1-T75N-R12W (east junction Iowa 149) and Sections 6, 5, 4, 3, 2, and 1-T75N-R11W and Sections 6, 5, 4, 3, 2 (junction Iowa 77), and 1-T75N-R10W to the Keokuk-Washington County line at a point near the NE Corner Section 1-T75N-R10W, Keokuk County (NW Corner Section 6-T75N-R9W, Washington County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 92, Keokuk County, Iowa.

Beginning on the Keokuk–Mahaska County line at a point near the NW Corner of Section 6–T75N–R13W, Keokuk County, (NE Corner of Section 1–T75N–R14W, Mahaska County); thence east to a point approximately ¼ mile east of the NW Corner of Section 6–T75N–R13W; thence in a southeasterly, easterly and northeasterly direction through the north part of Section 6–T75N–R13W, to a point approximately 900 feet west of the NE Corner of Section 6–T75N–R13W; thence east following substantially the section line to the west corporation line of the City of Sigourney, connecting with Jackson Street.

Beginning again on the east corporation line of the City of Sigourney connecting with Jackson Street; thence east following substantially the section line to the Keokuk–Washington County line at a point near the NE Corner of Section 1–T75N–R10W, Keokuk County (NW Corner of Section 6–T75N–R9W, Washington County).
