New Description – Iowa 92 and its extensions in Adair County described as follows:

Beginning on the Adair-Cass County line at a point near the NW Corner Section 31-T75N-R33W, Adair County (NE Corner Section 36-T75N-R34W, Cass County); thence east following substantially the section line through Sections 31, 32, 33, 34-T75N-R33W to a point near the N $\frac{1}{4}$ Corner of said Section 34; thence northeasterly through Sections 27, 26, 23, and 24-T75N-R33W to a point approximately $\frac{1}{4}$ mile west of the SE Corner of Section 13-T75N-R33W; thence east following substantially the section line of Section 24-T75N-R33W and Section 19-T75N-R32W to a point near the S $\frac{1}{4}$ Corner of Section 18-T75N-R32W; thence northeasterly in said Section 18 to the west corporation line of Fontanelle connecting with an unnamed street.

Fontanelle:

Beginning at the west corporation line connecting with an unnamed street; thence northeasterly on an unnamed street to Washington Street; thence east to Washington Place; thence northeasterly on Washington Place to the east corporation line.

Beginning again on the east corporation line of Fontanelle connecting with Washington Place; thence in a northeasterly direction through Sections 16 and 15-T75N-R32W to a point approximately 400 feet west of the NE Corner of said Section 15; thence east following substantially the section line to a point approximately $\frac{1}{4}$ mile west of the NE Corner of Section 14-T75N-R32W; thence in a northeasterly and easterly direction

through the south part of Sections 11 and 12-T75N-R32W to the west corporation line of Greenfield, connecting with Southwest Kent Street.

Greenfield:

Beginning at the west corporation line connecting with Southwest Kent Street then easterly to Southeast Kent Street; thence easterly and southeasterly on Southeast Kent Street to the east corporation line.

Beginning again on the east corporation line of Greenfield, connecting with Southeast Kent Street; thence east following substantially the section line through Sections 17, 16, 15, 14, and 13-T75N-R31W and Sections 18 and 17-T75N-R30W to a point approximately ¼ mile west of the SE Corner of Section 8-T75N-R30W; thence curving in a northeasterly direction to a point approximately ¼ mile north of the SE Corner of Section 8-T75N-R30W; thence northerly following substantially the Section line of Section 9-T75N-R30W to a point approximately 1,000 feet south of the NW Corner of section 9-T75N-R30W; thence curving northeasterly to a point approximately 1,000 feet east of the NW Corner of Section 9-T75N-R30W; thence easterly following substantially the section line of Sections 9, 10, 11, and 12-T75N-R30W to the Adair-Madison County line at a point near the NE Corner of Section 12-T75N-R30W, Adair County (NW Corner of Section 7-T75N-R29W, Madison County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 92 in Adair County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 92 begins at the Cass–Adair County line approximately 2 ¼ miles northwest of Bridgewater, Iowa, traveling northeasterly, and easterly to approximately 11 ¾ miles east of Greenfield, Iowa, to the Madison–Adair County line via the cities of Fontanelle and Greenfield, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 92 and its extensions in Adair County as follows:

Beginning on the Adair–Cass County line at a point near the NW Corner Section 31–T75N–R33W, Adair County (NE Corner Section 36–T75N–R34W, Cass County); thence east following substantially the section line through Sections 31, 32, 33, and 34–T75N–R33W to a point near the N ¼ Corner of said Section 34; thence northeasterly through Sections 27, 26, 23, and 24–T75N–R33W to a point approximately ¼ mile west of the SE Corner Section 13–T75N–R33W; thence east following substantially the section line of Section 24–T75N–R33W and Section 19–T75N–R32W to a point near the S ¼ Corner of Section 18–T75N–R32W; thence northeasterly in said Section 18 to the west corporation line of the City of Fontanelle connecting with an unnamed street.

Fontanelle:

Beginning at the west corporation line connecting with an unnamed street; thence in a northeasterly, easterly, and northeasterly direction to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Fontanelle connecting with an unnamed street; thence in a northeasterly direction through Sections 16 and 15–T75N–R32W to a point approximately 400

feet west of the NE Corner of said Section 15; thence east following the section line to a point approximately $\frac{1}{4}$ mile west of the NE Corner of Section 14-T75N-R32W; thence in a northeasterly and easterly direction through the south part of Sections 11 and 12-T75N-R32W to the west corporation line of the City of Greenfield, connecting with an unnamed street.

Greenfield:

Beginning at the west corporation line connecting with an unnamed street; thence easterly and southeasterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Greenfield, connecting with an unnamed street; thence east following substantially the section line through Sections 17, 16, 15, 14, and 13-T75N-R31W and Sections 18 and 17-T75N-R30W to a point approximately $\frac{1}{4}$ mile west of the SE Corner of Section 8-T75N-R30W; thence curving in a northeasterly direction to a point approximately $\frac{1}{4}$ mile north of the SE Corner of Section 8-T75N-R30W; thence northerly following substantially the Section line of Section 9-T75N-R30W to a point approximately 1,000 feet south of the NW Corner of Section 9-T75N-R30W; thence curving northeasterly to a point approximately 1,000 feet east of the NW Corner of Section 9-T75N-R30W; thence easterly following substantially the section line of Sections 9, 10, 11, and 12-T75N-R30W to the Adair-Madison County line at a point near the NE Corner of Section 12-T75N-R30W, Adair County (NW Corner of Section 7-T75N-R29W, Madison County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 92 in Adair County, Iowa.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 92 in Adair County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 92 begins at the Cass-Adair County line approximately 2 ¼ miles northwest of Bridgewater, Iowa, traveling northeasterly, and easterly to approximately 1 1 ¾ miles east of Greenfield, Iowa, to the Madison-Adair County line via the cities of Fontanelle and Greenfield, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 92 and its extensions in Adair County as follows:

Beginning on the Adair-Cass County line at a point near the NW Corner Section 31-T75N-R33W, Adair County (NE Corner Section 36-T75N-R34W, Cass County); thence east following substantially the section line through Sections 31, 32, 33, and 34-T75N-R33W to a point near the N ¼ Corner of said Section 34; thence northeasterly through Sections 27, 26, 23, and 24-T75N-R33W to a point approximately ¼ mile west of the SE Corner Section 13-T75N-R33W; thence east following substantially the section line of Section 24-T75N-R33W and Section 19-T75N-R32W to a point near the S ¼ Corner of Section 18-T75N-R32W; thence northeasterly in said Section 18 to the west corporation line of the City of Fontanelle connecting with an unnamed street.

Fontanelle:

Beginning at the west corporation line connecting with an unnamed street; thence in a northeasterly, easterly, and northeasterly direction to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Fontanelle connecting with an unnamed street; thence in a northeasterly direction through Sections 16 and 15-T75N-R32W to a point approximately 400 feet west of the NE Corner of said Section 15; thence east following the section line to a point approximately $\frac{1}{4}$ mile west of the NE Corner of Section 14-T75N-R32W; thence in a northeasterly and easterly direction through the south part of Sections 11 and 12-T75N-R32W to the west corporation line of the City of Greenfield, connecting with an unnamed street.

Greenfield:

Beginning at the west corporation line connecting with an unnamed street; thence easterly and southeasterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Greenfield, connecting with an unnamed street; thence east following substantially the section line through Sections 17, 16, 15, 14, and 13-T75N-R31W and Sections 18 and 17-T75N-R30W to a point approximately $\frac{1}{4}$ mile west of the SE Corner of Section 8-T75N-R30W; thence curving in a northeasterly direction to a point approximately $\frac{1}{4}$ mile north of the SE Corner of Section 8-T75N-R30W; thence northerly following substantially the Section line of Section 9-T75N-R30W to a point approximately 1,000 feet south of the NW Corner of Section 9-T75N-R30W; thence curving northeasterly to a point approximately 1,000 feet east of the NW Corner of Section 9-T75N-R30W; thence easterly following substantially the section line of Sections 9, 10, 11, and 12-T75N-R30W to the

Adair–Madison County line at a point near the NE Corner of Section 12–T75N–R30W, Adair County (NW Corner of Section 7–T75N–R29W, Madison County).
