

**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number 2003-TJ-032, between the City of Russell and the Iowa Department of Transportation, transferred that portion of Iowa 97 from Shaw Street at the intersection of West Street; thence east on Shaw Street to Prairie Street; thence north on Prairie Street to Stanton Street; thence east on Stanton Street to an unnamed street; thence northeast on unnamed street to the north corporation line to city jurisdiction on July 1, 2003.

Transfer of jurisdiction agreement number 2003-TJ-030, between Lucas County and the Iowa Department of Transportation, transferred that portion of Iowa 97 from the north corporation line of Russell connecting with an unnamed street; thence easterly following substantially the section line of Section 6-T71N-R20W to a point approximately 150 feet west of the SE Corner of Section 31-T72N-R20W; thence curving northeasterly through said Section 31 to a point approximately 150 feet north of the SE Corner said Section 31; thence northerly following substantially the section line of Section 32-T72N-R20W to a point near the NW Corner of Section 32-T72N-R20W (junction US 34) to county jurisdiction on July 1, 2003.

Russell:

Street; thence east on Stanton Street to an unnamed street; thence northeast on unnamed street to the north corporation line.

Beginning on the north corporation line of Russell connecting with an unnamed street; thence easterly following substantially the section line of Section 6-T71N-R20W to a point approximately 150 feet west of the SE Corner of Section 31-T72N-R20W; thence curving northeasterly through said Section 31 to a point approximately 150 feet north of the SE Corner said Section 31; thence northerly following substantially the section line of Section 32-T72N-R20W to a point near the NW Corner of Section 32-T72N-R20W (junction US 34).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 97 in Lucas County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Iowa 97 begins in Russell and travels in a northerly direction terminating at the junction US 34 approximately 1 mile north of Russell.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 97 and its extension in Lucas County as follows:

Russell:

Beginning on an unnamed street at West Street; thence easterly, northerly, easterly, and northeasterly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Russell, connecting with an unnamed street; thence easterly following substantially the section line of Section 6-T71N-R20W to a point approximately 150 feet west of the SE Corner Section 31-T72N-R20W; thence curving northeasterly through said Section 31 to a point approximately 150 feet north of the SE Corner said Section 31; thence northerly following substantially the section line of Section 32-T72N-R20W to a point near the NW Corner Section 32-T72N-R20W (junction US 34).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 97, Lucas County, Iowa.
