DISCUSSION/BACKGROUND:

Iowa 104 begins in the City of Woodburn, and travels generally northerly to US 34 approximately one mile north of the City of Woodburn.

Transfer of jurisdiction agreement number TJ-104-0 (2), between Clarke County and the Iowa Department of Transportation, transferred that portion of Iowa 104 from the north corporation line of the City of Woodburn north approximately one mile to US 34 near the N ¼ Corner NW ¼ Section 23-T72N-R24W to county jurisdiction on October 27, 1980. The portion of Iowa 104 in the City of Woodburn should be re-designated as unsigned Iowa 942.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 104 in Clarke County from the primary road system.

Remove Iowa 104 and its extension in Clarke County as follows:

Woodburn:

Beginning on an unnamed street at Vine Street; thence easterly and northerly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Woodburn connecting with an unnamed street; thence in a northeasterly and northerly direction through Section 23-T72N-R24W to a point

approximately ¼ mile east of the NW Corner Section 23–T72N–R24W (junction US 34).

direction through Section 23-T72N-R24W to a point approximately ¼ mile east of the NW Corner Section 23-T72N-R24W (junction US 34).
