Due to the transfer of jurisdiction agreements for Iowa 105 on other portions of Iowa 105, Iowa 105 in Worth County became Unsigned Iowa 972 in 1993.

It is recommended the old description of Iowa 105 in Worth County be deleted from the Primary Road System.

TITLE: Official Description Change: Iowa 105 in Worth County

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number 93-TJ-007-98 between the Iowa Department of Transportation and Worth County transferred portions of Iowa 105 to the County of December 31, 1992 which should be removed from the Primary Road System.

Iowa 105 begins at the Worth-Winnebago County line; then east, northeasterly, then easterly to WCL of Northwood; through Northwood; then easterly, southeasterly, southerly, and easterly to the Worth-Mitchell County line.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the old description of Iowa 105 in Worth County be deleted from the Primary Road System and the new description, as described in the attachment, be included in the Primary Road System.

New Description – Iowa 105 and its extensions in Worth County described as follows:

Northwood:

Beginning on Central Avenue at the WCL; then east on Central Avenue to the ECL.

New Description – Iowa 105 and its extensions in Worth County described as follows:

Beginning on the Worth–Winnebago County line at a point near the W $\frac{1}{4}$ Corner Section 6–T99N–R22W Worth County (E $\frac{1}{4}$ Corner Section 1–T99N–R23W Winnebago County); then east following substantially the center section line of Sections 6, 5, 4, 3, 2 and 1–T99N–R22W and Section 6–T99N–R21W to a point approximately 800 feet east of the W $\frac{1}{4}$ Corner Section 6–T99N–R21W; then northeasterly, northerly and northeasterly through Section 6–T99N–R21W and Section 31–T100N–R21W to a point near the NE Corner Section 31–T100N–R21W; then easterly following substantially the section line of Section 32 (Junction Interstate 35), 33, 34, 35 and 36–T100N–R21W and Sections 31 and 32–T100N–R20W to the west corporation line of Northwood, connecting with Central Avenue.

Northwood:

Beginning on Central Avenue at the west corporation line; then east on Central Avenue to the east corporation line.

Beginning again on the east corporation line of Northwood connecting with Central Avenue; then easterly following substantially the section line of Sections 34 and 35–T100N–R20W to a point near the NE Corner Section 35–T100N–R20W; then in a southeasterly direction through Section 36–T100N–R20W and Sections 31, 32, 33, 34 and 35–T100N–R19W to a point

approximately 700 feet west and 900 feet north of the S $\frac{1}{4}$ Corner Section 35-T100N-R19W; then southeasterly through Section 35-T100N-R19W and Section 2-T99N-R19W to a point near the E $\frac{1}{4}$ Corner Section 2-T99N-R19W; then southerly following substantially the section line of Section 1-T99N-R19W to a point approximately 1,200 feet north of the SW Corner Section 1-T99N-R19W; then curving in a southeasterly direction to a point approximately 1,200 feet east of the SW Corner Section 1-T99N-R19W; then easterly following substantially the section line of Section 12-T99N-R19W to a point near the SE Corner Section 1-T99N-R19W on the Worth-Mitchell County line at the west corporation line of Carpenter, connecting with William Street.

TITLE: Iowa 105, Worth County, Iowa

DISCUSSION/BACKGROUND:

Iowa 105 begins on the Worth-Winnebago County line approximately 5 ½ miles south of the NW corner of Worth County, and travels in a generally easterly direction via Northwood to the Worth-Mitchell County line at the west corporation line of Carpenter, Iowa.

Due to a review of our Primary Road System Records Iowa 105 in Worth County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Iowa 105 in Worth County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 105 and its extension in Worth County as follows:

Beginning on the Worth–Winnebago line at a point near the W $\frac{1}{4}$ Corner Section 6–T99N–R22W Worth County (E $\frac{1}{4}$ Corner Section 1–T99N–R23W Winnebago County); thence easterly following substantially the center section line of Sections 6, 5, 4, 3, 2, and 1–T99N–R22W and Section 6–T99N–R21W to a point approximately 800 feet east of the W $\frac{1}{4}$ Corner Section 6–T99N–R21W; thence northeasterly, northerly and northeasterly through Section 6–T99N–R21W and Sections 31 and 32–T100N–R21W to a point near the NW Corner 32–T100N–R21W; thence easterly following substantially the section line of Section 32 (junction Interstate Route 35), 33, 34, 35, and 36–T100N–R21W and Sections 31 and 32–T100N–R20W to the west corporation line of the City of Northwood connecting with an unnamed street.

Northwood:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Northwood connecting with an unnamed street; thence easterly following substantially the section line of Sections 34 and 35-T100N-R20W to a point near the NE Corner Section 35-T100N-R20W; thence in a southeasterly direction through Section 36-T100N-R20W; and Sections 31, 32, 33, 34, and 35-T100N-R19W to a point approximately 700 feet west and 900 feet north of the S $\frac{1}{4}$ Corner Section 35-T100N-R19W; thence southeasterly through Section 35-T100N-R19W add Section 2-T99N-R19W to a point near the E $\frac{1}{4}$ Corner Section 2-T99N-R19W; thence southerly following substantially the section line of Section 1-T99N-R19W to a point approximately 1200 feet north of the SW Corner Section 1-T99N-R19W; thence curving in a southeasterly direction to a point approximately 1200 feet east of the SW Corner Section 1-T99N-R19W; thence easterly following substantially the section line of Section 12-T99N-R19W to a point near the SE Corner Section 1-T99N-R19W on the Worth-Mitchell County line at the west corporation line of the City of Carpenter connecting with an unnamed street.
