### **DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number 2003-TJ-031, between the Cerro Gordo County and the Iowa Department of Transportation, transferred that portion of Iowa 107 from the north corporation line of Meservey, connecting with 1st Street; thence north to a point approximately 1,138 feet south of the NW Corner Section 29-T94N-R22W; thence curving in a northeasterly direction to a point approximately 1,110 feet east of the NW Corner Section 29-T94N-R22W; thence east following substantially the section line through Sections 29, 28 and

27-T94N-R22W to a point approximately 1,100 feet west of the NE Corner of said Section 27; thence northeasterly and easterly through Sections 22 and 23-T94N-R22W to the west corporation line of Thornton connecting with Larch Street; again at the north corporation line of Thornton connecting with 1st Street; thence north following substantially the section line through Section 18, 7 and 6-T94N-R21W; and Sections 31, 30, 19, 18, 7 and 6-T95N-R21W and Sections 31, and 30-T96N-R21W to the south corporation line of Clear Lake connecting with 8th Street to county jurisdiction on June 4, 2003.

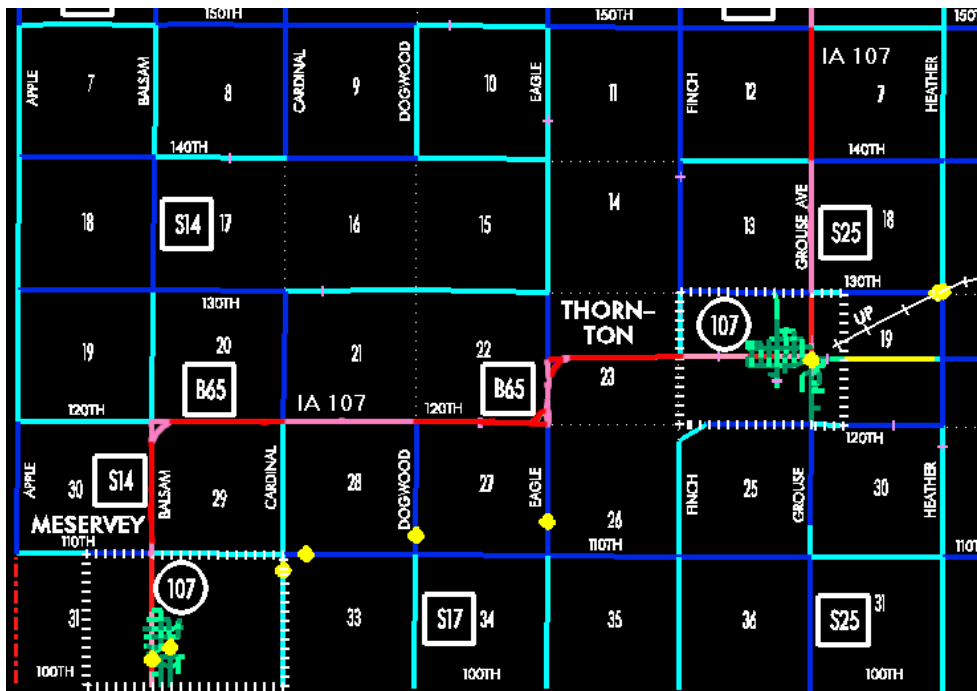

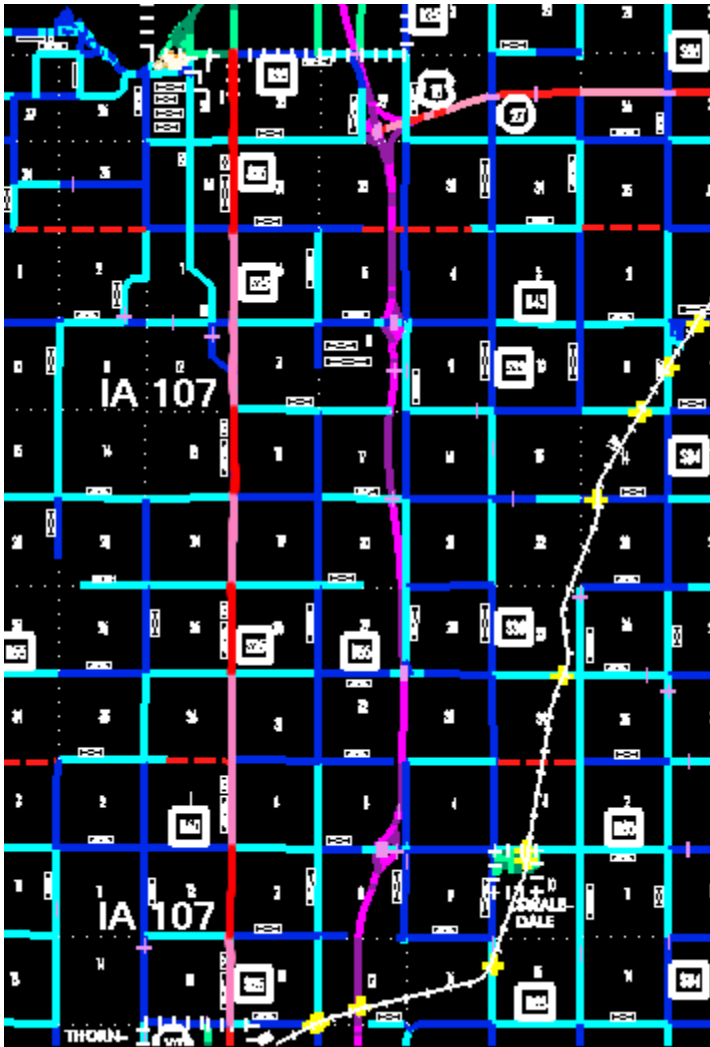

Beginning on Larch Street at the west corporation line (W  $\frac{1}{4}$  Corner Section 24–T94N–R22W); thence east on Larch Street to 1st Street; thence north on 1st Street to the north corporation line (NW Corner Section 19–T94N–R21W).

**DISCUSSION / BACKGROUND:**

Transfer of jurisdiction agreement number 92-TJ-006-17 between the Iowa Department of Transportation and city of Clear Lake transferred the portion of Iowa 107 from the south corporation line north approximately .50 mile to the old south corporation line to the city on July 1, 1992 and should be removed from the Primary Road System.

Iowa 107 begins at the Cerro Gordo-Franklin County line on the south corporation line of Meservey and travels in a northerly, easterly and northerly direction via Meservey and Thornton to the south corporation line of Clear Lake.

## **PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the old description of Iowa 107 in Cerro Gordo County be deleted from the Primary Road System and the new description, as described in the attachment, be included in the Primary Road System.

New Description – Iowa 107 and its extensions in Cerro Gordo County described as follows:

Meservey:

Beginning on 1st Street at the south corporation line (Cerro Gordo–Franklin County Line); thence north on 1st Street to the north corporation line.

Beginning on the north corporation line of Meservey, connecting with 1st Street; thence



north to a point approximately 1,138 feet south of the NW Corner Section 29-T94N-R22W; thence curving in a northeasterly direction to a point approximately 1,110 feet east of the NW Corner Section 29-T94N-R22W; thence east following substantially the section line through Sections 29, 28 and 27-T94N-R22W to a point approximately 1,100 feet west of the NE Corner of said Section 27; thence northeasterly and easterly through Sections 22 and 23-T94N-R22W to the west corporation line of Thornton connecting with Larch Street.

Thornton:

Beginning on Larch Street at the west corporation line; thence east on Larch Street to 1st Street; thence north on 1st Street to the north corporation line.

Beginning again at the north corporation line of Thornton connecting with 1st Street; thence north following substantially the section line through Section 18, 7 and 6–T94N–R21W; and Sections 31, 30, 19, 18, 7 and 6–T95N–R21W and Sections 31, and 30–T96N–R21W to the south corporation line of Clear Lake connecting with 8th Street.

**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number TJ-107-2 (17)--2M17 between the Iowa Department of Transportation and Clear Lake transferred that portion of Iowa 107 from the south corporation line of Clear Lake north to the junction of US 18 to city jurisdiction on October 1, 1987. The official description of Iowa 107 should be revised to reflect this transfer.

Iowa 107 begins at the Cerro Gordo, Franklin County Line on the south corporation line of Meservey and travels in a northerly, easterly and northerly direction

via Meservey and Thornton to the south corporation line of Clear Lake.

### **PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve revising the description of Iowa 107 in Cerro Gordo County and including the new description in the Primary Road System.
