DISCUSSION/BACKGROUND:

Iowa 125 begins in the City of Salem, and travels easterly to US 218 approximately eight miles south of the City of Mount Pleasant.

Transfer of jurisdiction agreement number TJ-125-0 (1), between the City of Salem and the Iowa Department of Transportation, transferred that portion of Iowa 125 from North Main Street generally southeasterly to the east corporation line to city jurisdiction on August 26, 1980.

A State Functional Classification Review Board hearing, between the Iowa Department of Transportation (transferring jurisdiction) and Henry County (receiving jurisdiction) transferred that portion of Iowa 125 from the east corporation line of the City of Salem easterly to US 218 approximately 3900 feet south of the NW Corner Section 21-T70N-R6W to county jurisdiction on April 6, 1981.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of Iowa 125 in Henry County from the primary road system.

Remove Iowa 125 and its extension in Henry County as follows:

Salem:

Beginning on an unnamed street at North Main Street; thence southerly, easterly, southerly, southeasterly and easterly to the east corporation line connecting with an unnamed street.

Beginning at the east corporation line of the City of Salem connecting with an unnamed street; thence easterly through Section 24-T70N-R7W, and Sections 19 and 20-T70N-R6W to a point approximately 3900 feet south of the NW Corner Section 21-T70N-R6W (junction US 218).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 125 in Henry County should be deleted, and the new description added should be officially included into the Primary Road System.

Iowa 125 begins in Salem and travels approximately 2 ½ miles in an easterly direction terminating at the junction US 218.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 125 and its extension in Henry County as follows:

Salem:

Beginning on an unnamed street at North Main Street; thence southerly, easterly, southerly, southeasterly and easterly to the east corporation line connecting with an unnamed street.

Beginning at the east corporation line of the City of Salem connecting with an unnamed street thence easterly through Section 24-T70N-R7W, and Sections 19 and 20-T70N-R6W to a point approximately 3900 feet south of the NW Corner Section 21-T70N-R6W (junction US 218).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 125 in Henry County, Iowa.

Beginning on the east corporation line of the Town of Salem connecting with Fort Madison Road; thence east, following substantially the quarter section line to a point approximately $\frac{1}{4}$ mile west of the E $\frac{1}{4}$ Corner Section 19-T70N-R6W; thence in a southeasterly direction to a point approximately $\frac{1}{4}$ mile north and $\frac{1}{4}$ mile east of the SW Corner Section 20-T70N-R6W; thence east to a point approximately $\frac{1}{4}$ mile north of the SE Corner of Section 20-T70N-R6W.
