**DISCUSSION/BACKGROUND:**

Iowa 126 begins at old US 6 on the east corporation line of the City of Mitchellville, and travels north into the City of Mitchellville.

Transfer of jurisdiction agreement number TJ-126-0 (2), between Polk County and the Iowa Department of Transportation, and transfer of jurisdiction agreement number TJ-126-0 (3), between the City of Mitchellville and the Iowa Department of Transportation, transferred that portion of Iowa 126 from old US 6 approximately 1530 feet south of the N ¼ Corner Section 13-T79N-R22W north along the east corporation line of the City of Mitchellville to local jurisdiction on March 9, 1981.

Transfer of jurisdiction agreement number TJ-126-0 (3), between the City of Mitchellville and the Iowa Department of Transportation, transferred that portion of Iowa 126 from the south corporation line north to Second Street to City jurisdiction on March 9, 1981.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the Commission approve deleting the present description of Iowa 126 in Polk County from the primary road system.

Remove Iowa 126 and its extension in Polk County as follows:

Beginning at a point approximately 1530 feet south of the N ¼ Corner Section 13-T79N-R22W (junction US 6); thence northerly following

substantially the center section line of Sections 13 and 12-T79N-R22W to the south corporation line of the City of Mitchellville connecting with an unnamed street.

Mitchellville:

Beginning at the south corporation line connecting with an unnamed street; thence northerly on unnamed street to Second Street.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 126 in Polk County should be deleted and the new description added should be officially included into the Primary System.

Iowa 126 begins at US 6 southeast of Mitchellville and travels northerly approximately 1 mile to a point in Mitchellville, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 126 and its extension in Polk County as follows:

Beginning at a point approximately 1530 feet south of the N  $\frac{1}{4}$  Corner Section 13-T79N-R22W (junction US 6); thence northerly following

substantially the center section line of Sections 13 and 12-T79N-R22W to the south corporation line of the City of Mitchellville connecting with an unnamed street.

Mitchellville:

Beginning at the south corporation line connecting with an unnamed street; thence northerly on unnamed street to 2nd Street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 126 in Polk County, Iowa.

#### Junction of US 6 and Iowa 126

Beginning at a point approximately 200 feet north of the S ¼ Corner Section 12-T79N-R22W; thence curving in a southeasterly direction to a point approximately 200 feet east of the S ¼ Corner Section 12-T79N-R22W.

#### Junction of US 6 and Iowa 126 south of Mitchellville

Beginning at a point approximately 200 feet east of the S ¼ Corner Section 12-T79N-R22W; thence east to a point approximately 1530 feet east of the S ¼ Corner said Section 12.
