New description – Iowa 130 and its extensions in Cedar County described as follows:

Beginning on the Scott-Cedar County line at a point approximately 1,000 feet south of the E $\frac{1}{4}$ Corner of Section 13-T80N-R1W, Cedar County (W $\frac{1}{4}$ Corner of Section 13-T80N-R1W, Scott County); thence northwest to a point about 700 feet west of the N $\frac{1}{4}$ Corner of Section 18-T80N-R1W; thence west following substantially the section line of Sections 13, 14, 15 and 16-T80N-R1W to the east corporation line of Bennett, connecting with 5th Street.

Bennett:

Beginning on 5th Street at the east corporation line; thence west on 5th Street to an unnamed street; thence northwest on unnamed street to the north corporation line.

Beginning again on the north corporation line of Bennett, connecting with an unnamed street; thence running northwesterly through Section 9-T80N-R1W to a point $\frac{1}{4}$ mile north of the SW Corner of Section 9-T80N-R1W; thence north following substantially the section line of Sections 9 and 4-T80N-R1W to a point approximately 1,200 feet south of the NE Corner of Section 5-T80N-R1W; thence running northwesterly to a point approximately 1,200 feet west of the NE Corner of said Section 5; thence west following substantially the section line through Sections 5 and 6-T80N-R1W; and Sections 1, 2, 3, 4, 5 and 6-T80N-R2W to the east corporation line of Tipton connecting with 7th Street.

Tipton:

Beginning on 7th Street at the east corporation line; thence west on 7th Street to Cedar Street.

Due to the review of our Primary Road System records, Iowa 130 in Cedar County should be deleted from the Primary System and the new description added should be officially included into the Primary Road System.

Iowa 130 begins at the Cedar-Scott County line approximately 4 miles east of Bennett, Iowa and travels in a northwesterly and westerly direction via Bennett, Iowa terminating at the junction of Iowa 38 in Tipton, Iowa.

Beginning on the Scott-Cedar County line at a point approximately 1,000 feet south of the E $\frac{1}{4}$ Corner of Section 13-T80N-R1W, Cedar County (W $\frac{1}{4}$ Corner of Section 18-T80N-R1E, Scott County); thence northwesterly to a point about 700 feet west of the N $\frac{1}{4}$ Corner of Section 13-T80N-R1W; thence west following substantially the section line of Sections 13, 14, 15 and 16-T80N-R1W to the east corporation line of the City of Bennett, connecting with an unnamed street.

Bennett:

Beginning at the east corporation line connecting with an unnamed street; thence northwesterly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Bennett, connecting with an unnamed street; thence running northwesterly through Section 9-T80N-R1W to a point about $\frac{1}{4}$ mile north of the SW Corner of Section 9-T80N-R1W; thence north following substantially the section line of Sections 9 and 4-T80N-R1W to a point approximately 1,200 feet south of the NE Corner of Section 5-T80N-R1W; thence running northwesterly to a point approximately 1,200 feet west of the NE Corner of said Section 5; thence west following substantially the section line through Sections 5 and 6-T80N-R1W; and Sections 1, 2, 3, 4, 5 and 6-T80N-R2W to the east corporation line of the City of Tipton connecting with an unnamed street.

Tipton:

Beginning at the east corporation line; connecting with an unnamed street; thence west on said unnamed street to Cedar Street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 130 in Cedar County, Iowa.

Tipton:

Beginning at the east corporation line; connecting with an unnamed street; thence west on said unnamed street to Cedar Street.

Beginning on the Scott–Cedar County line at a point approximately 1000 feet south of the E ¼ Corner of Section 13–T80N–R1W, Cedar County (W ¼ Corner of Section 18–T80N–R1E, Scott County); thence northwesterly to a point about 700 feet west of the N ¼ Corner of Section 13–T80N–R1W; thence west following substantially the section line to the east corporation line of the Town of Bennett, connecting with an unnamed street at Fifth Street.

Bennett:

Beginning at the east corporation line on Fifth Street to an unnamed street; thence northwesterly on an unnamed street to the north corporation line.

Beginning again on the north corporation line of the Town of Bennett, connecting with an unnamed street; thence running northwesterly to a point about $\frac{1}{4}$ mile north of the SW Corner of Section 9-T80N-R1W; thence north following substantially the section line to a point approximately 1200 feet south of the NE Corner of Section 5-T80N-R1W; thence running northwesterly to a point approximately 1200 feet west of the NE Corner of said Section 5; thence west following substantially the section line to the east corporation line of the City of Tipton, connecting with Seventh Street.

Tipton:

Beginning on Seventh Street at the east corporation line; thence west on Seventh Street to Cedar Street.
