**DISCUSSION/BACKGROUND:**

Iowa 135 begins in the City of Montour and proceeds northwesterly to a junction with US 30 approximately two miles east of the City of Le Grand.

Transfer of jurisdiction agreement number TJ-135-0 (2) --2M-86, between the City of Montour and the Iowa Department of Transportation, transferred that portion of Iowa 135 from Division Street west, north and northwest to the north corporation line of Montour to city jurisdiction on July 1, 1980.

Transfer of jurisdiction agreement number TJ-135-0 (1) --2M-86, between Tama County and the Iowa Department of Transportation, transferred that portion of Iowa 135 from the north corporation line of the City of Montour northwesterly to a junction with US 30 approximately 600 feet west and 400 feet north of the E ¼ Corner Section 17-T83N-R16W to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Iowa 135 in Tama County from the primary road system.

Remove from the primary road system Iowa 135 and its extension in Tama County as follows:

Montour:

Beginning on an unnamed street at Division Street; thence westerly, northerly, and northwesterly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Montour connecting with an unnamed street; thence generally northwesterly and northerly through Sections 21, 16, and 17-T83N-R16W to US 30 at a point approximately 600 feet west and 400 feet north of the E ¼ Corner Section 17-T83N-R16W.

**DISCUSSION/BACKGROUND:**

Iowa 135 begins in Montour, and travels generally northwesterly to US 30 approximately 2 miles east of Le Grand, Iowa.

Due to a review of our Primary Road System Records Iowa 135 in Tama County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 135 in Tama County be deleted and the new description, as referred in the attached detailed

description, be included into the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 135 and its extension in Tama County as follows:

Montour:

Beginning on an unnamed street at Division Street; thence westerly, northerly, and northwesterly to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of City of Montour connecting with an unnamed street; thence generally northwesterly and northerly through Sections 21, 16, and 17-T83N-R16W to US 30 at a point approximately 600 feet west and 400 feet north of the E ¼ Corner Section 17-T83N-R16W.
