New Description: – Iowa 137 and its extensions in Wapello County described as follows:

Beginning on the Wapello–Monroe County line at a point approximately 140 feet south of the NW Corner Section 7–T73N–R15W; thence northeast through Sections 7 and 6–T73N–R15W to the west corporation line of Eddyville (approximately 660 feet north and 1320 feet east of the SW Corner Section 6–T73N–R15W) connecting with an unnamed street.

Eddyville:

Beginning on an unnamed street at the west corporation line; thence northeast and southeast on unnamed street to the south corporation line (approximately 1250 feet north and 1710 feet west of the SE Corner Section 6–T73N–R15W).

Beginning again on the south corporation line connecting with unnamed street; thence southeast to the junction with US 63 (approximately 1240 feet north and 730 feet west of the SE Corner Section 6–T73N–R15W).

**DISCUSSION/BACKGROUND:**

Due to the relocation of US 63 north of Ottumwa, and the rerouting of US 63, Iowa 23 and Iowa 149, Iowa 137 is being shortened to end at US 63 in Eddyville.

The former section of Iowa 137 from Eddyville to Oskaloosa will now become US 63.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve revising the description of Iowa 137 in Wapello County to include the attached new description in the Primary Road System.

New Description – Iowa 137 and its extension in Wapello County described as follows:

Beginning on the Wapello–Monroe County line at a point near the NW Corner Section 7–T73N–R15W; thence northeast through Sections 7 and 6–T73N–R15W to the west corporation line of Eddyville connecting with an unnamed street.

Eddyville:

Beginning on an unnamed street at the west corporation line; thence northeast on unnamed street to 8th Street (junction US 63).

**DISCUSSION/BACKGROUND:**

Iowa 137 begins on the Wapello–Monroe County line southwest of Eddyville, and travels northeasterly and northwesterly via Eddyville to the Wapello–Mahaska County line in Eddyville, Iowa.

Due to a review of our Primary Road System Records Iowa 137 in Wapello County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Iowa 137 in Wapello County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Iowa 137 and its extension in Wapello County as follows:

Beginning on the Wapello–Monroe County line at a point near the NW Corner Section 7–T73N–R15W; thence northeasterly through Sections 7 and 6–T73N–R15W to the west corporation line of the City of Eddyville connecting with an unnamed street.

Eddyville:

Beginning on the west corporation line connecting with an unnamed street; thence northeasterly and northwesterly to the Wapello–Mahaska County line on an unnamed street.
