New Description – Iowa 140 and its extension in Plymouth County described as follows:

Beginning on the Plymouth-Woodbury County line at a point on the south line of Section 35-T90N-R44W, Plymouth County (north line of Section 2-T89N-R44W, Woodbury County); thence in a northeasterly direction through Sections 35, 36 and 25-T90N-R44W to a point approximately 700 feet west of the E ¼ Corner of Section 25-T90N-R44W; thence east to the west corporation line of Kingsley, connecting with Primary Road.

Kingsley:

Beginning on a primary road at the west corporation line; thence east, northeast and north on primary road to 1st Street; thence east on 1st Street to the east corporation line.

Beginning again on the east corporation line of Kingsley connecting with 1st Street; thence north following substantially the section line of Sections 20, 17, 8 and 5-T90N-R43W; Sections 32, 29, 20, 17, 8 and 5-T91N-R43W; and Sections 32, 29, 20, 17 and 8-T92N-R43W to a point near the NW Corner Section 8-T92N-R43W (junction Iowa 3).

**DISCUSSION/BACKGROUND:**

Due to a transfer of jurisdiction agreement number TJ-140-2 (5)--2M-75, between the City of Kingsley and the Iowa Department of Transportation, First Street from Main Street to County Road L-14 was transferred to state jurisdiction on July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-140-2 (5) --2M-75, between the City of Kingsley and the Iowa Department of Transportation and due to a transfer of jurisdiction agreement number TJ-140-2 (4)--2M-75, between Plymouth County and the Iowa Department of Transportation, that portion of County Road L-14 along the east corporation line of the City of Kingsley from First Street northerly to the NE Corner of the City of Kingsley was transferred to state jurisdiction on July 1, 1980.

Due to a transfer of jurisdiction agreement number TJ-140-2 (4)--2M-75, between Plymouth County and the Iowa Department of Transportation, that portion of County Road L-14 from the NE Corner of the City of Kingsley northerly approximately 14 ½ miles to Iowa 3 was transferred to state jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the description of Iowa 140 in Plymouth County be deleted from the primary road system and the new description, as attached, be included into the primary road system.

Locate Iowa 140 and its extension in Plymouth County as follows:

Beginning on the Plymouth–Woodbury County line at a point on the south line of Section 35–T90N–R44W, Plymouth County (north line of Section 2–T89N–R44W, Woodbury County); thence in a northeasterly direction through Sections 35, 36 and 25–T90N–R44W to a point approximately 700 feet west of the E ¼ Corner of Section 25–T90N–R44W; thence east to the west corporation line of the City of Kingsley connecting with an unnamed street.

Kingsley:

Beginning on the west corporation line connecting with an unnamed street; thence easterly, northeasterly, northerly and easterly to the east corporation line and connecting with an unnamed street.

Beginning again on the east corporation line of the City of Kingsley connecting with an unnamed street; thence northerly following substantially the section lines of Sections 29, 20, 17, 8 and 5–T90N–R43W; Sections 32, 29, 20, 17, 8 and 5–T91N–R43W; and Sections 32, 29, 20, 17 and 8–T92N–R43W to a point near the NW Corner Section 8–T92N–R43W (junction Iowa 3).

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System Records, Iowa 140 in Plymouth County should be deleted and the new description added should be officially included into the Primary System.

Iowa 140 begins on the Plymouth–Woodbury County line approximately 3 miles southwest of Kingsley, and travels generally northeasterly to a point in Kingsley, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 140 and its extensions in Plymouth County as follows:

Beginning on the Plymouth–Woodbury County line at a point on the south line of Section 35–T90N–R44W, Plymouth County (north line of Section 2–T89N–R44W, Woodbury County); thence in a northeasterly direction through Sections 35, 36 and 25–T90N–R44W to a point approximately 700 feet west of the E ¼ Corner of Section 25–T90N–R44W; thence east to the west corporation line of the City of Kingsley connecting with an unnamed street.

Kingsley:

Beginning on the west corporation line connecting with an unnamed street; thence easterly, northeasterly and northerly to First Street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 140 in Plymouth County, Iowa.

Beginning on the Plymouth-Woodbury County line at a point on the south line of Section 35-T90N-R44W, Plymouth County (north line of Section 2-T89N-R44W, Woodbury County) on the east side of the Chicago and Northwestern Railway; thence in a northeasterly direction along the east side of said railway and substantially parallel thereto through Sections 35, 36, and 25-T90N-R44W to a point approximately 700 feet west of the E  $\frac{1}{4}$  Corner of Section 25-T90N-R44W; thence east to the west corporation line of the Town of Kingsley, connecting with an unnamed street.

NOTE: To become effective upon adoption of this resolution to be used as temporary route of Iowa 140 for a five year period ending December 31, 1967 as per agreement between the Plymouth County Board of Supervisors and the Iowa State Highway Commission (dated May 1963).

Access Control Classification – The remaining portion of Iowa 140 is a Class IV road.
