

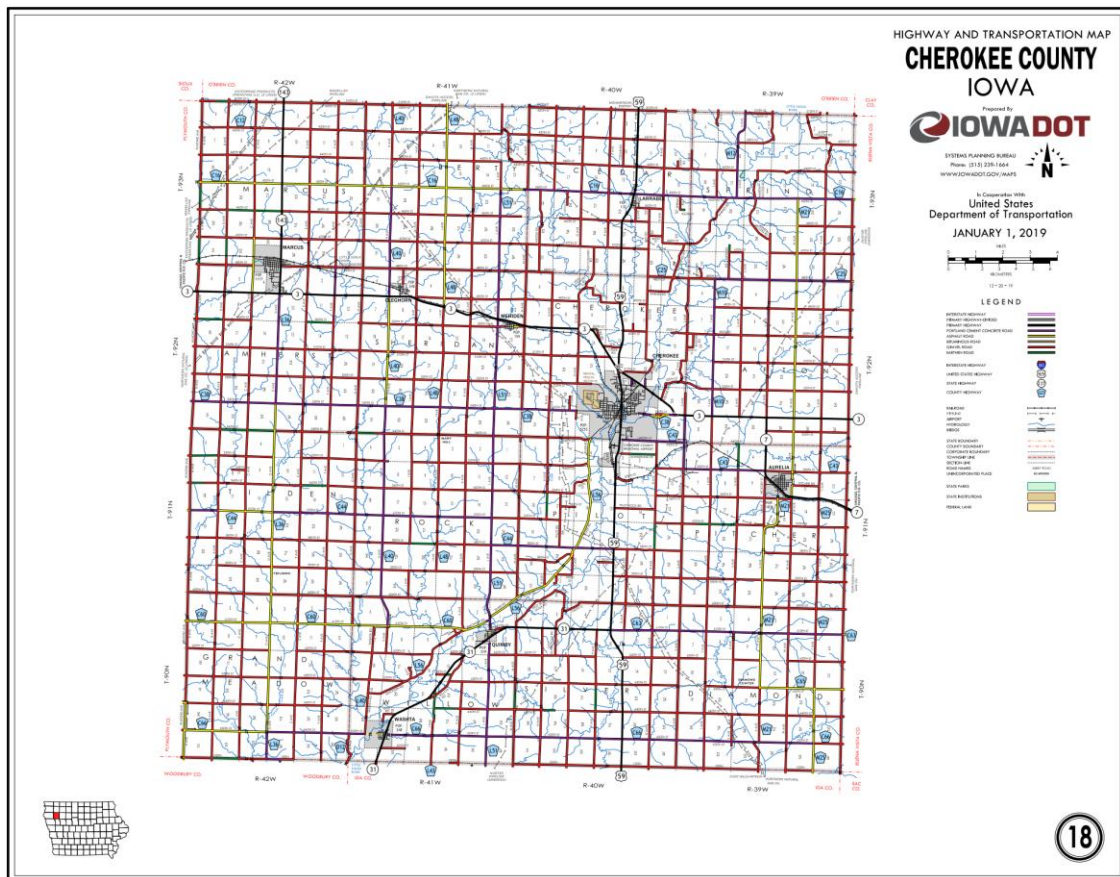

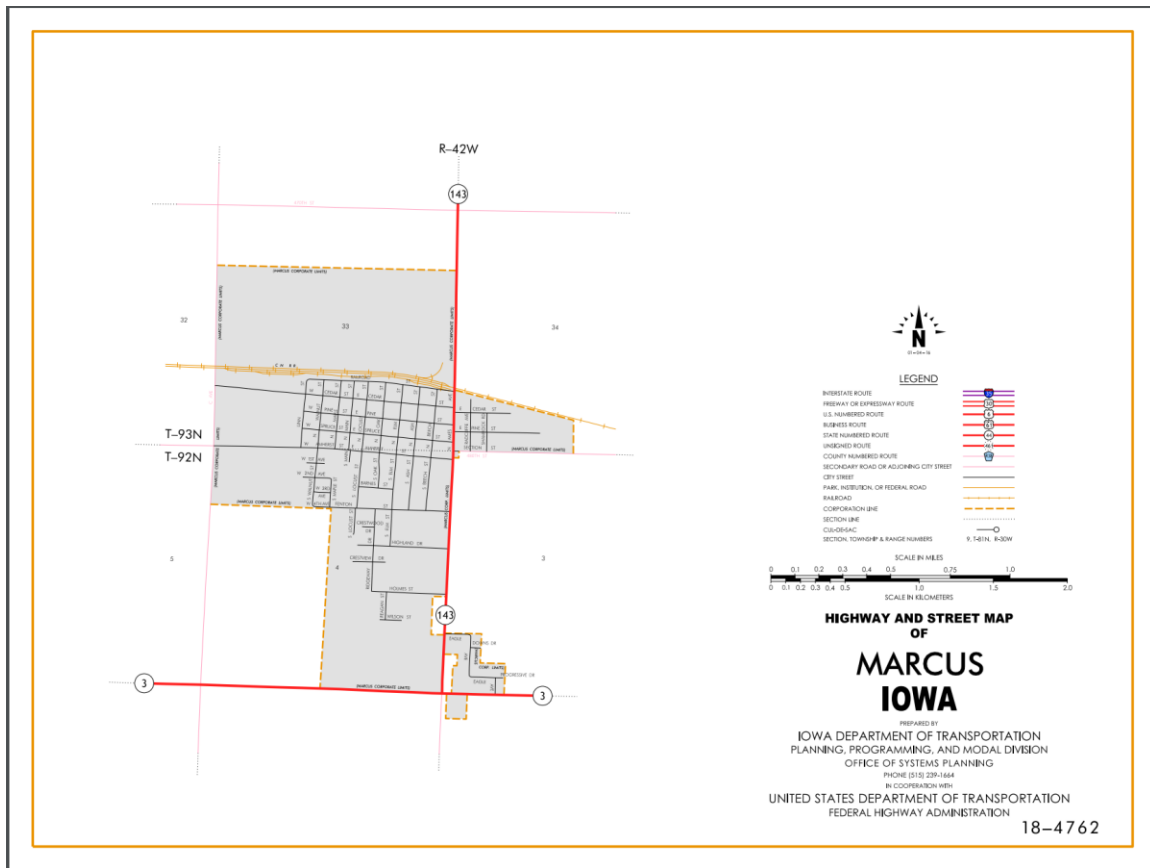

Beginning again at the north corporation line of Marcus connecting with Ames Avenue; then north following substantially the section line of Section 3-T92N-R42W to the south corporation line of Marcus connecting with Ames Avenue.

Marcus:

Beginning at the south corporation line, connecting with Ames Avenue; then north on Ames Avenue to the north corporation line.

Beginning again at the north corporation line of Marcus, connecting with Ames Avenue; then north following substantially the section line of Section 34, 27, 22, 15, 10 and 3-T93N-R42W to the Cherokee-O'Brien County line at a point near the NW Corner of Section 3-T93N-R42W, Cherokee County (SW Corner Section 34-T94N-R42W, O'Brien County).

Beginning again at the north corporation line of the City of Marcus, connecting with an unnamed street; thence north following substantially the section line of Sections 34, 27, 22, 15, 10 and 3-T93N-R42W to the Cherokee-O'Brien County line at a point near the NW Corner of Section 3-T93N-R42W, Cherokee County (SW Corner Section 34-T94N-R42W, O'Brien County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 143 in Cherokee County, Iowa.
