Beginning on the Cass-Adams County line at a point near the SW Corner of Section 34-T74N-R34W, Cass County (NW Corner of Section 3-T73N-R34W, Adams County); thence north following substantially the section line through Sections 34, 27, 22, 15, 10 and 3-T74N-R34W; thence through Sections 34 (junction Iowa 92), 27, 22, 15, 10 and 3-T75N-R34W; then through Sections 34, 27, 22, 15, 10 and 3-T76N--R34W; thence north, northwesterly through Sections 34, 33, and 28-T77N-R34W to the south corporation line of Anita connecting with Michigan Street.

Anita:

Beginning on Michigan Street at the south corporation line; thence north and northwest on Michigan Street to 2nd Street; thence northeast on 2nd Street to unnamed street; thence northerly on unnamed street to the north corporation line.

Beginning again on the north corporation line of Anita connecting with an unnamed street; thence north following substantially the section line of Sections 22, 15, 10 and 3-T77N-R34W to a point approximately 700 feet north of the W  $\frac{1}{4}$  Corner of said Section 3-T77N-R34W (junction Interstate 80 north ramps).

Beginning again on the north corporation line of the City of Anita connecting with an unnamed street; thence northeasterly through Section 21-T77N-R34W and north following substantially the section line of Sections 22, 15, 10 and 3-T77N-R34W to a point approximately 700 feet north of the W ¼ Corner of said Section 3-T77N-R34W (junction Interstate 80 north ramps).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 148 in Cass County.
