

Senate File 451 transferred Iowa 156 in its entirety, in Marion County, to county jurisdiction on July 1, 2003.

New description – Iowa 156 in Marion County described as follows:

Beginning at a point approximately 200 feet west of the NE Corner of Section 18-T74N-R18W (junction of Iowa 5); thence east following substantially the section line of Sections 18, 17, 16, 15, and 14-T74N-R18W to a point approximately 800 feet west of the NE Corner of Section 14-T74N-R18W; thence curving in a southeasterly direction to a point approximately 800 feet south of the NE Corner of Section 14-T74N-R18W; thence south following substantially the section line of Section 13-T74N-R18W to the west corporation line of Bussey connecting with West Street.

**DISCUSSION/BACKGROUND:**

Iowa 156 begins at Iowa 5 approximately four miles west of the City of Bussey, and travels easterly and southerly into the City of Bussey.

Transfer of jurisdiction agreement number TJ-156-0 (2), between the City of Bussey, and the Iowa Department of Transportation, transferred that portion of Iowa 156 from Fifth Street northerly and westerly to the west corporation line to city jurisdiction on December 19, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the present description of Iowa 156 in Marion County from the primary road system and approve including the attached new description of Iowa 156 in the primary road system.

Locate Iowa 156 in Marion County as follows:

Beginning it a point approximately 200 feet west of the NE Corner of Section 18-T74N-R18W (junction of Iowa 5); thence easterly following substantially the section line of Sections 18, 17, 16, 15, and 14-T74N-R18W to a point approximately 800 feet west of the NE Corner of Section 14-T74N-R18W; thence curving in a southeasterly direction to a point approximately 800 feet south of the NE Corner of Section 14-T74N-R18W; thence southerly following substantially the section line of Section 13-T74N-R18W to the west corporation line of the City of Bussey connecting with an unnamed street.

**DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, Iowa 156 in Marion County should be deleted from the primary system and the new description added should be officially included into the Primary Road System.

Iowa 156 begins at the junction of Iowa 5 approximately 5 miles northwest of Bussey, and travels easterly and southerly terminating in Bussey, Iowa.

**PROPOSAL/ACTION RECOMMENDATION:**

Locate Iowa 156 and its extension in Marion County as follows:

Beginning at a point approximately 200 feet west of the NE Corner of Section 18-T74N-R18W (junction of Iowa 5); thence easterly following substantially the section line of Sections 18, 17, 16, 15, and 14-T74N-R18W to a point approximately 800 feet west of the NE Corner of Section 14-T74N-R18W; thence curving in a southeasterly direction to a point approximately 800 feet south of the NE Corner of Section 14-T74N-R18W; thence southerly following substantially the section line of Section 13-T74N-R18W to the west corporation line of the City of Bussey connecting with an unnamed street.

Bussey:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and southerly to Fifth Street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 156 in Marion County, Iowa.
