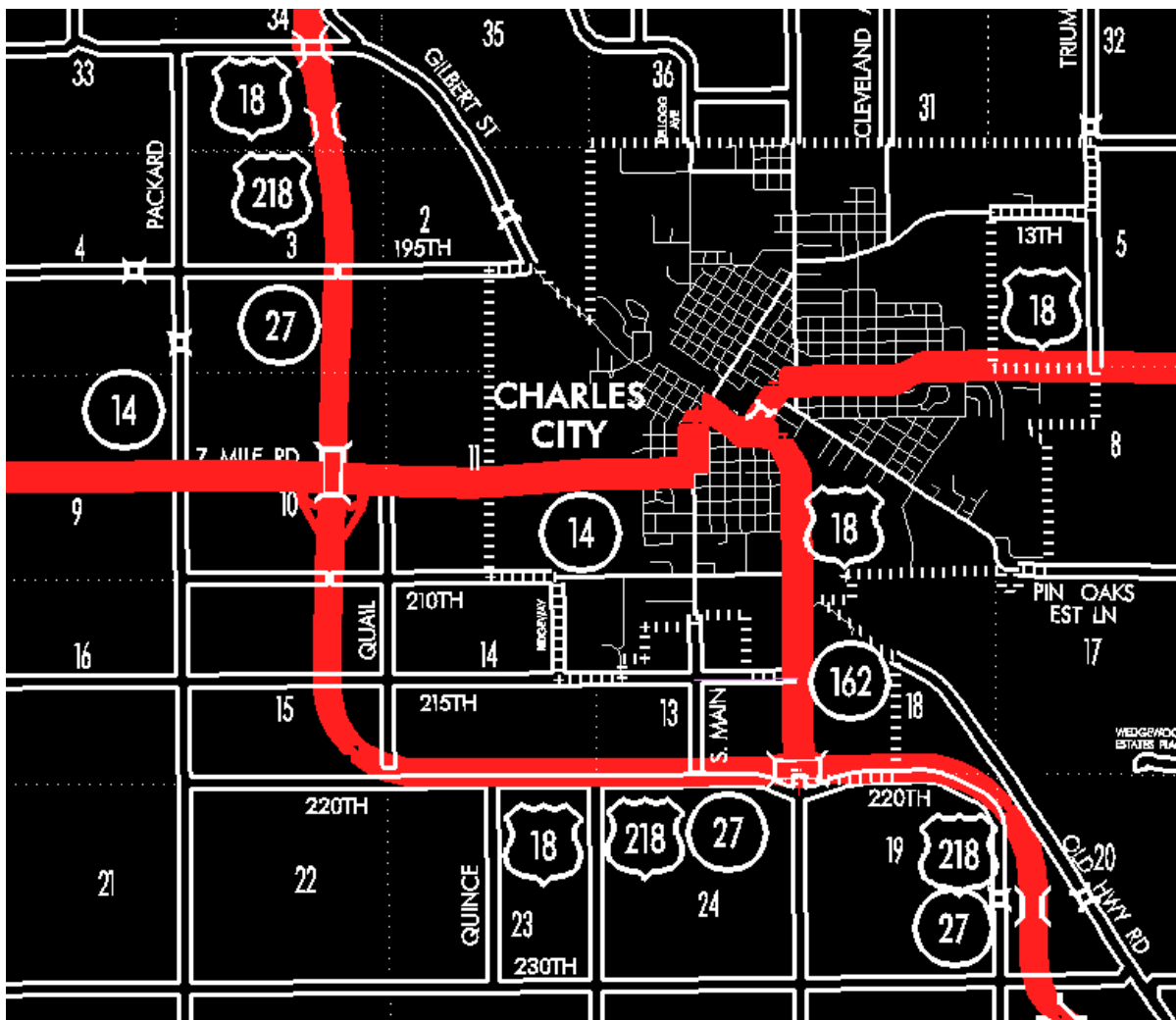

Unsigned Iowa 162 travels from the south ramps of US 218 (south corporation line) northerly and northwesterly on South Grand Avenue to the junction with Iowa 14 (Brantingham Street).

Due to the realignment of US 18 over this section of road, Unsigned Iowa 162 in Floyd County is deleted from the Primary Road System.

**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number 94-P-120 between Floyd County and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 162 from junction of US 218 (near W ¼ Corner SW ¼ Section 28-T95N-R15W); thence north and northeast through Sections 28, 29, 20, and 18-T95N-R15W to the east corporation line of Charles City (near south junction Gar Drive) connecting with an unnamed street to county jurisdiction on November 20, 2001.

Transfer of jurisdiction agreement number 94-P-120 between the City of Charles City and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 162 from the east corporation line (near south junction Gar Drive) connecting with an unnamed street; thence northeast on said street to intersection of South Grand Avenue (approximately 550 feet south of the NW Corner Section 18-T95N-R15W).

Transfer of jurisdiction agreement number 94-P-120 between Floyd County, the City of Charles City, and the Iowa Department of Transportation, transferred a portion of County Road T-64 and South Grand Avenue to state jurisdiction on November 20, 2001.

New Description – Unsigned Iowa 162 and its extensions in Floyd County described as follows:

Charles City:

Beginning at the south ramps of US 218 (south corporation line) (approximately the NW Corner Section 19-T95N-R15W) connecting with South Grand Avenue; thence northerly and northwesterly to junction of US 18 (Brantingham Street) (approximately 1050 feet west and 160 feet south of the NE Corner Section 12-T95N-R16W).

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Unsigned Iowa 162 and its extensions in Floyd County be deleted and the new description be included in the Primary Road System.

**DISCUSSION/BACKGROUND:**

New Description- Unsigned Iowa 162 and its extensions in Floyd County described as follows:

Beginning at the junction US 218 (near the W  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  of Section 28-T95N-R15W); thence north and northeast through Sections 28, 29, 20, and 18-T95N-R15W to the east corporation line of Charles City (near south junction Car Drive) connecting with an unnamed street.

Charles City:

Beginning on the east corporation line (near south junction Car Drive) connecting with unnamed street; thence northeast on said street to intersection of Shadow Street; thence north and northeast on unnamed street to intersection of US 18 and Brantingham Street.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve adding the description of Unsigned Iowa 162 in Floyd County to the Primary Road System.
