**DISCUSSION/BACKGROUND:**

Due to the extension of Iowa 163, the official route description in the Primary Roads System should be revised to reflect this change

New Description– Iowa 163 and its extensions in Mahaska County described as follows:

Beginning on the Mahaska–Marion County line near the W  $\frac{1}{4}$  Corner NW  $\frac{1}{4}$  Section 18–T76N–R17W, Mahaska County (E  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  Section 13–T76N–R18W, Marion County); thence in an easterly and southeasterly direction through Sections 18, 17, 16, 21, 22, 23, 26, and 25–T76N–R17W, Sections 31 and 32–T76N–R16W, and Sections 5, 4, 9, 10, 11, and 14–T75N–R16W to the north corporation line of Oskaloosa (near the N  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  Section 14–T75N–R16W) connecting with an unnamed street.

Oskaloosa:

Beginning on the north corporation line (near the N  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  Section 14–T75N–R16W), connecting with an unnamed street; thence south on said street to the south corporation line (near the S  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  Section 14–T75N–R16W).

Beginning again on the south corporation line of Oskaloosa (near the S  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  Section 14–T75N–R16W), connecting with an unnamed street; thence south and southeasterly through Sections 23, 26, 25, and 36–T75N–

R16W to a point near the E ¼ Corner Section 36–T75N–R16W (junction US 63).

Beginning again a point near the E ¼ Corner Section 36–T75N–R16W, (the junction of US63) traversing along US63 southerly through Sections 6, 7, 18, 19 and 30–T74N–R15W, thence southeasterly to the Mahaska–Wapello County Line (north corporation line of Eddyville) near the SE Corner of Section 31–T74N–R15W.

**Proposal/Action Recommendation:**

It is recommended that the old description of Iowa 163 and its extensions in Mahaska County be deleted and the new description be included in the Primary Road System

Beginning on the Mahaska–Marion County line near the W ¼ Corner NW ¼ Section 18–T76N–R17W, Mahaska County (E ¼ Corner NE ¼ Section 13–T76N–R18W, Marion County); thence in an easterly and southeasterly direction through Sections 18, 17, 16, 21, 22, 23, 26, and 25–T76N–R17W, Sections 31 and 32–T76N–R16W, and Sections 5, 4, 9, 10, 11, and 14–T75N–R16W to the

north corporation line of Oskaloosa (near the N ¼ Corner SW ¼ Section 14–T75N–R16W) connecting with an unnamed street.

Oskaloosa:

Beginning on the north corporation line (near the N ¼ Corner SW ¼ Section 14–T75N–R16W), connecting with an unnamed street; thence south on said street to the south corporation line (near the S ¼ Corner SW ¼ Section 14–T75N–R16W).

Beginning again on the south corporation line of Oskaloosa (near the S ¼ Corner SW ¼ Section 14–T75N–R16W), connecting with an unnamed street; thence south and southeasterly through Sections 23, 26, 25, and 36–T75N–R16W to a point near the E ¼ Corner Section 36–T75N–R16W (junction US 63).

It is recommended that the old description of Iowa 163 and its extensions in Mahaska County be deleted and the new description be included in the Primary Road System

Beginning on the Mahaska–Marion County Line near the W  $\frac{1}{4}$  Corner of Section 18–T76N–R17W, Mahaska County (E  $\frac{1}{4}$  Corner Section 13–T76N–R18W, Marion County); thence northerly to junction of Unsigned Iowa 968; thence in an easterly and southeasterly direction through Sections 18, 17, 16, 21, 22, 23, 26 and 25–T76N–R17W, Sections 31 and 32–T76N–R16W and Sections 5, 4, 9, 10, 11, and 14–T75N–R16W to a point in the SE  $\frac{1}{4}$  Section 14–T75N–R16W (east junction Iowa 92). Then west on Iowa 92 to approximately the center of the SW  $\frac{1}{4}$  of Section 14–T75N–R16W (west junction Iowa 92) then southerly and southeasterly through Section 14, 23, 26, 25 and 36–T75N–R16W to a point near the E  $\frac{1}{4}$  Corner of Section 36–T75N–R16W (junction US 63).

Beginning on the Mahaska-Marion County line at a point approximately 700 feet south of the NW Corner of Section 18-T76N-R17W, Mahaska County (NE Corner of Section 13-T76N-R18W, Marion County); thence in an easterly and southeasterly direction through Sections 18, 17, 16, 21, 22, 23, 26, and 25-T76N-R17W, Sections 31 and 32-T76N-R16W and Sections 5, 4, 9, 10, 11, and 14-T75N-R16W to a point in the SE ¼ Section 14-T75N-R16W (junction Iowa 92).
